In response, **the Chairman** detailed the current position on the consultation exercise and stated that an electronic letter had been sent to over 3800 businesses and workers and 800 face to face interviews had been conducted. He reported that, to date, 856 postal questionnaires had been received and he gave statistics of the balance of responses from City residents and workers. He concluded that the consultation exercise would run until 11 February 2011, after which the results would be collated and any draft policy would be prepared for submission to a special meeting of the Licensing Committee on 30 March 2011, to which all Members of the Court were invited to attend. He added the draft policy would be submitted to the Court of Common Council for adoption on 5 May 2011.

### (A) POLICY AND RESOURCES COMMITTEE (Stuart Fraser)

### The City Prospectus: Local Economic Assessment

The previous Government placed a statutory duty on local authorities to prepare a Local Economic Assessment (LEA) for their area to ensure that they have an understanding of how economic conditions and forces shape local areas and to inform policies, priorities and the allocation of resources. This Committee recently considered and endorsed the LEA for the City of London and this is submitted in the form of a printed and circulated report for the information of the Court.

### (B) London Councils Grants Scheme – Levy on the London Local Authorities

The London Councils Grants Scheme (LCGS) enables the City of London Corporation and the London boroughs to share the cost of making grants to voluntary organisations which operate in more than one borough.

This year the annual process of approving the LCGS budget and the constituent councils' subscription to it has involved London Councils carrying out a comprehensive review of the Grants Scheme. This was undertaken in anticipation of the cuts in public sector spending and to facilitate local decisions on grants to the voluntary sector in accordance with the Localism agenda. The review resulted in the re-prioritisation of the services funded and, consequently, in a recommendation that a number of organisations lose their funding. It is proposed that overall borough contributions to the LCGS are reduced by 49.7% compared with last year.

On this occasion, in order to comply with the deadline for constituent councils to respond, approval of the Court to the overall expenditure for the Grants Scheme for 2011/12 of £17,691,000 and the City Corporation's subscription to it, £19,640 (a decrease of £7,658) was obtained under urgency procedures and we accordingly report the action taken. Of the total expenditure to be incurred under the Scheme (£17,691,000), £13,241,000 is made up of local authority subscriptions as listed below. These sums are based on predicted resident population. The approval of two thirds of London boroughs is required in order for the budget to be set. Therefore it should be noted that our approval to both the overall expenditure and our contribution is subject to that being achieved.

The City of London Corporation has been the designated council responsible for issuing the levies to all the constituent councils for their contributions to the London Councils' Grants Scheme since 1 February 2004. The City of London is defined, for these purposes, as a levying body under sections 74 and 117 of the Local Government Finance Act 1988 and the Levying Bodies (General) Regulations 1992. It now falls to us to agree the annual levy on all constituent councils (i.e. both the total

contributions from them and the apportionment of that total between them) so that contributions can be collected from the boroughs towards the total expenditure of the Scheme. The 1992 Regulations state that this needs to be done by 14 February.

It should also be noted that London Council's recommendation to reduce expenditure on the Scheme is the subject of a Judicial Review by one of the applicants for funding, based on the perceived failure of London Councils properly to conduct equality impact assessments and on how that organisation was classified in terms of eligibility for future funding. If successful, this will have implications for the proposed level of expenditure as, if total expenditure to be incurred under the LCGS is not agreed by 1 February then, in accordance with the Grants to Voluntary Organisations (Specified Date) Order 1992, the total expenditure for the Scheme will be deemed to be the same as that approved in the previous year i.e. £30,116,000 with our subscription for the coming year reverting to £27,298. The hearing in the Judicial Review proceedings has been fixed for 27 January and the outcome of the hearing is expected to be known before 1 February. The implications of any adverse judgement on next year's LCGS budget will only be known once the judgement has been handed down. As this report had to be prepared prior to these dates, there will be an oral update to the Court.

On the basis that the 2011/12 grants budget is approved by two thirds of London Boroughs and the Judicial Review is not upheld, we **recommend** that approval be given to the issue of levies as set out below:-

# (B) Early Evening Reception to coincide with the National Olympic and National Paralympic Committees' Chefs De Mission Seminars in London

In August 2011, "Chefs de Mission" from the 205 National Olympic Committees (NOCs) will meet in London for their official seminar with the London Organising Committee of the Olympic and Paralympic Games (LOCOG). This will be followed by an official seminar in September with "Chefs de Mission" from each of the 167 National Paralympic Committees (NPCs) for the London 2012 Paralympic Games. Each NOC has a government appointed "Chef de Mission" who oversees the administration and arrangements on behalf of their nation's team of athletes, coaches and managers.

The Chefs de Mission Seminars are of great importance to LOCOG as they act as an early pre-Games evaluation. The City Corporation has been working closely with LOCOG and it is proposed that the City hosts an early evening reception during both meetings of the "Chefs de Mission" and immediately prior to the official LOCOG hosted dinners in the Great Hall. It is anticipated that these receptions will provide an opportunity to make the "Chefs de Mission" aware of the range of facilities and activities offered by the City, which may be of interest to their teams when visiting London for the Games.

In addition to delegates from each NOC and NPC, it is anticipated that guests would include representatives from the International Olympic Committee, the International Paralympic Committee, the Association of National Olympic Committees, representatives from past Winter and Summer Olympic and Paralympic Games, LOCOG Executive and stakeholders, the Olympic Delivery Authority, the British Olympic Association and senior Government representatives.

We **recommend** that hospitality be granted in the form of two early evening receptions, the cost being met from within the strategic hospitality element of the Committee's budget, within approved cost parameters, the arrangements being left in the hands of the Policy and Resources Committee.

## (C) Early Evening Reception to mark the Centenary of the Guild of the Royal Hospital of St Bartholomew

The Royal Hospital of St Bartholomew, known as Barts, is located in Smithfield. The Hospital has existed on the same site for almost 900 years, surviving both the Great Fire and the Blitz. In 1546 Henry VIII signed an agreement under which Barts became one of the four royal hospitals that were at one time administered by the City.

The Guild of the Royal Hospital of St Bartholomew, which was founded in October 1911, is a voluntary organisation whose aim is to support the work of the hospital through volunteers and it raises funds to provide equipment and comfort for the benefit of both patients and staff. As part of the celebrations for the centenary, it is proposed that a reception be held at Guildhall in the Spring of 2012.

It is anticipated that a reception would both help raise the profile of the Guild, and also provide an opportunity to acknowledge the volunteers involved with its work. It would also provide an opportunity for the City Corporation, through the Economic Development Office's volunteering section, to reach out to City workers who may wish to become involved with the Guild's work as volunteers thereby linking into the Government's Big Society agenda. It is anticipated that the guest list for this occasion would include the Trustees and members of the Guild of the Royal Hospital of St Bartholomew, individuals from Barts Hospital, Livery Companies involved with the hospital, City financial figures and Members with relevant interests.

We **recommend** that hospitality be granted in the form of an early evening reception and that arrangements be left in the hands of the City Lands and Bridge House Estates Committee within approved cost parameters.
