Resolved – That the Court of Aldermen endorse the Guild of Air Pilots and Air Navigators' petition to the Privy Council for a Royal Charter.

(iii) Company of Educators

Company of Educators

A recommendation of the General Purposes Committee recommending that the Company of Educators be constituted as a Livery Company of the City of London and that the prayer of the Petition be complied with, on the following conditions:

- That the number of the Livery should not exceed 300;
- That the fine for admission to the Livery should be not less than £65; and
- That no person shall be admitted to the Livery of the Company unless he or she first produces his or her copy of the freedom of the City of London.

That as the proposed Constitution and Ordinances conform to the law and custom of the City, the Company of Educators be constituted a Livery Company of the City with the title "The Worshipful Company of Educators," that the formal grant be embodied in Letters Patent under the Mayoralty Seal and that the proposed Constitution and Ordinances be approved and enrolled among the records of the Court of Aldermen as the 109th Livery Company of the City.

Resolved – That the recommendation be agreed to.
