The Head of Centre advised that, via the DEF project, links had been created between the Learning Providers and 33 different schools. The Centre was keen to maintain contacts with the schools where possible.

The Head of Centre advised that there were still some minor amendments to be made and that hard copies would be made available for the Teacher Workshop on 16 November. He stated that he hoped that there would be a fairly good turnout for this event.

Questions were raised around the Legacy of the DEF and whether enough work was being done to keep the legacy going for future years. The Head of Centre stated that funding was an issue especially for Key Stage 1 and 2 and that external funding was needed. The Superintendent advised that a fundraising pack for individual schools to enable them to approach businesses for funding was being developed

## Head of Centre's report on final Discovering Epping Forest (DEF) Workshop

#### **Purpose of report:**

This report is intended to provide information to the Committee in relation to the final Def workshop and the steps to build on the legacy of the DEF Project. I recommend that this report be RECEIVED.

This is the final report of the DEF project and follows the publication of the full Project report. It refers to:

- the seventh and final Champions' Workshop
- the Project legacy
- the future

The seventh and final Champions' Workshop was held at Epping Forest Field Centre (EFFC) on 12 September 2012 and (with this report) concluded the delivery of the DEF project and provided the opportunity to present the Project report 2009 -2012 to participant schools.

The Workshop was used as means to bring the project to an end and to facilitate the transition to post-DEF collaboration of the partners involved (ie the schools and the learning providers) in taking forward the DEF legacy.

The workshop was generously supported by the Heritage Lottery Fund as part of the 'Branching Out' project and was designed to:

- Inspire teachers to continue to champion the aims of the 'Discovering Epping Forest' project.
- Encourage continuing use of the services of Epping Forest Learning providers
- Highlight the legacy of Discovering Epping Forest including the learning programmes, resources, networking and collaboration.

Teachers from primary schools had the opportunity to experience or observe a range of exciting key stage two learning activities including 'leading edge' science and 'ESD' programmes as well as having the opportunity to discuss with learning providers plans for ongoing learning in Epping Forest. Participants also heard about plans for continuing and improved access to online learning resources and the Learning Outside the Classroom (LOtC) Mark for schools as well as receiving copies of the Discovering Epping Forest report and DVD.

#### **Steve Bunce**

Steve drew attention to the Project report and to some significant numbers :

- 12,150 learner experiences across three years mass participation
- **93**% of teachers ranked 'overall' satisfaction of the programme in the highest category on a 5-point scale outstanding quality
- 0.012% of learners received a injury (only very minor) terrific safety record

#### Sally Thompson

Quality Badge Development Manager for the Council for Learning Outside the Classroom

Sally explained how LOtC is valued by the government and OFSTED and is gaining widespread recognition. She introduced the new LOtC Mark for schools answered questions that teachers raised regarding LOtC in general and the LOtC Mark in particular.

#### **Anthony Thomas**

Formerly Chair of the Real World Learning Steering Group reporting to HM Government, Chairman of the Forest Education Initiative and CEO of the Field Studies Council. Trustee of the Royal Geographical Society and Trustee of the Council for Learning Outside the Classroom

Tony gave an inspirational presentation on real world learning to encourage Champions to take forward the DEF legacy and answered questions about the latest developments in education.

### **Discovering Epping Forest Report and DVD**

A free copy of the Discovering Epping Forest short film (DVD) and the Discovering Epping Forest 2009 – 2012 Report was provided to each of the participant schools

Both the Report and DVD will be available soon on the City of London website.

#### Summary of the DEF legacy taken from the full DEF Report

The legacies of the Discovering Epping Forest project include the following:

- Increased awareness and appreciation of Epping Forest among participating students and teachers.
- A network of teaching professionals in local schools committed to teaching in and about the Forest, acting as 'Epping Forest Champions'.
- A growing number of primary schools have built DEF work or activities into their programming with intentions to use the Forest on a frequent basis.
- Raised levels of skill, knowledge and confidence about outdoor teaching within participating schools.
- Greater use of Epping Forest by schools arriving by foot or on public transport has
  increased understanding in relation to how the Forest can be accessed with to help to
  minimize travel costs and the impacts of traffic upon the Forest.
- Increased understanding and appreciation of each Forest Learning Provider that enabled more effective working relations.
- Promotion of all the Forest Learning Provider services through the programme and online materials, raising the profile of Epping Forest.
- An enhanced ability amongst the Learning Providers to work in partnership and understand how services can be delivered in a complementary manner.
- Web based learning resources.

#### **Legacy for the Learning Providers**

City of London Corporation learning service

#### 1. Course development

As a result of developing a module for the DEF project, the QEHL now has a permanent school session entitled 'Epping Forest through History (Case study: Victorians) KS2'.

#### 2. More learners at QEHL

The DEF project has increased confidence, enthusiasm and ability among DEF Champions to continue using the Forest as a learning resource for classes.

#### 3. Website resources

DEF-derived teaching support material form all partners is now available to download from the EF section of the CoL website:

#### 4. Repeat visits to QEHL

We have lots of anecdotal evidence that participating children and adult helpers have spread enthusiasm for the Forest among friends and family.

Epping Forest Centenary Trust (EFCT)

#### 1. Delivery capacity

The Discovering Epping Forest Project has helped develop the confidence and capacity of the Trust, to secure and manage grant funded projects in the future.

#### 2. Partnership working

The DEF Project increased our understanding of partnership working and the work of partners in the Forest.

#### 3. Web site resources

The web based materials developed through the DEF project is enabling the Trust to better assist groups visiting the Forest and to expand its services to a wider range of groups.

#### 4. Engaging new audiences

Through the DEF Project, EFCT was able to work with new audiences, increasing schools' awareness of our services and encouraging new participants in the future.

Epping Forest Field Centre (EFFC)

#### 1. Multi-partner working

The Discovering Epping Forest project enabled EFFC to develop multi-partner working with the City of London, Epping Forest Centenary Trust and Suntrap, which provided added value to core funding.

### 2. Delivery capacity

Increased funding allowed an increase in Key Stage 2 delivery and allowed EFFC to teach groups and reach new audiences, especially those from the deprived London boroughs of Newham and Redbridge.

#### 3. Cascading learning

Learning by EFFC from the innovation and delivery of the successful City Bridge Trust funded 'Sustainable Schools<sup>TM</sup>' project (2004-2007) allowed cascading of experience to develop the Discovering Epping Forest project.

#### 4. Best practice for documentation

By delivering the DEF project, EFFC was able to develop best practice for documenting and recording in a range of areas including: evaluation tools, pre- and post- course liaison, risk assessments, site working information cards, transport and schools liaison.

#### 5. Outreach capacity

The DEF project enhanced the Centre's ability to deliver outreach projects at a number of learning sites within the east London area and to carry out teaching at sites near the learners.

#### 6. Teaching modules

EFFC has developed a stand-alone KS2 course which examines the impacts of humans on Epping Forest.

Suntrap Forest Education Centre

### 1. Improved course delivery

Forming partnership with other Learning Providers allowed Suntrap to experience other teaching courses which resulted in improved course delivery.

#### 2. Improved teaching capacity

Taking part in the Discovering Epping Forest Project resulted in an increase in teaching capacity by the Centre.

#### 3. Development of materials

The Centre has developed specific Epping Forest teaching resources which can be incorporated into other courses.

### 4. Teaching at Forest sites

The project allowed teaching at alternative Forest sites and has increased the capacity of the Centre to deliver at these locations in the future.

# **Epping Forest Field Centre Head of Centre's report on activity in 2012**

Purpose of report: To inform the Joint Committee; I recommend that this report be RECEIVED

With **22,140** learner experiences (target exceeded), it was only the ending of the Discovering Epping Forest (DEF) project and the changed location for the 'Santa' event that made 2012 the second best year in the Centre's history and not quite in line with the 2011 record.





This **City Bridge Trust** (CBT) funded project was successfully extended from schools to include informal learning (families and adults). All participants indicated that their experiences had led to a significant increase in understanding of issues affecting London's biodiversity as well as learning in relation to taxonomic and identification skills.

The **HLF** funded 'Discovering Epping Forest' (DEF) project came to an end with the production of the final project report and DVD. The EFFC team had led the three year project, and together with our partner organisations (City of London, EF Centenary Trust and Suntrap) delivered 12,150 learning experiences for KS2 students and training and support for 90 teachers, who would have not otherwise visited Epping Forest.

Activities relating to the pan European project 'Lessons from Nature' were trialled in advance of a planned rollout to 30 schools in 2013.

The Centre team currently uses 44 learning sites within and outside of Epping Forest. Providing learning at 'outreach' sites away from the Centre itself continues to take learning closer to the learners offers the potential of reduced travel costs to schools and families.

We continue to maintain good links with London Biodiversity Officers and Open Spaces/ Community officers, and are collaborating with them on the potential for the utilization of other sites and other funding sources.



James Bromhead and Tania Oram spent two days in the heart of Epping Forest improving their bush craft survival skills so that they can make improvements to our provision to children, families and adults.




This year we were able to introduce the third formal education module in our **City Bridge Trust** (CBT) funded 'Learning for Biodiversity' project where staff visited the six partner London borough primary schools to work with two classes of Year 5 pupils (aged 10-11 years old) in their school and grounds. The aim was to build on the previous modules and to discover biodiversity present. Pupils took part in a variety of re-cap classroom activities in the morning with a selection of outdoor practical tasks in the afternoon aimed to enhance the biodiversity of their school grounds.

A team from Epping Forest Country Care and their volunteers spent a day in February at the Centre removing plant overgrowth from the two centre ponds and from the reptile mound.

In addition to teachers reacting well to 'Mind the Gap' online resources, we were pleased to have the opportunity to collaborate with EU partner organisations in the Netherlands, Hungary, Bulgaria and Slovakia on this EU funded project. We are exploring possible future collaborations with these partners and our other EU partners from other EU projects including Spain, Latvia and Romania. In May Sarah Etherington and Michelle Savage joined Jonathan Oldham in Astana, Kazakhstan to work with Nazarbayev University.

We are continuing to develop a wide range of UK partners including John Muir, BSA (Crest awards), BES, Country Care and Archimedes (the leading commercial Forest Schools organisation in the UK).

The Associates 2013 Action Plan approved at Associates of Epping Forest Field Centre AGM on 28 November reveals the transformation of the Associates into an active community based organisation and a focal point for volunteering. Special thanks go to former Epping Forest Superintendent, John Besent, who retired as the Associates President. There are currently 723 members of the Associates. In 2012 the Associates transferred £770 to fund activities at the Centre. The Associates of Epping Forest held a plant sale in May to raise money for resources and secured a donation of 54 pairs of wellingtons from Shoezone and Stead and Simpson. Wellingtons are vital for students visiting the centre who cannot afford to buy boots for a one day fieldtrip.

Tutor Dr Laurence Jarvis Laurence delivered a talk on his PhD research (ecology of juvenile Great Crested Newts) to the British Herpetological Society in December following on from his participation at 'Aquatics Live' in Brighton in November.

#### Income and expenditure:

The 2012 Plan had made reference to the need to respond to a potential operating deficit that could have occurred with rising basic costs and reduced DEF and City of London income. As indicated previously to the JCC, the initial response included the making the administrator post of redundant, not replacing a Trainee Tutor and not reverting a 0.4 FTE Tutor post to full time. A further cut to staffing costs (with an eye on the 2014 salary budget) was then made in the summer of 2012 when tutor, Christian Kiel, left and was not replaced. (This had been possible with the reduction of 25 DEF group/days in the Autumn compared to previous years and because, after a good period of staff retention) the remainder of the teaching team were sufficiently capable of covering some additional teaching across all levels and subjects.

Grant income for 2012 was better than had been forecast in October 2011 with some EU project work coming in 2012 rather than 2011 as previously anticipated together with some additional FSC Kids Fund bursary income.

The combination of the significant reduction in salary costs in 2012 (compared to 2011) and better than forecast grant income produced a significantly healthier financial out turn than had been anticipated at the time of budgeting.

Staff turnover arising from the departures of our Team Leaders and one of our tutors (with responsibilities for publicity and Lessons from Nature) in the early months of 2013 created an opportunity to make further cuts to staff costs. Both replacement appointments were made at the starting point on the FSC tutor scale. The resultant salary savings, together with confidence now that we shall exceed estimates for grant income, should help to ensure that we will now have a modest operating surplus by the end of 2013. (The estimates presented to the Committee in October had shown a deficit).

I and the remaining two Team Leaders are attempting to cover the operational management and leadership responsibilities formerly undertaken by the outgoing Team Leader. Even with effective and efficient systems we have struggled a little at times with the cuts to staffing but we have managed to avoid any significant service issues. We are pleased to have successfully recruited two suitably experienced and talented tutors to join our team in place of the highly valued leavers from our team. We remain broadly on track to deliver the 2013 Plan but there will be significant challenges in delivering the KPIs alongside ambitious project work arising from these changes.

Looking ahead we have lots of scheduled 'Forest Families' activity days throughout the year as well as eco-activities for children and a wide range of leisure learning and professional development courses for adults alongside our normal schools provision. Notable events include:

- an evening session for teachers in Lea Valley Park on 22 May in partnership with other Essex Learning for Sustainability (ELFS) providers #
- an informal Open Day for families on 25 July a walk for FSC Life Members and members of the Associates of EFFC on 7 September #

# these events are linked to plans to recognise the FSC's 70th anniversary.

In relation to the recommended actions arsing from the Fire Risk Assessment that took place in 2012, as reported to the JCC in October, it is my understanding that City of London Officers have asked its contractors to address all of the items that I referred to the Superintendent as potentially CoL responsibilities. Some of the work has already been completed and it is envisaged that the remaining actions will be completed in the near future.

The aspiration in the 2011-2014 EFFC Plan to make Lessons from Nature a major part of the learning provision of the Centre has been moved forward with the creation of new a new website <a href="https://www.lessonsfromnature.org">www.lessonsfromnature.org</a> the content of which has been developed by the EFFC team.
