In response to a Member's question, the Assistant Director of Environmental Health and Public Protection advised that certificates for all Members who passed the Award for Personal Licence Holders would be circulated via post later this month.

#### 8. MINUTES OF LICENSING (HEARING) SUB COMMITTEES

**RESOLVED** – That the minutes of the Licensing (Hearing) Sub Committee held on 29 January 2015 be noted.

## 9. APPEALS AGAINST LICENSING (HEARING) SUB COMMITTEE DECISIONS There were none.

#### 10. LOCAL GOVERNMENT (REVIEW OF DECISIONS) ACT 2014

The Committee received a report of the Remembrancer regarding the provisions of the Local Government (Review of Decisions) Act 2015, which required local authorities to put in place a formal review procedure for any decisions which stop or restrict a proposed event on grounds of health or safety and enabled the introduction of a fast-track procedure for such decisions to be reviewed by the Local Government Ombudsman.

**RESOLVED** – That the provisions of the Local Government (Review of Decisions) Act 2015 be noted.

# 11. DELEGATED DECISIONS OF THE DIRECTOR OF MARKETS AND CONSUMER PROTECTION PERTAINING TO PREMISES LICENCES

The Committee received a report of the Director of Markets and Consumer Protection that provided details of the premises licences and variations to premises licences granted under the Licensing Act 2003 by the Licensing Service from 1 January 2015 to 31 March 2015.

In response to Members' requests, the Town Clerk and officers from the Markets and Consumer Protection Department agreed to provide Committee Members with the details of premises obtaining sufficient points on the Risk Scheme to reach Red or Amber in advance of the meeting as part of a Non-Public appendix in the main agenda.

The Licensing Manager advised that there was another premises in Lime Street who had reached Amber on the Risk Scheme with 11 penalty points. The list of premises obtaining sufficient points on the Risk Scheme would therefore be amended. He added that the full list of Green to Red premises on the Risk Scheme could be circulated to Member upon request.

**RESOLVED** – That the details of premises licences and variations to premises licences granted under the Licensing Act 2003 by the Licensing Service from 1 January to 31 March 2015 be noted.

# 12. DEPARTMENT OF MARKETS & CONSUMER PROTECTION BUSINESS PLAN 2015-2018

The Committee considered a report of the Director of Markets and Consumer Protection that sought approval to the 2015-18 Business Plan of the City of London Corporation's Licensing Service.

In response to a Members' questions regarding Operational Performance Indicators, the Director of Markets and Consumer Protection advised that the wording of PI 2 would be revised to be clear that it is a snapshot indicator. The

Chamberlain advised that the latest available figures showed that as at 31 March 2015, 97.6% of debts were less than 60 days old and 99.9% were less than 120 days old. The Director of Markets and Consumer Protection added the target to achieve an overall sickness absence level of no more than 6 days per person had been reduced from a target of 7 days in 2014/15, which had been met.

The Licensing Manager advised that the Statements of Licensing Policies under the Licensing Act 2003 and Gambling Act 2005 would be drawn up through public consultation in late 2015 and would be submitted for Committee approval in early 2016. The Chamberlain added that a statutory annual update report on the Late Night Levy would be considered in October 2015.

**RESOLVED** – That the Licensing Service Business Plan 2015-18 be approved.

#### 13. SEX ESTABLISHMENTS - ANNUAL REVIEW OF FEES

The Committee considered a report of the Director of Markets and Consumer Protection that sought approval to the annual fees for those premises requiring a licence under the Local Government (Miscellaneous Provisions) Act 1982 as a sex establishment.

The Comptroller and City Solicitor advised Members of the Supreme Court Decision in relation to Hemming vs. Westminster City Council. Members were advised that the Supreme Court concluded on 29 April 2015 that licensing schemes which required the applicant to pay a fee covering the administrative costs of the application at the time the application is made and, in the event that the application is granted, a further fee to cover the costs of enforcing the licensing scheme did not fall foul of the Provision of Services Regulations 2009.

Members were also advised that a decision regarding licensing schemes which required a fee that covered both the administrative costs and the costs of enforcing the scheme to be paid at the time the application was made, with the enforcement element being refunded should the application be rejected, was referred to the European Court of Justice for determination.

These findings from the Supreme Court case could be applied to the entire local authority licensing regime save for premises licensed under the Licensing Act 2003 and the Gambling Act 2005 where there were statutory fee structures in place.

**RESOLVED** – That the annual fees for those premises requiring a licence under the Local Government (Miscellaneous Provisions) Act 1982 as a sex establishment, be approved.

#### 14. LATE NIGHT LEVY UPDATE

The Committee received a report of the Director of Markets and Consumer Protection that provided a update of the Late Night Levy (LNL) since 1 October 2014.

Members were introduced to Simon Douglas, the new Licensing Inspector for the City of London Police, who was attending his first Committee meeting.

In response to a Member's question, the Licensing Manager advised that most premises removed the condition on their licence to allow the sale of alcohol after midnight on New Year's Eve only for free before the LNL was introduced in October 2015. This meant that they would no longer be liable to pay the LNL. The condition remained on some premises licences but these premises were able to remove it from their licence for a charge of £89.

**RESOLVED** – That the report be noted.

#### 15. **SAFETY THIRST UPDATE**

Members received a verbal update from the Licensing Manager regarding the Safety Thirst scheme.

The Licensing Manager advised that letters had been sent to Safety Thirst members at the start of May 2015. This was later than originally intended as some amendments had been made to the scheme. Amendments included the introduction of different 'grades' to the award as well as an award for the Licensed Premises of the Year. In response to a Member's question, he confirmed that previous winners of the award would still have to re-apply this year. He added that the Award ceremony would take place on 12 October 2015 in the Livery Hall.

**RESOLVED** – That the Safety Thirst update be noted.

# 16. QUESTIONS ON MATTERS RELATING TO THE WORK OF THE COMMITTEE

There were no questions.

#### 17. ANY OTHER BUSINESS THAT THE CHAIRMAN CONSIDERS URGENT

The Chairman advised Members that there would be a presentation at the next Committee meeting regarding the expected impact of Transport for London's introduction 24 hour Tube services on Fridays and Saturdays with effect from 12 September 2015. It was noted that the City of London would be affected by 24 hour services on the Central Line.

The Chairman expressed thanks to the Remembrancer's Department for a successful Licensing Committee Dinner on 16 April 2015 and was particularly grateful to staff who secured an excellent new venue at short notice.

#### Summary

This report compares the revenue outturn for the services overseen by your Committee in 2014/15 with the final budget for the year. Overall total net expenditure during the year was £96,000 whereas the total budget was £179,000 representing an underspending of (£83,000) as set out below:

The underspend was largely due to a contingency for Late Night Levy related expenditure that was not required, and changes in the cost and attribution of central department recharges.

The Director of Markets and Consumer Protection has submitted a request to carry forward underspendings, and this request will be considered by the Chamberlain in consultation with the Chairman and Deputy Chairman of the Resource Allocation Sub Committee.

#### **Main Report**

#### **Revenue Outturn for 2014/15**

1. Actual net expenditure for your Committee's services during 2014/15 totalled £96,000, an underspend of (£83,000) compared to the final budget of £179,000. A summary comparison with the final budget for the year is tabulated below. In this and subsequent tables, figures in brackets indicate income or in hand balances, increase in income or decreases in expenditure.

- 2. The most significant local risk variation was a (£28,000) contingency for Late Night Levy (LNL) related expenditure that was not required during 2014/15. Unapplied LNL income is treated as a receipt in advance and has been carried forward to be spent during 2015/16. A full financial report on the LNL will be brought to your Committee after the end of the Levy year to 30 September 2015. The balance of the underspend was made up of small variances across a number of budgets.
- 3. The reduction in capital and support services is due to changes in the level and attribution of central costs, most significantly the Town Clerk's Department (£41,000).
- 4. Appendix 1 shows the movement from the 2014/15 latest approved budget (as reported to your Committee in October 2014) to the final budget.

#### **Local Risk Carry Forward to 2015/16**

5. The Director of Markets and Consumer Protection has a local risk underspending of (£33,000) on the activities overseen by your Committee. The Director also had local risk underspendings totalling (£735,000) on activities overseen by other Committees. The Director is proposing that his maximum permitted underspend

of £413,000 be carried forward, of which £5,000 relates to activities overseen by your Committee for the following purpose:

 Overtime for street trading enforcement out-of-hours (particularly in relation to ice-cream vans) and to facilitate reallocation of stalls at Middlesex Street due to structural alterations – £5,000

### **Summary:**

This report details the premises licences, and variations to premises licences, granted under the Licensing Act 2003 by the Licensing Service from 1 April 2015 to 30 June 2015. It does not include any premises where Members have been involved in the decision making process i.e. decisions made at licensing sub-committee hearings.

The report gives a summary of the enforcement action taken under the Licensing Act 2003 between 1 April 2015 and 30 June 2015. This report also presents data from the 'traffic light' risk scheme introduced within the City of London on 1 April 2013. The data covers the period 1 December 2014 to 31 May 2015.

## **Main Report**

## **Premises Licence Applications**

- 1. Pursuant to the instructions from your committee, I attach for your information a list detailing 'premises licence' applications (Appendix I) and variations (Appendix II) granted by the Licensing Service between 1 April 2015 and 30 June 2015.
- 2. The report also contains information appertaining to the number of personal licences issued. This information is also contained in Appendix II.
- 3. Any questions of detail concerning premises licences can be obtained from the Corporation's public register which can be found on <a href="http://www.cityoflondon.gov.uk/business/licensing/alcohol-and-entertainment/Pages/Search-the-public-register.aspx">http://www.cityoflondon.gov.uk/business/licensing/alcohol-and-entertainment/Pages/Search-the-public-register.aspx</a>. or by contacting Peter Davenport, Licensing Manager, on extension 3227 or by email to the Licensing Team at licensing@cityoflondon.gov.uk.

4. Appendix IV details the conditions attached to the premises licences listed in Appendices I and II.

#### **Routine Enforcement**

- 5. This report also outlines the enforcement activity of the Licensing Service in relation to premises with a licence granted under the Licensing Act 2003 (Appendix III). The table in Appendix III shows the number of visits undertaken, number of complaints received and the number of enforcement actions taken. Enforcement actions include warning letters, notices, simple cautions, legal proceedings etc.
- 6. Appendix III provides data from 1 April 2015 to 30 June 2015.
- 7. Licensing Officers undertake routine enforcement visits checking on premises licence conditions where there are concerns, e.g. closing times, compliance with Temporary Event Notices and managing numbers of people consuming alcohol outside venues, and also in response to complaints. The Departmental Policy Statement on Enforcement is followed prior to escalating action and taking legal proceedings.
- 8. The Departmental Policy Statement on Enforcement conforms to the Regulators' Compliance Code and the regulatory principles required under the Legislative and Regulatory Reform Act 2006. It sets out the general principles and approach which Officers are expected to follow and addresses issues of proportionality, consistency, targeting, transparency and accountability.
- 9. More widely, enforcement arrangements are currently coordinated at the Licensing Liaison Partnership meetings that are held monthly and are attended by representatives from all enforcement agencies. Joint visits are organised via this forum and subsequent reports are used to add to the top level premises list that that comprises those premises that have accrued the most points under the 'traffic light' risk scheme. These are then targeted by relevant enforcement officers.
- 10. This report details data produced from the 'traffic light' risk scheme for the period of 1 December 2014 to 31 May 2015. For the first time since the scheme began in April 2013 there are no premises classified as 'Red'. 7 premises have a sufficient number of points to be classified as 'Amber'. Further details can be seen in Appendix V.
- 11. There is a very good working relationship between the Port Health & Public Protection (PH&PP) Licensing Team, The City of London Police

- Licensing Team and the PH&PP Pollution Control Team, all of whom are based at Walbrook Wharf.
- 12. The Memorandum of Understanding (MoU) between the City of London Police and the Markets and Consumer Protection Department agreed in November 2011 outlines specific arrangements for cooperation between the Licensing Teams.
- 13. The other City Corporation Department that is routinely involved in enforcement is the Department of the Built Environment (DoBE). Where it appears that a material change of use has occurred, or there is a failure to comply with any condition attached to a planning permission or a breach of planning controls, when it is expedient to do, officers from this Department seek authorisation to take enforcement action under the Town and Country Planning Act 1990.

## Response to complaints

- 14. Any complaints about licensed premises are dealt with by the relevant agency/team, e.g. crime and disorder Police, fire safety London Fire Brigade. As far as PH&PP are concerned, complaints relating to the conditions on a licence will be dealt with in the first instance by the Licensing Team, but if there are noise issues the Pollution Team will also be involved.
- 15. Investigations are undertaken and if there are grounds for a review of the licence in relation to the licensing objectives, then the responsible authorities can apply accordingly. In practice, potential applications are considered at the Licensing Liaison Partnership meetings, and agencies/authorities support one another in providing evidence and making applications.

#### Summary

This report outlines the steps taken by the licensing team on discovering offences committed by a premises in Eastcheap.

The offences concerned selling alcohol without the correct authorisation contrary to s.136 of the Licensing Act 2003. The premises licence had previously been suspended for non-payment of their licence fee and they were in breach of a mandatory condition in that they refused to supply tap water.

The matter was taken to court and the licence holder (a limited company) and the Designated Premises Supervisor received between them fines and costs totalling £5,589.

#### Recommendations

#### **Main Report**

## **Background**

- On 4 September 2013 two licensing officers visited the premises of Viet Café, 20 Eastcheap. The purpose of the visit was to ascertain if the premises were selling alcohol as their premises licence had been suspended on 26 June 2012 for non-payment of the annual fee.
- 2. The premises were suspected of selling alcohol as they were seen by one of the officers on a television programme that was looking at the problems associated with the 'Walkie-Talkie' building. The premises happened to appear in one of the screen shots and wine glasses could be clearly seen on the tables.
- During the visit officers noticed bottles of beer available for self service in a refrigerator and purchased two. An offence had now been committed by the licence holder and the designated premises supervisor (DPS) by selling alcohol without the correct authorisation contrary to s.136 of the Licensing Act 2003. Officers cautioned the seller and left the premises with a view to continuing the matter under formal interview.
- Following a number of attempts to arrange a formal interview the DPS finally attended an interview at Walbrook Wharf on 24 October. He was also representing the licence holder as a director of the company DCHH(UK) Ltd. Page 27

The premises licence was transferred to them on 13 August 2013. The interview was stopped early as the licensing officers were not convinced that the DPS could fully understand the questions. He was told that a further date would be arranged with an interpreter present.

- 5. The second interview was arranged for 4 December 2013 having secured the services of a Vietnamese interpreter.
- 6. I the meantime, on 14 November 2013 the Licensing Service received a complaint by a member of the public concerning the premises Viet Cafe at 20 Eastcheap. The complainant alleged that whilst ordering a meal he asked three times for some tap water. The premises refused to give him tap water and in fact laughed at him stating that, 'We do not serve tap water here'.
- 7. On the 28 November 2013 the Licensing Service carried out a test purchase which involved the purchase of a meal. After the food was ordered the officer asked for two glasses of tap water and was told by a member of Viet Café's staff that it was a policy of the restaurant not to serve tap water.
- 8. The premises' DPS was informed of the refusal to supply tap water and told the matter would also be discussed at interview on 4 December. Refusal to supply tap water is in itself a breach of a mandatory condition thus creating the offence of selling alcohol without the correct authorisation contrary to s.136 of the Licensing Act 2003.
- 9. The legislation creates a statutory defence for the licence holder and DPS of their actions being due to a mistake, reliance on information from another person, an act or omission by another person or some other cause beyond his control. In addition, it would have to be shown by the licence holder and DPS that they took all reasonable precautions and exercised all due diligence to avoid committing the offence.
- 10. Following the conclusion of the second interview licensing officers were satisfied that the statutory defence could not be relied upon and that the DPS, and thus the licence holder, were culpable of a number of offences. We were satisfied that the DPS had not told the truth during the interview and in fact had gone to great lengths to present a picture aimed at misleading the licensing officers.
- 11. As a result, it was decided to instigate legal proceedings and the matter was passed to legal services to take forward. Separate charges were taken against the licence holder and the DPS essentially for the sale of alcohol on 4 September 2013, the refusal to give tap water to the complainant and the refusal to give tap water on 28 November 2013.

#### Result

- 12. The first time the matter could be actually heard was 9 October 2014 however, following a number of adjournments, the matter was not finalised until 16 June 2015. On all charges the defendants, both the company and the DPS, pleaded not guilty.
- 13. Costs were sought to cover the time spent by counsel, corporation officers, the use of an interpreter at the interview and the cost of transcribing the interview tape.

- 14. In relation to the licence holder, he was found guilty on three charges and fined a total of £1,150 plus costs of £1,607 and a victim surcharge of £75 totalling £2,132.
- 15. In relation to the DPS, he was also found guilty on three charges and fined a total of £1,400 plus costs of £1,957 and a victim surcharge of £100 totalling £3,457.
- 16. The result was a total penalty of £5,589 justifying the work of the licensing team in their perseverance over a period of 21 months from the date the investigation commenced.
