Memorial:-

Sir Gavyn Farr Arthur, formerly Alderman for the Ward of Cripplegate

Resolved unanimously:- That this Court has leaned with great sorrow of the death of Sir Gavyn Farr Arthur, formerly the Alderman for the Ward of Cripplegate. Born in Natal, South Africa and educated at Harrow and Christchurch, Oxford, Sir Gavyn's civic career commenced in 1988 following his election as Common Councilman for the ward of Farringdon Without. Thereafter, in 1991 he was elected to this Court as Alderman for the Ward of Cripplegate. He served as Sheriff between 1998 and 1999 and, in 2002, he took Office as Lord Mayor. Sir Gavyn was called to the Bar in 1975 with his career culminating as a Deputy High Court Judge in 1998.

Sir Gavyn was always an enthusiastic supporter of the Court of Aldermen, the Honourable the Irish Society and the three Livery companies of which he had been Master: the Worshipful Company of Gardeners, the Worshipful Company of Wax Chandlers and the Guild of Freemen of the City of London.

Following his retirement from this Court in 2008, upon his appointment as one of Her Majesty's judges, Sir Gavyn remained passionate about travel, history and writing.

The members of this Court wish to take this opportunity to convey their sincere and heart-felt sadness at the passing of a respected, much loved and amiable former member of this Court.
