### LICENSING (HEARING) SUB COMMITTEE PROCEDURE FOR PUBLIC HEARINGS

- 1. This procedure shall apply to all public hearings conducted under the provisions of the Licensing Act 2003.
- 2. Public hearings conducted under the provisions of the Licensing Act 2003 shall take the form of a discussion led by the licensing authority. Cross-examination will be permitted when the Sub Committee considers it to be required. The conduct of hearings shall be broadly based, subject to the discretion of the Sub Committee, on the points set out below.
- 3. At the start of the hearing the Chairman of the Sub Committee will introduce him/herself and other Members of the Sub Committee as well as the City Corporation officers present. Anyone making representations will then be asked to introduce themselves and anyone accompanying them. The applicant will then do likewise.<sup>1</sup>
- 4. The Chairman will then explain the purpose of the hearing and the procedure to be followed at the hearing. The Sub Committee will then make any rulings necessary in respect of requests for witnesses to be heard in support of any of the parties making representations or the applicant.
- 5. Those making representations will then be invited to present their case. Repetition will not be permitted. Equal time will be offered to the applicant and those making representations. Where there is more than one party making representations and/or calling witnesses in support, consideration should be given to having one spokesman on behalf of all parties so as to avoid repetition. Although the use of a spokesman will be encouraged by the Sub Committee, the decision rests with those parties making representations.
- 6. In the event of disorder or persistent disregard of the authority of the Chair, the Chairman may suspend or adjourn the hearing, or require that the person(s) causing disorder or showing disregard leave the hearing.
- 7. In the event that the Sub Committee has decided that cross-examination will be permitted, the applicant will be invited to ask questions of the party(s) making representations and their witnesses (if any). The party(s) making representations and any witnesses giving evidence in support will then answer any questions put to them by members of the Sub Committee.
- 8. The applicant will then be invited to present their case and call any witnesses in support of their application. The applicant will be entitled to the same period of time to present his case as those making representations were afforded.

<sup>&</sup>lt;sup>1</sup> In hearings where a licence is being reviewed, references in this procedure to 'applicant' should be read as references to the licence holder and references to 'those making representations' should be read as references to those applying for the review.

- 9. In the event that the Sub Committee has decided that cross-examination will be permitted, those making representations will be invited to ask questions of the applicant and their witnesses (if any). The applicant and any witnesses giving evidence in support will then answer any questions put to them by members of the Sub Committee.
- 10. The Chairman will ask all parties if there is anything else they would like to add in support of their respective cases.
- 11. Those making representations will then be invited to make closing submissions followed by the applicant.
- 12. The Sub Committee will then retire to consider their decision. They may call for assistance by the representatives of the Town Clerk and/or the Comptroller & City Solicitor but those persons will play no part in the decision-making process.
- 13. In due course, the Sub Committee will return to announce their decision or to inform those present when the decision will be given.

#### 1 Introduction

- 1.1 To consider and determine, by public hearing, the application for a new premises license under the Licensing Act 2003, taking into account the representations of 'other persons' detailed in paragraph 5, and the policy considerations detailed in paragraph 6 of this report.
- 1.2 The decision of the Sub-Committee must be made with a view to promoting one or more of the four licensing objectives, namely:
  - the prevention of crime and disorder
  - public safety
  - the prevention of public nuisance
  - the protection of children from harm

#### 2 **Summary of Application**

2.1 An application made by:

Zebrano Bars & Clubs Limited 130 Shaftesbury Avenue 2<sup>nd</sup> Floor W1D 5EU was received by the City of London Licensing Authority on 4 July 2017 for a new premises licence in respect of the premises at:

Dukes House Dukes Place (18-22 Hounsditch) EC3A 7LP

- 2.2 Full details of the application are contained in the copy of the Application Form at Appendix 1.
- 2.3 It should be noted that the original application was amended on 17 July 2017 following consultation with the City of London Police Licensing Team. Details of this amendment are contained in an email sent to the Licensing Team on 17 July 2017 and is attached as Appendix 1a.
- 2.3 The application (as amended) is to provide the following activities:

- 2.4 The premises is to be open to the public between 11:00 and 03:30 Mon to Sun.
- 2.5 The supply of alcohol is for both on and off the premises.
- 2.6 The Operating Schedule submitted by the applicant suggests 'further details' and 'seasonal variations' are contained in a former premises licence, namely LN/200500086. These references were made by the applicant in error and should be ignored.

- 2.7 The Operating Schedule submitted by the applicant requests nonstandard timings on New Year's Eve. These have now been removed in the amended application (see Appendix 1a).
- 2.8 The Operating Schedule also suggests that the steps to be taken in order to promote the four licensing objectives, and which can be used as conditions consistent with the operating schedule, are contained in an Annex A. This Annex actually refers to the conditions (Annex 2) of the aforementioned previous licence.
- 2.9 However, following the amendment referred to in paragraph 2.3 references in the operating schedule to 'Please See Annex A' can now be ignored. The only conditions which are consistent with the operating schedule are contained in Appendix 2 to this report.
- 2.10 The mandatory licence conditions can be found in the Licensing Act 2003, sections 19-21. Also, in the Schedules to The Licensing Act 2003 (Mandatory Licensing Conditions) Order 2010 (as amended) and The Licensing Act 2003 (Mandatory Conditions) Order 2014.
- 2.11 To summarise the current application:
  - The terminal hours in the table above for supply of alcohol, late night refreshment, live music, recorded music and anything similar to live/recorded music are now 03:00.
  - The New Year's Eve variation has been removed.
  - The only conditions that are now consistent with the operating schedule are those listed in Appendix 2.

#### 3 <u>Licensing History of Premises</u>

- 3.1 A premises licence was originally issued to Kenglaze Ltd trading as Dukes Restaurant on 1 September 2005. The licence was transferred to Glen Eagle Limited in October 2008 and again in July 2010 to Gerald Cole where it was now trading as T-Bar.
- 3.2 The licence was once again transferred to Glen Eagle Limited in July 2010 and again in March 2015 to Automa Ltd, trading as Zebrano. The licence is no longer in existence as Automa Ltd went into administration.

3.3 The current application is to operate the premise in a similar way to that previously as a bar/club.

#### **Complaints**

- 3.4 Not applicable as premises not yet trading.
- 3.5 The premises received no complaints during the time the previous licence was in force.

#### 4 Representations from Responsible Authorities

4.1 There are no representations from responsible authorities.

#### 5 Representations From Other Persons

5.1 There are four representations from 'other persons'. The representations are against the granting of the licence on the basis that if granted it will lead to the licensing objective of 'the prevention of public nuisance' being undermined. One of the representations suggest that the cumulative effect of a number of late night premises in the vicinity is a contributable factor. The representations can be seen in full as Appendix 3(i) to 3(iv).

#### **6** Policy Considerations

6.1 In carrying out its licensing functions, the Licensing Authority must have regard to its Statement of Licensing policy and statutory guidance issued under s 182 of the Licensing Act 2003.

#### City of London Corporation's Statement of Licensing Policy

6.2 The following sections/paragraphs of the City of London Corporation's Statement of Licensing Policy are particularly applicable to this application.

Paragraphs 27 and 75 state that residents have a reasonable expectation that their sleep will not be unduly disturbed between the hours of 23:00 and 07:00.

The boxed comment on page 19 states the need to strike a fair balance between the benefits to a community of a licensed venue, and the risk of disturbance to local residents and workers.

The boxed comment on page 19 also states an overriding policy principle namely, that each application will be decided on its individual merits.

Paragraphs 79 - 81 address the need of care when controlling noise particularly from those persons leaving a premises.

The boxed comment on page 22 considers various factors that should be taken into account when considering whether any licensable activity should be permitted.

Paragraphs 115-121 state the Corporation's policy on setting conditions which may be applicable dependant on the step(s) taken by members as stated in paragraph nine of this report.

#### **Statutory Guidance**

6.3 The following sections/paragraphs of the statutory guidance issued under s182 of the Licensing Act 2003 are particularly applicable to this application (revised April 2017):

Chapter 2 of the guidance covers the four licensing objectives. In particular, paragraph 2.15 states that it is, '...important that in considering the promotion of [the public nuisance licensing objective, licensing authorities] focus on the effect of the licensable activities at the specific premises on persons living and working (including those carrying on business) in the area around the premises which may be disproportionate and unreasonable.' Also, paragraph 2.16 indicates that the prevention of public nuisance could, in appropriate circumstances include, 'the reduction of the living and working amenity and environment of other persons living and working in the area of the licensed premises.'

Chapter 10 refers to conditions attached to premises licences with paragraph 10.10 stating that, 'Conditions should be determined on a

case-by-case basis and standard conditions which ignore these individual aspects should be avoided.' Also, 'Licensing authorities should therefore ensure that any conditions they impose are only those which are appropriate for the promotion of the licensing objectives.'

#### 7 Map and Plans

- 7.1 A map showing the location of the premises together with nearby licensed premises is attached at Appendix 4. A key of those premises is included which indicates the maximum permitted hours for alcohol sales or other licensable activity in respect of each premises.
- 7.2 Plans of the premises are attached as Appendix 5.

#### 8 Summary

8.1 The Licensing Authority has a duty under the Licensing Act 2003 to promote the Licensing Objectives. Each objective has equal importance. In carrying out its licensing functions, the Licensing Authority must also have regard to its Statement of Licensing Policy, any Statutory Guidance under the Licensing Act 2003 and is bound by the Human Rights Act 1998. The Corporation must also fulfil its obligations under section 17 of the Crime and Disorder Act 1998 to do all that it reasonably can to prevent crime and disorder in the City.

#### 9 Options

- 9.1 The Sub-committee must, having regard to the representations, take such of the following steps as it considers appropriate for the promotion of the licensing objectives:
  - i) grant the licence subject to any conditions consistent with the operating schedule modified to such extent as the Subcommittee considers appropriate for the promotion of the licensing objectives and include the mandatory conditions contained in Ss. 19-21 of the Licensing Act 2003;
  - ii) exclude from the scope of the licence any of the licensable activities to which the application relates;
  - iii) To refuse to specify a person in the licence as the premises supervisor;
  - iv) Reject the application.

For the purposes of paragraph 9.1(i) conditions consistent with the operating schedule are modified if any of them are altered or omitted or any new condition is added.

9.2 Where a licensing authority takes one or more of the steps stated in paragraph 9.1 above the applicant, or the holder of the licence and/or a person who made relevant representations in relation to the application, may appeal the decision to the Magistrates' Court. Any appeal must be commenced within 21 days following notification of the decision to the appellant by the licensing authority.

#### 10 Recommendation

10.1 It is therefore RECOMMENDED that your Sub-Committee determine this application for a premises licence in accordance with paragraph 9 of this report.

I refer to our application for a premises licence for Zebrano, Dukes House, London, EC3A 7LP.

I confirm that our client is agreeable to the conditions in italics below (as proposed by the Police) being placed on the premises licence and should be grateful if the application could be amended accordingly.

- A. Terminal hour to be 03:00 every day Monday to Sunday
- B. New Year's Eve variation to hours **not** to be requested on the application.

To include the following conditions:

- 1. The premises licence holder shall advise the Police of any promoted event that is to take place at the premises by completing a Risk Assessment form provided by the Police. Promoted events shall only be held on a Saturday night and the form must be submitted to the City of London Police Licensing Office, at least 14 days before the event. Promoted events may only commence on or after 1800 hours on Saturday and must have ceased no later than 0300 the following day. Police have the absolute right to veto any promoted event where they consider that the Licensing Objectives will be undermined if it were to go ahead. A promoted event is defined as follows:
  - \* A promoted event is an event involving music and/or dancing where the musical entertainment is provided at any time by a disc jockey or disc jockeys one or some of whom are not employees of the licensee (premises license holder) and/or the event is (independent of the licensee) promoted to the general public.

- 2. When promoted events are held door supervisors shall be employed on a ratio of 1:50 patrons. At least one member of the door staff shall be female. All door supervisors will wear and use functioning body worn cameras. The images captured on body worn cameras will be made available for viewing by Police or other authorised persons immediately on request.
- 3. The premises shall install and maintain a comprehensive digital colour CCTV system. All public areas of the licensed premises, including all public entry and exit points, will be covered enabling facial identification of every person entering in any light condition. The CCTV cameras shall continually record whilst the premises are open to the public and recordings shall be kept available for a minimum of 31 days with date and time stamping. A staff member who is conversant with the operation of the CCTV system shall be present on the premises at all times when they are open to the public. This staff member shall be able to show the police or the Licensing Authority recordings of the preceding two days immediately when requested.

To remove all of the Annex 2 conditions which are proposed on the application dated 4<sup>th</sup> July 2017, numbered 1-9 inclusive as well as mention of the safer clubbing code.

I am writing in respect of Zebrano's intention to renew/extend its licence operation/hours for its operations in the area near my flat.

In additional to the recent applications for three new late-night venues around the area of our flats (namely Beer and Buns, Brewskee and Bob-Bob Exchange), I am shocked to know that there is yet another application to the late night entertainments in the area.

My experience from living in Creechurch Lane for the last eight years has shown me time and time again that licensed premises are unable and uninterested at controlling the early morning noise created by their clientele when they leave the premises. I am being woken up in the early hours of morning by punters leaving Swingers, Zebrano, Pause and Revolution regularly in the weekends.

I now note that Zebrano is applying to remain open until 3am Monday-Wednesday, 4am Thursday and Sunday and 6am on Friday/Saturday. Together with the long hours and a Sunday opening means that there would not be one night/early morning when I will have any respite from revellers noise.

In addition to noise, punters also leave litter on the street. More alarmingly, our courtyard is also being regularly used as an urinal (and on one occasion even worse) by punters.

All the above effects are not only unpleasant in the extreme but also create a sense of physical insecurity within the close space of my home.


All these worries have also been justified by the murder from stabbing, committed after just such a late night licenced event, in the Caravaggio Restaurant on Leadenhall Street near to my flat last year.

Discussions with the City of London Police and the noise control team at your corporation, who are in agreement with us in not wanting any more licensed premises in the City, apparently have had no effect as I see more and more late night licensing applications being considered.

In view of the likely effects on our well being and quiet enjoyment of our home, my fellow residents and I would really appreciate if Zebrano's application for extended licensing hours could be curtailed now.

Any assistance that you could provide on this matter would be gratefully received.

In that case, I am upholding my representation, as off sales = outside noise - and a 3am licence means being impacted until 4-5am as it takes that long for people to carry out some screaming/shouting before they eventually leave the area.

We didn't get a chance to object to the initial license as unfortunately didn't learn of the bar until it opened. This doesn't mean we haven't been unhappy about its operation. As for complaining, sometimes we do contact the noise team, but if we can't detect which bar is the culprit, the will to dress/head out at 4am, not to mention the fear of facing drunken punters usually stops us from pursing further.

We frequently see bottles, drug paraphernalia etc in/outside our courtyard as they head towards Fenchurch St station... WHY are these licensed premises not made to better enforce the quiet dispersal of their clientele? Perhaps an extra surcharge could be payable to the City Police so that they handle this?

To whom it may concern,

In additional to the recent applications for 3 new late-night venues around the area of our flats (namely Beer and Buns, Brewskee and Bob-Bob Exchange) - we understand Zebrano is looking to renew/extend its licence operation/hours - due to a CVA.

We residents know from experience that licensed premises are unable and inept at controlling the early morning noise their clientele submits us to as they leave the premises. Consequenty we are regularly woken at 2,3 4am by punters leaving Swingers, Zebrano, Pause and Revolution.

We note that Zebrano's are looking to remain open until 3am Monday-Wednesday, 4am Thursday and Sunday and 6am on Friday/Saturday. The long hours and a Sunday opening means there is not one night/early morning when we have respite from revellers noise.

Punters noise - thanks to not being properly/effectively dispersed - is not the only issue from late-nighters. Besides the inevitable litter, more seriously, we suffer from our courtyard being used as an urinal and on one occasion even worse...

I trust you will appreciate that this is unpleasant in the extreme and something that no-one should have to suffer.

Lastly, and most seriously, it may be recalled that when Caravaggios near us on Leadenhall Street enjoyed a late-night licence, there was a death by stabbing.

This has lead to residents feeling very unsafe when returning at night; a situation we should not have to live through again.

Following encounters with the City Police and your noise team, they are in agreement about not wanting any more licensed premises in the City - yet this falls on deaf ears.

It would be much appreciated if this application's licensing hours are curtailed because of the impact on us residents.

I write to object to the application for extended opening hours at the subject premises.

I live at Flat Creechurch Lane, London. EC3A 5AY.

I have seen a number of applications in recent weeks, all of which have the potential to affect the quality of life in our area. I suspect that those making the applications consider the area as a business district and have little or no consideration to the fact that there are residents.

As the matter stands, even with few of these establishments in our area, we suffer from late-night noise. Additionally, we find that our courtyard is regarded by their clientele as a convenient place to urinate and, on one occasion, even to defecate. I hope that it will be agreed that for we residents to have to suffer this is unreasonable and that it is a threat to our health.

I know (because I have been contacted directly by one of them) that the proprietors think that they can control their clientele after they have left the premises to keep disruption to a minimum. My experience is that they cannot and that regardless of their efforts, we suffer from their presence so late into the morning.

Lastly, it will be recalled that, when Caravaggio was allowed a late licence, there was a death by stabbing. I was extremely grateful that the establishment closed its late-night doors soon after, as the presence of the clientele in our neighbourhood late at night caused much concern for personal safety when returning home at the wrong time. I do not want to have to feel unsafe in my own neighbourhood.

I hope that this and the other applications will be dealt with the full consideration that this is a residential area and that we have a right to a certain quality of life which should not be impacted by late-night noise or, indeed, a fear for our own safety.

While these applications appear to be being dealt with on an individual basis the overall impact on what is a residential / business district is not being considered.
