LICENSING (HEARING) SUB COMMITTEE PROCEDURE FOR PUBLIC HEARINGS

- 1. This procedure shall apply to all public hearings conducted under the provisions of the Licensing Act 2003.
- 2. Public hearings conducted under the provisions of the Licensing Act 2003 shall take the form of a discussion led by the licensing authority. Cross-examination will be permitted when the Sub Committee considers it to be required. The conduct of hearings shall be broadly based, subject to the discretion of the Sub Committee, on the points set out below.
- 3. At the start of the hearing the Chairman of the Sub Committee will introduce him/herself and other Members of the Sub Committee as well as the City Corporation officers present. Anyone making representations will then be asked to introduce themselves and anyone accompanying them. The applicant will then do likewise.¹
- 4. The Chairman will then explain the purpose of the hearing and the procedure to be followed at the hearing. The Sub Committee will then make any rulings necessary in respect of requests for witnesses to be heard in support of any of the parties making representations or the applicant.
- 5. Those making representations will then be invited to present their case. Repetition will not be permitted. Equal time will be offered to the applicant and those making representations. Where there is more than one party making representations and/or calling witnesses in support, consideration should be given to having one spokesman on behalf of all parties so as to avoid repetition. Although the use of a spokesman will be encouraged by the Sub Committee, the decision rests with those parties making representations.
- 6. In the event of disorder or persistent disregard of the authority of the Chair, the Chairman may suspend or adjourn the hearing, or require that the person(s) causing disorder or showing disregard leave the hearing.
- 7. In the event that the Sub Committee has decided that cross-examination will be permitted, the applicant will be invited to ask questions of the party(s) making representations and their witnesses (if any). The party(s) making representations and any witnesses giving evidence in support will then answer any questions put to them by members of the Sub Committee.
- 8. The applicant will then be invited to present their case and call any witnesses in support of their application. The applicant will be entitled to the same period of time to present his case as those making representations were afforded.

¹ In hearings where a licence is being reviewed, references in this procedure to 'applicant' should be read as references to the licence holder and references to 'those making representations' should be read as references to those applying for the review.

- 9. In the event that the Sub Committee has decided that cross-examination will be permitted, those making representations will be invited to ask questions of the applicant and their witnesses (if any). The applicant and any witnesses giving evidence in support will then answer any questions put to them by members of the Sub Committee.
- 10. The Chairman will ask all parties if there is anything else they would like to add in support of their respective cases.
- 11. Those making representations will then be invited to make closing submissions followed by the applicant.
- 12. The Sub Committee will then retire to consider their decision. They may call for assistance by the representatives of the Town Clerk and/or the Comptroller & City Solicitor but those persons will play no part in the decision-making process.
- 13. In due course, the Sub Committee will return to announce their decision or to inform those present when the decision will be given.

1 Introduction

1.1 To consider and determine, by public hearing, the application for a new premises license under the Licensing Act 2003, taking into account the representations of 'other persons' detailed in paragraph 5, and the policy considerations detailed in paragraph 6 of this report.

- 1.2 The decision of the Sub-Committee must be made with a view to promoting one or more of the four licensing objectives, namely:
 - the prevention of crime and disorder
 - public safety
 - the prevention of public nuisance
 - the protection of children from harm

2 **Summary of Application**

2.1 An application made by:

Lucky Voice (Soho) Ltd **Eastcastle House** 27 – 28 Eastcastle Street W1W 8DH

was received by the City of London Licensing Authority on 2 August 2017 for a new premises licence in respect of the premises at:

Lucky Voice 111 Fleet Street EC4A 2AB

- 2.2 Full details of the application are contained in the copy of the Application Form at Appendix 1.
- 2.3 The application is to provide the following activities:

- 2.4 In addition to the table above, the applicant is seeking to extend the timings above by an additional hour on the morning that British Summer Time commences.
- 2.5 The premises will be open to the public between 13:00 and 00:30 Mon to Wed, 13:00 and 02:30 Thu to Sat, and 13:00 and 23:30 on Sun.

The supply of alcohol is for on the premises only.

2.6 The Operating Schedule submitted by the applicant suggests a number of steps intended to be taken in order to promote the four licensing objectives. Those conditions which are consistent with the operating

schedule and could be included on the licence are attached as Appendix 2.

2.7 The mandatory licence conditions can be found in the Licensing Act 2003, sections 19-21. Also, in the Schedules to The Licensing Act 2003 (Mandatory Licensing Conditions) Order 2010 (as amended) and The Licensing Act 2003 (Mandatory Conditions) Order 2014.

3 Licensing History of Premises

- 3.1 This a new application and the premises has not had a premises licence before.
- 3.2 The premises is to be used as a karaoke bar with karaoke rooms and bar situated at basement level.
- 3.3 An application was previously submitted on 26 May 2017 and was due to go to a hearing on 24 July 17. The application was withdrawn and now re-submitted following further consultation with the Environmental Health Pollution Team, local members and local residents.

Complaints

3.4 Not applicable as premises not yet trading.

4 Representations from Responsible Authorities

4.1 There are no representations from responsible authorities.

5 Representations From Other Persons

- 5.1 There are ten representations from 'other persons'. The representations are against the granting of the licence primarily on the on the basis that if granted it will undermine the licensing objective of 'the prevention of public nuisance'.
- 5.2 Many of those persons making a representation suggest 23:00 as a suitable terminal hour. Many of the letters of objection also suggest a number of conditions they would like to see on the premises licence if

granted, most of which are contained in the application's operating schedule. The representations can be seen in full as Appendix 3.

6 Policy Considerations

6.1 In carrying out its licensing functions, the Licensing Authority must have regard to its Statement of Licensing policy and statutory guidance issued under s 182 of the Licensing Act 2003.

City of London Corporation's Statement of Licensing Policy

6.2 The following sections/paragraphs of the City of London Corporation's Statement of Licensing Policy are particularly applicable to this application.

Paragraphs 27 and 75 state that residents have a reasonable expectation that their sleep will not be unduly disturbed between the hours of 23:00 and 07:00.

Paragraphs 79 - 81 address the need of care when controlling noise particularly from those persons leaving a premises.

The boxed comment on page 19 states the need to strike a fair balance between the benefits to a community of a licensed venue, and the risk of disturbance to local residents and workers.

The boxed comment on page 19 also states an overriding policy principle namely, that each application will be decided on its individual merits.

The boxed comment on page 22 considers various factors that should be taken into account when considering whether any licensable activity should be permitted.

Paragraphs 115-121 state the Corporation's policy on setting conditions which may be applicable dependant on the step(s) taken by members as stated in paragraph nine of this report.

Statutory Guidance

6.3 The following sections/paragraphs of the statutory guidance issued under s182 of the Licensing Act 2003 are particularly applicable to this application (revised April 2017):

Chapter 2 of the guidance covers the four licensing objectives. In particular, paragraph 2.15 states that it is, '...important that in considering the promotion of [the public nuisance licensing objective, licensing authorities] focus on the effect of the licensable activities at the specific premises on persons living and working (including those carrying on business) in the area around the premises which may be disproportionate and unreasonable.' Also, paragraph 2.16 indicates that the prevention of public nuisance could, in appropriate circumstances include, 'the reduction of the living and working amenity and environment of other persons living and working in the area of the licensed premises.'

Chapter 10 refers to conditions attached to premises licences with paragraph 10.10 stating that, 'Conditions should be determined on a case-by-case basis and standardised conditions which ignore these individual aspects should be avoided.' Also, 'Licensing authorities should therefore ensure that any conditions they impose are only those which are appropriate for the promotion of the licensing objectives.'

7 Map and Plans

- 7.1 A map showing the location of the premises together with nearby licensed premises is attached at Appendix 4. A key of those premises is included which indicates the maximum permitted hours for alcohol sales in respect of each premises along with the latest terminal hour for any other licensed activity if greater.
- 7.2 Plans of the premises are attached as Appendix 5.

8 Summary

8.1 The Licensing Authority has a duty under the Licensing Act 2003 to promote the Licensing Objectives. Each objective has equal importance. In carrying out its licensing functions, the Licensing

Authority must also have regard to its Statement of Licensing Policy, any Statutory Guidance under the Licensing Act 2003 and is bound by the Human Rights Act 1998. The Corporation must also fulfil its obligations under section 17 of the Crime and Disorder Act 1998 to do all that it reasonably can to prevent crime and disorder in the City.

9 Options

- 9.1 The Sub-committee must, having regard to the representations, take such of the following steps as it considers appropriate for the promotion of the licensing objectives:
 - i) grant the licence subject to any conditions consistent with the operating schedule modified to such extent as the Subcommittee considers appropriate for the promotion of the licensing objectives and include the mandatory conditions contained in Ss. 19-21 of the Licensing Act 2003;
 - ii) exclude from the scope of the licence any of the licensable activities to which the application relates;
 - iii) To refuse to specify a person in the licence as the premises supervisor;
 - iv) Reject the application.

For the purposes of paragraph 9.1(i) conditions consistent with the operating schedule are modified if any of them are altered or omitted or any new condition is added.

9.2 Where a licensing authority takes one or more of the steps stated in paragraph 9.1 above the applicant, or the holder of the licence and/or a person who made relevant representations in relation to the application, may appeal the decision to the Magistrates' Court. Any appeal must be commenced within 21 days following notification of the decision to the appellant by the licensing authority.

10 Recommendation

10.1 It is therefore RECOMMENDED that your Sub-Committee determine this application for a premises licence in accordance with paragraph 9 of this report.

We write to strongly object to the above application: Lucky Voice, <u>111 Fleet Street EC4A 2AB</u>. We are residents at Bride Court, EC4Y 8DU and own a rental property in Sovereign House, Poppins Court, EC4A 4AX.

We understand that the applicants have amended the most recent application to slightly reduce the opening hours. This amendment is not material enough to mitigate our concerns as below:

The 7 days a week hours and in particular the 0200 closing time on the busiest social days each week (Thurs-Sat) will cause public nuisance with people coming and going at all hours and will disturb what should be a resident's right for a peaceful night sleep between 2300 and 0700. We have already experienced with other establishments where conditions on a licence do not manage people's behaviour once they are outside of the licensed premises on public pavements and 0200 is not suitable for this area. We are concerned that further noise is against licensing policy which states that residents have a reasonable expectation not to be unduly disturbed between 2300 and 0700. Also we do not see how this would align with the prevention of public nuisance which we understand is a licensing objective the City is promoting.

We already experience antisocial behaviour with existing local establishments with late licenses, with rubbish, noise, urinating, vomiting and drinking on the streets. Another late license of the nature being applied for, where people will be expecting to party early into the morning, will be unacceptable.

Overall, we question the appropriateness of a karaoke bar in this area. There must be more useful services that can be provided to city people that are in keeping with the high standards set by the City Council.

Please can you acknowledge this objection and confirm when the hearing will take place so we are kept informed and can consider the application.

I am writing to object to this application.

I have been a resident of the City of London since 1999. I live in Sovereign House with my young family. We love living in the very heart of the City. We enjoy being able to walk to work (and school sometimes) and live a car-free life with great ease. Everyday we are privileged to walk past historic architecture and iconic views of London. We appreciate the diversity and choices we are able to make by living in the City. We are, however, realistic and we do accept that urban living has some challenges for families and residents generally. Noise levels are one challenge and in order to minimise it, we have already installed triple glazing to keep the noise of the City at an acceptable level for us to live and sleep in this very busy area.

I am extremely concerned that if the licence is granted to Lucky Voice Ltd ("the Club"), in its unmodified form, it will lead to an enormous amount of disturbance to my family's peaceful enjoyment of our nights and in particular our sleep in our home, in the City and to the local residents more generally. I also wonder whether the Club would diminish the "ceremonial grandeur" of Fleet Street and its surrounding areas.

My specific concerns are as follows:

1. Noise within the Club- regulated entertainment

The noise levels and vibrations caused by the live music, recorded music and films within the Club should be controllable, I hope, by any necessary conditions that are imposed on the licence so as not to disturb residents and surrounding businesses.

2. Noise and disturbances outside the Club

Given the proximity of the Club to residential property, I do not consider the terminal hours of 00.00 Monday to Wednesday and 02.00 Thursday to Saturday to be acceptable. The consequence of these terminal hours is that after 00.30 and 02.30 (on the relevant days) members of the public will still be leaving the premises of the Club. The terminal hours for the Club should surely be 23.00 for everyday of the week, in keeping with the rest of the block.

The additional conditions proposed by the applicant, including registered door supervisors should be welcomed, however, it is still not clear to me how the registered door supervisors or indeed a "written dispersal policy" can negate any public disturbance or antisocial behaviour on public pavements and surrounding streets. Whilst it would be interesting to know what detail a written dispersal policy might contain, there is clearly a limit to what registered door supervisors can do to enforce such a policy and inhibit noise or antisocial behaviour in public streets.

I think that the specific geographic layout of Fleet Street, Poppin's Court and St Bride's Street and the bus stop just outside the Club, is material to this licence application:

- Sovereign House is a triangular building with 15 flats, which has windows on both sides, namely on Poppin's Court and St Bride's Street and therefore residents of Sovereign House may be disturbed from both sides of the building.
- If you leave the Club left along Fleet Street you come upon St Bride's Street with a pleasant pedestrianised area with seating. After 00.30 or worse still 02.30, it will be very disruptive having this as the spill-out area for the Club.
- If you leave the Club and turn right along Fleet Street you will find Poppin's Court
 directly to your right. At night, despite being well lit, Poppin's Court is potentially a
 little intimidating for the safety conscious. If Poppin's Court becomes filled with the
 Club's smokers and revellers, Poppin's Court will become even less attractive to walk
 down at night for residents to get home.
- I anticipate that Poppin's Court will become the cigarette smoking area for the Club during the night (as it is for City workers during the day). It would be very helpful to know where the Club anticipates their guests smoke and how it plans to deal with the inevitable littering and noise.
- I would highlight that no other business on this block is open after 23.00 (some nights 22.00) and most are closed much earlier and nearly all are closed at the weekend.
- I note that the City of London Police are extremely responsive and helpful, if necessary, but surely have much better things to do that deal with than late night disturbances and anti-social behaviour.

3. Fleet Street Conservation Area

The Club is located on the ceremonial route along Fleet Street to St Paul's Cathedral, nearly opposite St Bride's Church and is within the Fleet Street Conservation Area. The Poppin's Court and St Bride's Street area abuts the Shoe Lane Quarter, with its new enhancement scheme.

The request for the Club to be open 7 days a week and for such extended hours, including daytime hours, feels to me inappropriate and incongruous given its location on the ceremonial route to St Paul's Cathedral and proximity to St Bride's Church.

Despite many internet searches and walking up and down Fleet Street numerous times, I have not found any other night clubs present on the ceremonial route along Fleet Street.

Amendments to licence

I would ask that:

- 1. the licence does not allow a full 7 days a week opening; and
- 2. the licensing terminal hours be set to be no later than 23.00, and the following of the Corporation's model conditions should be imposed:
 - All doors and windows to be kept closed at all times save for entry or exit (MC13), and no loudspeakers to be located in the entrance lobby (MC14).
 - No consumption of drinks to be permitted outside the premises (MC17) and no sales of alcohol for consumption off the premises (MC28).
 - No promoted events allowed (MC02).
 - The Licence Holder shall make a contact telephone number available to nearby residents and City of London Licensing Team to be used in the event of complaints arising (MC19).
 - Registered door supervisors as specified in the licence application.
- 3. In addition, noise generated by amplified music should be controlled by a noise limiting device set at a level determined by a City Corporation Environmental Health Officer (EHO), and should not be adjusted without the consent of an EHO.

Dear City of London

I refer to the planning and licensing applications made by Lucky Voice (Soho) Ltd in respect of 111 Fleet Street, London, EC4A 2AB.

I am a local resident living on one of the pedestrian streets off Fleet Street.

I understand there is a planning application 17/00530/FULL, and also a licensing application. I have previously made objections in regard to these applications. I refer to my email to licensing@cityoflondon.gov.uk on Jun 27 at 9:04 AM, and my comments on the planning poplanning2.cityoflondon.gov.uk submitted on Fri 28 Jul 2017.

I have since had a meeting with the management of Lucky Voice in order to express my concerns and hear from them directly. They appeared to be professional and were proposing revised conditions which they hoped would address the concerns that had been raised. However, I maintain my concerns and therefore resubmit my objection.

First, a venue serving alcohol with late night entertainment will inevitably cause noise and other social disruption (in particular litter, urination and property damage), even if the management puts in place the type of revised conditions now proposed.

Indeed, the very fact that it is now proposed there be 2 registered door supervisors on duty for Thursday to Saturday reinforces that the proposed club will potentially have a large number of patrons capable of causing such social disruption.

We already have the occasional problem of drunk people in the area who shout or singing loudly, sometime fight, leaving alcoholic contains, and urinating. However, thankfully this remains limited, and the area remains generally quiet at night. It would clearly be made much worse by the proposed karaoke club.

Second, the revised proposed hours for licensable activities remain, to put it simply, anti-social. To start with, the venue would be open 7 days a week, even on a Sunday evening. This is notwithstanding that the area benefits from being quiet during the weekend. Equally, even on a Monday to Wednesday the licensing hours are proposed to be Midnight, which realistically means patrons leaving the premises at 12.30am. Moreover, the proposed hours are 2am for Thursday, Friday and Saturday, which again means patrons leaving about 2.30am.

These are far too late. If permission is to be given, it must be with licensing hours which end at 11pm at latest, similar to nearby pubs such as Ye Olde Chesire Cheese and the Old Bell Tavern. On Sundays, if open at all, the hours should end at 4pm (as with those 2 pubs).

Ultimately the area would be better served by the location remaining a restaurant as it previously was.

Thank you for considering my objection. Please let me know when there is a hearing of the application.

I have seen the objection lodged by my ward colleague Graham Packham, and agree with him that to prevent public nuisance the terminal hour should be set to be no later than 11pm, and the following of the Corporation's model conditions should be imposed:

- All doors and windows to be kept closed at all times save for entry or exit (MC13), and no loudspeakers to be located in the entrance lobby (MC14).
- No consumption of drinks to be permitted outside the premises (MC17).
- No promoted events allowed (MC02).



Dear Sir/Madam

I write to object to this application, as if it is granted unmodified it will clearly cause significant public nuisance.

The applicant runs a chain of Karaoke Bars and advertises themselves as follows: 'Scream, shout and let it all out in London's number one karaoke spot!'.

Having met with the applicant with Henrika Priest following the withdrawal of their initial application, the slight reduction in requested hours is welcome but inadequate to allay legitimate concerns. Given the business model of the applicant I accept that it is likely that they will be able to contain noise leakage within their Karaoke pods. However, once customers are decanted onto the streets at 2am after being encouraged to drink and sing loudly, disruption to residents trying to sleep would seem to be inevitable.

The main issue is the requested terminal hours (Midnight Monday to Wednesday, 2am Thursday to Saturday) which are completely unreasonable given the proximity of the premises to residential properties in Sovereign House, 5 Poppins Court (15 Flats), the 3 flats opposite at 101 Fleet Street as well as the 9 flats at 24 and 26 Bride Lane.

To prevent nuisance and help ensure that residents are able to get a decent night's sleep the terminal hour should be set to be no later than 11pm, and the following of the Corporation's model conditions should be imposed:

All doors and windows to be kept closed at all times save for entry or exit (MC13), and no loudspeakers to be located in the entrance lobby (MC14).

No consumption of drinks to be permitted outside the premises (MC17).

No promoted events allowed (MC02).

If the premises license is granted for a Karoakebar with live and recorded music in addition to sale of alcohol there is bound to be noise disturbance no matter what regulations are imposed. This will be very disturbing to the residents of this currently quiet area. It is important for us (residents) to maintain this environment without adding an unnecessary noise pollution. Dear Sir / Madam

I am writing to strongly object to this application – **re-submitting my previous objection**. My view is still that if it is granted unmodified it will cause significant public nuisance given its proximity to several residential properties.

Following my meeting with the managers of Lucky Voice, the main issue still remains, namely the now requested 2.00 am terminal hour (Thursday / Friday / Saturday) which is still completely inappropriate given the proximity of the premises to residential properties in Sovereign House, 5 Poppins Court (15 Flats), the 3 flats opposite at 101 Fleet Street as well as the 9 flats at 24 and 26 Bride Lane.

As already high-lighted by my ward colleagues, Graham Packham and Catherine McGuinness, to prevent nuisance and help ensure that residents are able to get a decent night's sleep **the terminal hour should be set to be no later than 11.00 pm.** As stated in the City of London's own Statement of Licensing Policy of 2017, residents have a reasonable expectation that their sleep will not be unduly disturbed between the hours of 23.00 and 07:00 – **this will not be the case if it runs to 2.00 am at any point during the week.**

In addition, the following the following of the Corporation's model conditions should be imposed:

- All doors and windows to be kept closed at all times save for entry or exit (MC13), and no loudspeakers to be located in the entrance lobby (MC14).
- No consumption of drinks to be permitted outside the premises (MC17).
- No promoted events allowed (MC02).

It would also be appropriate to limit the number of smokers outside and keep a door supervisor outside at all times.

I have lived in Fleet Street for over 20 years, and although very noisy during the day, the ambient noise reduces significantly during the evening in Fleet Street including the nearby lanes and streets, so much so that small groups of people talking, and sometimes individual conversations, can easily be heard in our flats. If large numbers of people mill about, coming and going, we hear it clearly, and more intensely, as sometimes happens when people are drinking on the street outside the pubs, or passing groups walk by, for example, on their way to and from Smithfield's club scene in the early mornings. We fear that with Lucky Voice this could be a permanent feature, in too close proximity, given the type of venue it is.

Again, I must stress that despite restrictions and conditions imposed **within** a licenced premises, once customers leave, there is absolutely no way they can be controlled by the licenced premises, ie to ensure how quickly they make their way away from the premises, what they get up to generally on the street, ie how much noise they make, how drunk they are, etc etc. And therein lies the real problem which will affect the local residents going forward.

I am aware that the applicants, Lucky Voice, have amended their application, with the terminal hour of 02.00am. now proposed.

As I have stated previously, I live at Poppins Court and I greatly value my residential amenity. This area is generally quiet at weekends because it is primarily an office environment interspersed with residential use. The retailers and pubs have restricted opening times.

I still wish to make a strong objection to the revised terminal hours as they would still result in significant noise nuisance and disturbance to myself and other residential occupiers in and around Poppins Court. The issue is that Lucky Voice cannot manage people's behaviour once they have left the premises, so a 02.00am closing time is not suitable for this area.


