- (iv) Agree that appointments to the new sub-committee be as follows, noting the existing delegated authority given in July to the Chairman and the Deputy Chairman to appoint the sub-committee: Alderman Prem Goyal, Alderman Gregory Jones, Alderman Vincent Keaveny, Alderman Alistair King and Alderman and Sheriff Michael Mainelli.
