LICENSING (HEARING) SUB COMMITTEE PROCEDURE FOR PUBLIC HEARINGS

- 1. This procedure shall apply to all public hearings conducted under the provisions of the Licensing Act 2003.
- 2. Public hearings conducted under the provisions of the Licensing Act 2003 shall take the form of a discussion led by the licensing authority. Cross-examination will be permitted when the Sub Committee considers it to be required. The conduct of hearings shall be broadly based, subject to the discretion of the Sub Committee, on the points set out below.
- 3. At the start of the hearing the Chairman of the Sub Committee will introduce him/herself and other Members of the Sub Committee as well as the City Corporation officers present. Anyone making representations will then be asked to introduce themselves and anyone accompanying them. The applicant will then do likewise.¹
- 4. The Chairman will then explain the purpose of the hearing and the procedure to be followed at the hearing. The Sub Committee will then make any rulings necessary in respect of requests for witnesses to be heard in support of any of the parties making representations or the applicant.
- 5. Those making representations will then be invited to present their case. Repetition will not be permitted. Equal time will be offered to the applicant and those making representations. Where there is more than one party making representations and/or calling witnesses in support, consideration should be given to having one spokesman on behalf of all parties so as to avoid repetition. Although the use of a spokesman will be encouraged by the Sub Committee, the decision rests with those parties making representations.
- 6. In the event of disorder or persistent disregard of the authority of the Chair, the Chairman may suspend or adjourn the hearing, or require that the person(s) causing disorder or showing disregard leave the hearing.
- 7. In the event that the Sub Committee has decided that cross-examination will be permitted, the applicant will be invited to ask questions of the party(s) making representations and their witnesses (if any). The party(s) making representations and any witnesses giving evidence in support will then answer any questions put to them by members of the Sub Committee.
- 8. The applicant will then be invited to present their case and call any witnesses in support of their application. The applicant will be entitled to the same period of time to present his case as those making representations were afforded.

¹ In hearings where a licence is being reviewed, references in this procedure to 'applicant' should be read as references to the licence holder and references to 'those making representations' should be read as references to those applying for the review.

- 9. In the event that the Sub Committee has decided that cross-examination will be permitted, those making representations will be invited to ask questions of the applicant and their witnesses (if any). The applicant and any witnesses giving evidence in support will then answer any questions put to them by members of the Sub Committee.
- 10. The Chairman will ask all parties if there is anything else they would like to add in support of their respective cases.
- 11. Those making representations will then be invited to make closing submissions followed by the applicant.
- 12. The Sub Committee will then retire to consider their decision. They may call for assistance by the representatives of the Town Clerk and/or the Comptroller & City Solicitor but those persons will play no part in the decision-making process.
- 13. In due course, the Sub Committee will return to announce their decision or to inform those present when the decision will be given.

1 Introduction

- 1.1 To consider and determine, by public hearing, the application for a variation of a premises license under the Licensing Act 2003, taking into account the representations of a responsible authority and 'other persons' detailed in paragraphs 4 & 5, and the policy considerations detailed in paragraph 6 of this report.
- 1.2 The decision of the Sub-Committee must be made with a view to promoting one or more of the four licensing objectives, namely:
 - the prevention of crime and disorder
 - public safety
 - the prevention of public nuisance
 - the protection of children from harm

2 **Summary of Application**

2.1 An application made by:

City Centre Events Ltd Tavistock Hotel Bedford Way London WC1H 9EU was received by the City of London Licensing Authority on 25 January 2019 for a variation of the premises licence in respect of:

The Pelt Trader Arch 3 Dowgate Hill EC4N 6AP

- 2.2 Full details of the application are contained in the copy of the Application Form at Appendix 1.
- 2.3 The variation is to change the following activities:

- 2.4 The premises are licensed to sell alcohol on the premises between the hours of 10.00 23.00 Monday to Wednesday, 10.00 00.00 Thursday to Saturday and 11.00 23.00 Sunday. Off-sales in unsealed containers are restricted to 21.00 every night. A copy of the Premises Licence can be seen in Annex 2
- 2.5 The Operating Schedule submitted by the applicant seeks to change the condition restricting off-sales at 21.00 to 22.30 and also suggests an outdoor management plan intended to promote the four licensing objectives. Those conditions which are consistent with the operating schedule and could be included on the licence are attached as Appendix 3.
- 2.6 Additionally, on 8 March 2019, the applicant's solicitor wrote to all objectors offering a number of concessions (including a possible reduction of off-sales to 22.00) and further conditions. This letter is attached as Appendix 3 (i).
- 2.7 The mandatory licence conditions can be found in the Licensing Act 2003, sections 19-21. Also, in the Schedules to The Licensing Act 2003 (Mandatory Licensing Conditions) Order 2010 (as amended) and The Licensing Act 2003 (Mandatory Conditions) Order 2014.

3 <u>Licensing History of Premises</u>

- 3.1 The unit is an arch beneath Cannon Street Station which has previously been used as a sorting office for lost property.
- 3.2 It was converted into a bar in 2012 and the first Premises Licence was granted on 11th February 2013 to Jonathan Dalton.
- 3.3 The licence was granted after a hearing before the Sub-Committee following objections from a Ward Member, Environmental Health, Workers in Cannon Bridge House and residents of Dowgate Hill including the Worshipful Companies. Off-sales in unsealed containers were restricted to the hours of 19.00 21.00. This was to allay concerns that the pavement would be obstructed when people were leaving work after 17.00.
- 3.4 Six months later the licence holder applied for a variation to permit off-sales in unsealed containers during all hours up until 21.00. It was contended that the bar had traded without any concerns during its first summer and a management plan would be put in place to prevent obstruction during the evening rush-hour. Further objections were received from workers and residents, but the application was granted by the Sub-Committee on 3rd September 2013.
- 3.5 The licence was transferred to City Centre Events Ltd on 13 June 2014.
- 3.6 On 20th March 2017 the licence holder applied for another variation to permit off-sales in unsealed containers until 22.00. However, following talks between themselves, Environmental Health and residents the application was withdrawn.

Complaints

3.7 There have been no recent complaints in respect of this site. Whilst the pavement outside the bar can get very busy on certain nights, visits have shown that management keep patrons within a chalk line and regularly clear away glassware. There have been no recorded incidents of the 21.00 curfew having been breached.

4 Representations from Responsible Authorities

4.1 One representation has been received from the Environmental Health Office Pollution Team. It is stated that if granted the variation will undermine the objective of "prevention of public nuisance".

5 Representations From Other Persons

- 5.1 There are two representations from 'other persons'. These have come from residents of the Worshipful Company of Skinners who share the same concerns regarding 'the prevention of public nuisance'.
- 5.2 The representations can be seen in full as Appendix 4(i) to 4(iii).

6 Policy Considerations

6.1 In carrying out its licensing functions, the Licensing Authority must have regard to its Statement of Licensing policy and statutory guidance issued under s 182 of the Licensing Act 2003.

City of London Corporation's Statement of Licensing Policy

6.2 The following sections/paragraphs of the City of London Corporation's Statement of Licensing Policy are particularly applicable to this application.

Paragraphs 79 - 81 address the need of care when controlling noise particularly from those persons leaving a premises.

The boxed comment on page 19 states the need to strike a fair balance between the benefits to a community of a licensed venue, and the risk of disturbance to local residents and workers.

The boxed comment on page 19 also states an overriding policy principle namely, that each application will be decided on its individual merits.

The boxed comment on page 22 considers various factors that should be taken into account when considering whether any licensable activity should be permitted. Paragraphs 115-121 state the Corporation's policy on setting conditions which may be applicable dependant on the step(s) taken by members as stated in paragraph nine of this report.

Statutory Guidance

6.3 The following sections/paragraphs of the statutory guidance issued under s182 of the Licensing Act 2003 are particularly applicable to this application (revised April 2017):

Chapter 2 of the guidance covers the four licensing objectives. In particular, paragraph 2.15 states that it is, '...important that in considering the promotion of [the public nuisance licensing objective, licensing authorities] focus on the effect of the licensable activities at the specific premises on persons living and working (including those carrying on business) in the area around the premises which may be disproportionate and unreasonable.' Also, paragraph 2.16 indicates that the prevention of public nuisance could, in appropriate circumstances include, 'the reduction of the living and working amenity and environment of other persons living and working in the area of the licensed premises'.

Chapter 10 refers to conditions attached to premises licences with paragraph 10.10 stating that, 'Conditions should be determined on a case-by-case basis and standardised conditions which ignore these individual aspects should be avoided.' Also, 'Licensing authorities should therefore ensure that any conditions they impose are only those which are appropriate for the promotion of the licensing objectives.'

7 Map and Plans

- 7.1 A map showing the location of the premises together with nearby licensed premises is attached at Appendix 5. A key of those premises is included which indicates the maximum permitted hours for alcohol sales in respect of each premises along with the latest terminal hour for any other licensed activity if greater.
- 7.2 Plans of the premises are attached as Appendix 6.

8 Summary

8.1 The Licensing Authority has a duty under the Licensing Act 2003 to promote the Licensing Objectives. Each objective has equal importance. In carrying out its licensing functions, the Licensing Authority must also have regard to its Statement of Licensing Policy, any Statutory Guidance under the Licensing Act 2003 and is bound by the Human Rights Act 1998. The Corporation must also fulfil its obligations under section 17 of the Crime and Disorder Act 1998 to do all that it reasonably can to prevent crime and disorder in the City.

9 Options

- 9.1 The Sub-committee must, having regard to the representations, take such of the following steps as it considers appropriate for the promotion of the licensing objectives:
 - i) grant the variation subject to any conditions consistent with the operating schedule modified to such extent as the Subcommittee considers appropriate for the promotion of the licensing objectives and include the mandatory conditions contained in Ss. 19-21 of the Licensing Act 2003;
 - ii) Reject the application.

For the purposes of paragraph 9.1(i) conditions consistent with the operating schedule are modified if any of them are altered or omitted or any new condition is added.

9.2 Where a licensing authority takes one or more of the steps stated in paragraph 9.1 above the applicant, or the holder of the licence and/or a person who made relevant representations in relation to the application, may appeal the decision to the Magistrates' Court. Any appeal must be commenced within 21 days following notification of the decision to the appellant by the licensing authority.

10 Recommendation

10.1 It is therefore RECOMMENDED that your Sub-Committee determine this variation of a premises licence in accordance with paragraph 9 of this report.

Annex 1 - Mandatory conditions

Alcohol

- 1. No supply of alcohol may be made under the Premises Licence
 - (a) At a time when there is no Designated Premises Supervisor in respect of the Premises Licence; or
 - (b) At a time when the Designated Premises Supervisor does not hold a Personal Licence or his Personal Licence is suspended.
- 2. Every supply of alcohol under the Premises Licence must be made, or authorised by a person who holds a Personal Licence.
- 3. (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
 - (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises.
 - a) games or other activities which require or encourage, or are designed to require or encourage, individuals to
 - (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
 - (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
 - b)provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
 - c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
 - d)selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner.
 - e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).
- 4. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
- 5. (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.

- (2) The designated premises supervisor in relation to the premises licences must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
- (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either:-
- (a) a holographic mark or
- (b) an ultraviolet feature.
- 6. The responsible person shall ensure that
 - (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures
 - (i) beer or cider: ½ pint;
 - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
 - (iii) still wine in a glass: 125 ml; and
 - (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
 - (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

Minimum Drinks Pricing

- 1. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
- 2. For the purposes of the condition set out in paragraph 1 -
 - (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979
 - (b) "permitted price" is the price found by applying the formula –

$$P = D + (DxV)$$

Where -

- (i)P is the permitted price
- (ii)D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii)V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
- (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence
 - (i) The holder of the premises licence

- (ii) The designated premises supervisor (if any) in respect of such a licence, or
- (iii) The personal licence holder who makes or authorises a supply of alcohol under such a licence:
- (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.
- 3. Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from the paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- 4. (1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
 - (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

If the Premises Licence allows Exhibition of Films

- 1. Where a premises licence authorises the exhibition of films, the licence must include a condition requiring the admission of children to the exhibition of any film to be restricted in accordance with this section.
- 2. Where the film classification body is specified in the licence, unless subsection (3)(b) applies, admission of children must be restricted in accordance with any recommendation by that body.

3.Where

- (a) The film classification body is not specified in the licence, or
- (b) The relevant licensing authority has notified the holder of the licence that this subsection applies to the film in question,

admission of children must be restricted in accordance with any recommendation made by that licensing authority.

4.In this section "children" means any person aged under 18; and

"film classification body" means the person or persons designated as the authority under Section 4 of the Video Recordings Act 1984(c39) (authority to determine suitability of video works for classification).



I act for the applicants, City Centre Events Limited, in relation the variation for the Pelt Trader. We are responding to your comments and concerns raised in your representations. In doing so, we hope to give you a better understanding of why this application is being made and how the operators will look to work with you to address your concerns.

Reason for the application

Since opening, the management of the premises have been managing the external area to ensure that as far as possible customers do not cause a nuisance to pedestrians or persons living in the vicinity. Customers tend to be workers or visitors to the City and are mostly professionals and are well-behaved. There is no crime and disorder associated with the premises and since opening there has been no issue of trouble at the premises.

Customers often come in small groups after work to relax for a short time prior to going home. Given the later working hours and international nature of businesses in the vicinity, there is a regular turnover of customers over the course of an evening, with customers arriving, as well as leaving after 9pm (as with other leisure businesses in the area). Customers tend to react positively to the reasonable requests of staff and management, inside and outside the premises, when needed.

However, it has been a bone of contention for some customers that the external area closes at 9pm. Some customers just arriving after a hard day at work want to stand outside, having been inside and seated all day. They often point to the fact that other premises do not have a curfew of 9pm and have been known to leave to go to other nearby premises. In the summer, some customers will not come at all if they know they will be ushered inside at 9pm. This is both a point of frustration for staff and customers alike.



The application has therefore been made to seek a modest increase to rectify these issues.

Representations

The owners and management team at the premises take your concerns seriously and want to work with you in relation to ensuring that the premises manages customers of the premises properly. We have attached for your information the updated management plan relating to use of the external area and noise management in general. We hope that this give you some comfort that your concerns are taken seriously.

Amendment to the application

Following consideration of your representation, the applicants are offering to close the external area to customers at 10pm, rather than 10:30pm as set out in the application. They feel that this is a fair compromise, balancing the needs of all parties.

Proposed additional conditions

In addition, the applicants propose that the following conditions are added to the premises licence application:

- The external area shall be managed as far as practicable to ensure that customers do not behave in a manner that is likely to cause a public nuisance. For the avoidance of doubt, this condition does not seek to prevent customers from engaging socially as would be expected a social situation, but requires a degree of management of customers should their behaviour become overly loud or deemed to be offensive.
- An 'Outside area management plan and general noise management plan' shall be drawn up and implemented at the premises ('the plan') to ensure that as far as practicable the external area is properly supervised. The plan is to be made available at the premises for inspection by an authorised officer of the Council or Police on request.
- A prominent sign will be displayed in the door leading to the external area reminding customers to respect the fact that there are residents living nearby.
- A complaints log will be maintained by the DPS ('the log'). The log will be used to record any complaints made by residents or other people working in the area in relation to the operation of the premises. The log will record the date, time and nature of the complaint, along with the name of the person making the record and any action taken in relation to that complaint.

We hope that these proposed conditions go some way to addressing your concerns.

The manager, Lauren, would be delighted to meet you and give you any further detail you require in relation to this application. As such, she will be at the Pelt Trader on Monday 11 March between 6 and 7pm and available to speak to you. Simply ask for her at the bar.

Invitation to withdraw your representation

We hope that this letter has gone some way to mitigating your concerns and offering a greater insight into what is being sought. Front outside area management plan and general noise plan

Measures taken for supervision and management of guests outside the front of the premises

When the outside area is likely to be busy, in particular early Thursday and Friday evenings during hot sunny weather, the Duty Manager will appoint a single person to supervise the areas ('the supervisor) from 5pm onwards. The supervisor will be instructed that their sole duty will be the supervision of the outside areas until it closes or unless for any other reason it is empty (such as bad weather forcing all or most guests inside).

The supervisor will be also be responsible for keeping the outside areas tidy of glass, crockery etc.

The supervisor may be given additional roles and responsibilities that are located outside as required.

Guests will be supervised to ensure that they do not block the pavement or encroach on the road. Anyone found there is to be asked firmly and politely to move back into the designated area.

Guests acting unreasonably, such as shouting, singing or swearing excessively, or not moving on request will be reminded that as a courtesy to neighbours and other guests that noise must be kept to a reasonable level.

If the guests persist, the Duty Manager should be informed

If required, The Duty Manager should again ask the guests to reduce the noise to a reasonable level or they will be asked to leave the outside area.

If they continue to make noise, they will be required to leave the outside area.

No glasses will be permitted to be taken outside from 22:00 hours. Thereafter, only smokers will be permitted outside.

Signage and other information to be used to remind guests using the outside areas do so in a way which will not cause a public nuisance to nearby residents.

A sign will be displayed in a prominent position at the exit to make our guests aware of the consequences of late night noise and to be respectful to the neighbours. Signs will also state the closing times of the external area.

Dealing with complaints from residents

In the event of any complaint being received this will be dealt with immediately by a member of the management team and the details recorded in writing. A complaints record book will be collated and a record will be kept at all times. This will be regularly reviewed by the management team to identify any reoccurring incidents. All management team will be effectively trained on how to deal with complaints and accurate record keeping.

All staff members required to undertake duties in relation to this management plan will be asked to read a copy of this plan and a copy will be available to staff during their shifts if needed.

Other Noise management measures

Deliveries

Suppliers will be instructed to deliver only between the hours of 10am and 5pm daily. On occasion where this is not possible due to scheduling issues, no deliveries will be accepted before 8am. This will be made clear to suppliers.

Rubbish collection

Bin collection is from the service yard underneath Cannon Street station in Cannon place. Businesses within Cannon Street station and the offices above also use the bins. Collection is organised by the station, not the Pelt Trader. However, no glass bottles will be emptied into bins outside the frontage of the premises, nor when the doors to the front of the premises are open.

Dear licensing team,

I would like to raise a strong objection to the proposed extension of one and half hours to the conditions of the licence enabling patrons of the Pelt Trader to consume drinks outside the premises until 10:30pm.

As a resident of the Dowgate ward for the past 11 years and who's main residence overlooks said business, one has had to tolerate the additional noise generated by the patrons standing outside the venue Mon-Fri evenings - especially in the summer months. (loud talking/shouting, singing, dropped glass wear – could the use of plastic receptacles for outside drinking be enforced - like Westminster council applies?)

We have seen the overspill of customers on Thurs/Fri evenings spread up Dowgate Hill and onto the road which has completely changed the quiet fabric of the Dowgate Ward.

As a former publican for over ten years I am acutely aware of the responsibilities of the licensee and the awareness they need to have for their neighbours. I am also conscious that it is almost impossible to control the volume of people after a few drinks on a lovely sunny evening, however this is my home and the noise generated by those members of the public drinking outside is a daily problem especially at the end of the week in warmer months, the noise in such an enclosed street reverberates between the buildings even with the windows closed it continues to be audible.

Therefore, I do strongly object to having this extended by 1.5 hrs. and hope the licensing team empathise with the points raised above in favour of the local business and residents.

I am writing to register my formal objection to the request by The Pelt Trader at Arch 3, Dowgate Hill for an extension to their hours of operation. My bedroom is directly above the street in which their noisy, smoking and inconsiderate customers shout and drink. Their use of the street as a bar is already unacceptable, not least for the negative image it paints of City life.

My routine often requires early morning work and I sleep from 9pm at night. This just about works with the current licence but would be an unholy intrusion with an extension to the licence. The noise from the bar is far too loud to permit sleep and in the early morning refuse collection, including the shattering sound of glass waste being emptied into recycling trucks, mean that sleep after 0530am is impossible.

This means that the Pelt Trader aiready condemns me to routine demanding sleep from 9 30pm to awake at 05-0530am. Any further extension to their operating house cuts into an aiready short eight hour night. No one should be forced into a six or seven hour sleep pattern by a bar.




