Aims of your organisation:

icandance believes that all children should have the opportunity to express themselves through dance and performance. Our approach is aimed at developing a creative experience for each dancer, a social connection to ease the burden of isolation and an opportunity to express themselves through their body.

Our aim is to offer children and young people with physical and learning disabilities a dance programme that enhances their skills, enables their social development and encourages their self-expression.

This is achieved by:

- Offering weekly dance classes staffed by expert dance therapists, community dance artists, special needs support
 - workers and volunteers, working 1-to-1 or 1-to-2
- Creating a fun, nurturing and safe environment
- Providing financially accessible classes by subsidising the fees
- Providing respite for families
- Offering an opportunity for the dancers to participate in a large-scale, annual production in a theatre
- Sharing the icandance ethos, skills and experience with the broader community through community engagement

projects and working in schools.

Main activities of your organisation:

icandance offers dance and performance opportunities to children and young people aged 4 to 25 years old with a variety of complex disabilities. Staffed by highly-trained and experienced support workers and committed volunteers, we are skilled in working with children with a wide range of needs, including those with complex, multiple and severe disabilities. Classes take place on Saturday mornings, Wednesday evenings and additionally at special educational needs schools. Saturday and Wednesday classes lead to the Annual Show in July. All dancers participate in this performance in a professional theatre, which is a fabulous explosion of lights, music, costume and choreography and a celebration of their creativity and self-expression. The Show is the focus and goal of the year's sessions. We also offer a Winter awards ceremony where we celebrate the achievements of each dancer; Sibling Days, Family Discos and a Summer Holiday week-long project. We currently work with approximately 140 children weekly across our activities.

Summary of grant request

Icandance believes that dance and performance offer children and young people with disabilities social connection to ease the burden of Isolation, creative expression to allow each child's inner voice to be heard and confidence to be seen and celebrated. These are the aims of our organisation and the basis of all that we deliver. We offer weekly dance sessions for children and young people with disabilities aged 4 to 25 years. Led by highly-trained and experienced support workers and volunteers, we are skilled in working with children with complex, multiple and severe disabilities. Classes take place on Saturday mornings across two sites, on Wednesday evenings and during the school day at SEN schools in Camden, Barnet and Lambeth. Each year we hold an Annual Performance in a theatre, which is a wonderful celebration of the year's work, where each child can perform wearing costumes and experience the excitement of a professional production. We also offer a Winter Awards Ceremony, where we celebrate the achievements of each dancer; Sibling Days; Family Discos and a Summer holiday project.

The need for icandance was identified by the Principal, Juliet Diener, in her work both as a Special Educational Needs specialist and as a Dance Movement Psychotherapist. Working mostly 1 to 1 in various specialist settings Juliet identified the need for children with disabilities to gain all the necessary inputs and skills offered through intensive 1 to 1 treatment but in a group, social experience with peers and a nurturing team.

On a weekly basis each child works with their support worker to develop their creative expression, movement skills, self-confidence, friendships and ultimately some moments of independence. Our approach is that the icandance team create a framework for each dancer to imaginatively explore and offer opportunities to make choices and develop creatively within the session. The children make active choices concerning music, props, costumes, dance steps and formats of sessions supported by the boundaries, quidance and positive modelling of the staff. Many of our dancers are non-verbal and so alternative methods of communication such as PECS, Makaton, ipads etc. are used to encourage communication with each child. Dance allows each dancer to share thoughts and feelings without words as they creatively engage in the class through movement. These movements are supported and encouraged by the team and used within the performance choreography so that the Annual Performance is a culmination of each child's contribution. Our method draws on skills from Dance Movement Psychotherapy, Special Educational Techniques and dance. Our approach is unique and specifically targeted to meet the needs of the individual whilst offering a group experience. This is a unique service. We value not only diversity of skills but of backgrounds, learning and of experience. We value greatly our volunteers, especially our young volunteers many of whom are siblings of our dancers. We have a dedicated Volunteer Mentor who manages the training and development of each volunteer.

Every dancer at icandance is unable to attend mainstream dance sessions and would otherwise be excluded from experiencing the joy of dancing.

We are aware of our carbon footprint and where possible work from laptops as well as meeting via conference calls to reduce travel. Most of our team members use public transport.

The work of Icandance could not be delivered without the skills and high ratio of specialist support staff catering for the specific needs of each dancer supporting at a high level of engagement. Our request is for funding to support six workers and the vital work they deliver in making dance possible for many children and young people with complex physical and learning needs.

To support each child in accessing the Annual Performance. This provides an opportunity for every dancer to rise to the challenges of rehearsal and performance, to the thrill of public performance and to receive the applicate and celebration they deserve.

To offer an opportunity for creative self-expression. Despite the physical and learning difficulties challenging our dancers' ability to express their thoughts, feelings and responses, at icandance they are encouraged to use movement in whatever way they can, and wish to, to overcome this. It is a profound and joyful achievement!

To support the development of social skills in the inclusive dance space. Participating in icandance gives our dancers the opportunity to make friends, to learn to be respectful of others' needs, and of their physical space, and to have positive role models in their Support Workers.

To gain new dance and movement skills. icandance is about what the dancer CAN do. This can be taking a step, clapping hands, moving the head in time to the music or learning a 3 minute hip-hop routine, we celebrate each dancer individually for what they achieve.

To offer respite for parents on a weekly basis. Our family community is precious to lcandance. Being able to leave their child not simply in safe hands, but also in a fun, caring and healthy environment is very important to parents and gives them some rare time for themselves

The Annual Performance is a celebration for each dancer as they participate in a creative, professional theatre production. The specialised workers support each dancer in accessing the performance and catering for their individual learning, physical and emotional needs so that each dancer can be applicated by their friends and family.

icandance believes that dance offers every child a voice as they share, connect and express through movement what they are thinking and feeling, whether they are verbal or non-verbal. Opportunities to be creative using various moves, shapes and props offer positive empowerment for each child.

icandance sessions allow each child to have fun, increase physical strength and health alongside peers in a safe, nurturing environment. The fun, interactive sessions encourage friendships and social skills to develop naturally in a non-threatening environment where communication is creative and supported by experienced staff.

Gaining new skills and exploring new ways to engage with their body is also part of what each icandance session offer. Each worker caters the class for each dancer so they can extend themselves at their level, developing their dance skills and feeling a sense of pride in their achievements.

Respite is crucial for families managing the care of their disabled child/sibling. icandance offers a safe, supportive community for families as well as respite for parents on the weekends. This allows opportunities for siblings to also experience an ease in the burden of care.

Do you plan to continue the activity beyond the period for which you are requesting funding? If so, how do you intend to sustain it? If not, what is your exit strategy?

icandance requires the skills and experience of each specialist support worker. These roles are core to icandance's delivery and sustainability. The salaries will be funded through other funding streams including Parents Fees, multi-year grants and regular donations from major donors. We are committed to achieving the amount needed to maintain the positions and to offer highly-subsidised fees for families.
