A staff member who is conversant with the operation of the CCTV system shall be present on the premises at all times when they are open to the public. This staff member shall be able to show the police or the Licensing Authority recordings of the preceding two days immediately when requested.

#### **Simmons**

- 1. The premises shall install and maintain a comprehensive digital colour CCTV system. All public areas of the licensed premises, including all public entry and exit points, will be covered enabling facial identification of every person entering in any light condition. The CCTV cameras shall continually record whilst the premises are open to the public and recordings shall be kept available for a minimum of 31 days with date and time stamping. A staff member who is conversant with the operation of the CCTV system shall be present on the premises at all times when they are open to the public. - 5. There will be no amplified live music or speech at any time.
- 6. On any occasion that regulated entertainment is provided, not less than 1 SIA registered door supervisor shall be engaged to control entry, save that no SIA security shall be required at the weekend unless the venue is open past midnight.

#### **Donnelley Finance**

# **ETC**
