1. What is the Proposal?

To temporarily amend the Housing Allocations Scheme through the means of a Local Lettings Plans (LLP) which will for the period of the policy enhance the "studio upgrade" scheme whereby some City of London tenants of studio properties can apply to transfer to a one-bedroom home. The objective is to create additional voids within the studio property stock to support the Corporation's need to decant people who had been sleeping rough who have been housed as a response to Covid-19 in emergency temporary accommodation.

To approve the implementation of a LLP

The effect of the LLP will impact on people who have been rough sleeping, households on the Corporation's Housing Waiting List and tenants of the City of London seeking a transfer.

The demographics of those who sleep rough differs form the City's population. Nine per cent of those who slept rough in the Square Mile across 2018/19 were aged 55 years or older.

22 per cent of applicants for a studio flat on the Housing Waiting list are aged 55 years or older

The housing allocations scheme already gives tenants of studio properties who are aged 45 or over the ability to apply for an upgrade to a one-bedroom home. This policy would positively impact that group.

The increased advantage of this group may reduce opportunity for those underoccupiers seeking to down size to a one bedroom home. This group is more likely to What actions can be taken to avoid or mitigate any negative impact or to better advance equality and foster good relations?

The policy will be designed so that it does not dominate our allocations. In doing so it will continue to provide for urgent moves and for other needs groups. The policy will also be time limited so that any impacts will not be enduring. The increased priority given to studio upgrade will be less than that of under-occupying households.
