## Conditions consistent with the Operating Schedule

- 1. A CCTV system will be installed. All public areas of the licensed premises, including the main entrance lobby area, will be covered enabling facial identification of every person entering in any light condition. The CCTV cameras shall continually record whilst the premises are open to the public and recordings shall be kept available for a minimum of 31 days with date and time stamping. A staff member who is conversant with the operation of the CCTV system shall be present on the premises at all times when they are open to the public. This staff member shall be able to show the police or the Licensing Authority recordings of the preceding two days immediately when requested.
- 2. Prominent signage shall be displayed at all exits from the premises requesting that customers leave quietly.
