Withdrawn Applications:

Organisation

Advocacy for Older People in Greenwich

Purpose of Request

“To fund an Advocacy Project to provide information/advocacy for people over 75 on finance, housing and benefits issues and to support older people with dementia.”

Organisation has withdrawn the application with a view to submit a revised proposal later in the year.

Al-Hasaniya Moroccan Womens' Project

“To support, supervise and increase the capacity of the present work carried by the Centre with young people emanating from violent and abusive background.”

The applicant has withdrawn the application in order to re-submit a more focused bid in due course

Camden Community Law Centre “To employ a generalist Triage advisor provide a triage general advice service in housing, debt, employment and welfare benefits. - This was replica application to that, elsewhere, for Hackney Community Law Centre.”

The applicant has accepted guidance from your officer concerning weakness with proposal and has withdrawn this request.

Contact a Family “To provide financial advice and support to Londoners caring for a disabled child to improve their financial situation.”

Application has been withdrawn pending the organisation obtaining/ applying for the relevant advice accreditation, which is a requirement of your funding for this area of work.

Faith Matters “Muslim women and young people have reduced feelings of isolation and increased understanding of anti-Muslim hate crime and how to counter it.”

The applicant has withdrawn this application in order to submit a more focused bid.

Hackney Community Law Centre “To support and improve the lives of Hackney vulnerable residents through the provision of free legal social welfare advice and improve awareness of their rights.”

This was a replica application to that, elsewhere, for Camden Community Law Centre. The applicant concerning weaknesses with the proposal and has withdrawn this request.

Music For Youth “Application for an Arts Apprentice”

Application withdrawn as the grant, if awarded, would have been retrospective.

Rain Trust Following discussion by the organisation’s trustee committee, the application was withdrawn.

Volunteer Link Scheme	<p data-bbox="699 1019 1433 1131">Organisation has withdrawn the application on recognising that current uncertainty over its longer term sustainability would jeopardise its success.</p>
Tender Education and Arts	<p data-bbox="699 1198 1433 1344">“We want to equip targeted groups of vulnerable young people with the practical tools and resilience to avoid abuse or escape from violence in relationships.”</p> <p data-bbox="699 1388 1433 1489">Due to changes in the Charity's programme plan, the applicant wishes to withdraw its application in order to submit a new application in the future.</p>
Toucan Employment	<p data-bbox="699 1568 1433 1747">“Salary of Workstart Worker, supporting young NEET Southwark and Lambeth residents with learning difficulties/disabilities, 16-25 in Transition to access work experience placements and employment.”</p> <p data-bbox="699 1780 1433 1960">Having submitted a final monitoring report for previous grant in July 2013, the charity is not yet eligible for further funding. The organisation has therefore withdrawn it and is likely to reapply in 2016.</p>

Tower Hamlets Friends & Neighbours

“To support socially isolated housebound Older Londoners suffering depression and help them become more active and improve their health and wellbeing.”

Organisation has taken the advice of your officer that the internal finances of the organisation would not meet your requirements and has, therefore, withdrawn this request.
