> I am writing to give notice of my opposition to this application.  
>  
> I suspect, like me, many people didn't realise that planning permission for retail use included the right to build an extremely large restaurant and bar. The restaurant to be built in what was the old QE 11 building was specified as such. It is therefore reasonable that people would have expected this building also to have been specified as a restaurant and bar.  
>  
> To have such late hours of licensing to such a large restaurant and bar (some 6,300 square feet) along with another large restaurant (see previous paragraph) sandwiched between a predominantly residential neighbourhood and a large hospital is not appropriate.  
>  
> It will create a considerable public nuisance in terms of noise, especially to residents at Spencer Heights, to many of the new residents in the Barts Square Development and patients at Barts Hospital.  
>  
> As well as the hours being unacceptable, it is also important to impose conditions which mean that no tables be allowed on the pavements, doors and windows are kept closed and that there is no noise from air conditioning.
