1. The premises shall install and maintain a CCTV system with all entry and exit points covered. The CCTV cameras shall continually record whilst the premises are open to the public. A staff member who is conversant with the operation of the CCTV system shall be present on the premises at all times when they are open to the public. This staff member shall be able to show the police or the licensing authority recent data or footage with the absolute minimum of delay when requested.
2. After 19.00 hours any off sales of alcohol shall be in closed containers.
3. Doors to the restaurant shall be kept closed after 20.00 hours except for access and egress.

Annex 2 - Conditions consistent with the Operating Schedule

1. Substantial food and non intoxicating beverages, including drinking water, shall be available in all parts of the premises.
2. An incident log shall be kept at the premises, and made available on request to an authorised officer of the City of London Corporation or the Police, which will record the following:
 - (a) all crimes reported to the venue
 - (b) all ejections of patrons
 - (c) any complaints received
 - (d) any incidents of disorder
 - (e) seizures of drugs or offensive weapons
 - (f) any faults in the CCTV system or searching equipment or scanning equipment
 - (g) any refusal of the sale of alcohol
 - (h) any visit by a relevant authority or emergency service.
3. Alcohol supplied for consumption off the premises shall only be supplied in sealed containers.
4. Recorded or Live Music shall be only be played inside Unit SU62.
5. Except for entry and egress all doors and windows shall be kept closed at any time regulated entertainment is taking place.
6. Notices shall be prominently displayed at all exits requesting patrons to respect the needs of local residents and leave the area quietly.
7. There are no DJ's or juke boxes permitted at the premises.
8. The premises will not be used for promotional events, which is defined as 'an event involving music and/or dancing where the musical entertainment is provided at any time between 11.00pm (23.00 hours) and 7.00am (07.00) hours by a disc jockey (DJ) or disc jockeys (DJ's), one or some of whom are not employees of the licensee (premises licence holder) and the event is promoted to the general public.
9. A written refusals record shall be kept detailing all refused sales of alcohol. The record shall include the date and time of the refused sale and the name of the employee who refused the sale. The log shall be available for inspection at the premises by the police or an authorised officer of the corporation at all times the premises are open.
