All entry and exit points will be covered enabling frontal identification of every person entering in any light condition. The CCTV system shall continually record whilst the premises is open for licensable activities and during all times when customers remain on the premises. All recordings shall be stored for a minimum period of 31 days with date and time stamping. Recordings shall be made available immediately upon the request of Police or authorised officer throughout the preceding 31 day period.
- 2. A staff member from the premises who is conversant with the operation of the CCTV system shall be present on the premises at all times when they are open to the public. This staff member shall be able to show the police or the licensing authority recent data or footage with the absolute minimum of delay when requested.
- 3. Substantial food and non intoxicating beverages, including drinking water, shall be available in all parts of the premises where alcohol is sold or supplied consumption on the premises.
- 4. An incident log shall be kept at the premises, and made available on request to an authorised officer of the City of London Corporation or the Police, which will record the following:
- (a) all crimes reported to the venue
- (b) all ejections of patrons
- (c) any complaints received
- (d) any incidents of disorder
- (e) seizures of drugs or offensive weapons
- (f) any faults in the CCTV system or searching equipment or scanning equipment
- (g) any refusal of the sale of alcohol
- (h) any visit by a relevant authority or emergency service.
- 5. There shall be a personal licence holder on duty on the premises at all times when the premises are authorised to sell alcohol.

- 1. A noise limiting device shall be installed, fitted and maintained at the premises in such a manner as to control the volume of all amplified music or speech at the premises. The noise limiter shall be calibrated and secured to the satisfaction of the City of London's Environmental Health Service.
- 2. No promoted events will be held at the premises. A promoted event is defined as follows:
 - " A promoted event is an event involving music and/or dancing where the musical entertainment is provided at any time between 11.00 pm and 7.00 am by a disc jockey or disc jockeys one or some of whom are not employees of the licensee (premises licence holder) and the event is promoted to the general public"
- 3. The premises shall install and maintain a comprehensive CCTV system as per the minimum requirements of the City of London Police Crime Reduction Officer. All entry and exit points will be covered enabling frontal identification of every person entering in any light condition. The CCTV system shall continually record whilst the premises is open for licensable activities and during all times when customers remain on the premises. All recordings shall be stored for a minimum period of 31 days with date and time stamping. Recordings shall be made available immediately upon the request of Police or authorised officer throughout the preceding 31 day period. This to cover all public areas authorised for licensable activities.
- 4. A staff member who is conversant with the operation of the CCTV system shall be present on the premises at all times. This staff member shall be able to show the Police or the Licensing Authority recent data or footage with the absolute minimum of delay when requested. Copied images from the system must be of a quality acceptable to Police.
- 5. A register shall be maintained on the premises in which the full name, SIA licence number and signature of all door supervisors shall be recorded. Each entry in the register must be verified by the signature of the Designated Premises Supervisor (DPS) or in their absence by such other person authorised in writing by the DPS to do so. The register shall be readily available for inspection by the Police and the Licensing Authority.
- 6. An incident log shall be kept at the premises, and made available on request to an authorised officer of the City of London Corporation or the Police, which will record the following:
 - (a) all crimes reported to the venue
 - (b) all ejections of patrons
 - (c) any complaints received
 - (d) any incidents of disorder
 - (e) seizures of drugs or offensive weapons
 - (f) any faults in the CCTV system or searching equipment or scanning equipment
 - (g) any refusal of the sale of alcohol
 - (h) any visit by a relevant authority or emergency service.

- 7. Alcoholic and non-alcoholic drinks may not be removed from the premises in open containers save for consumption in the hotel bedrooms.
- 8. Children under the age of 16 shall not be permitted to enter the premises after 21:00 unless dining with an adult or attending a pre booked function or resident in the hotel.

- 2. There shall be no sale of alcohol for consumption off the premises.
- 3. In the event of any incidents of disorder, patrons ejected, crimes, or any visit by the emergency services a log shall be kept and made available to the City of London Police.
- 4. There shall be a personal licence holder on duty on the premises at all times when the premises are authorised to sell alcohol.
- 5. No super-strength beer, lagers or ciders of 5.5% ABV or above will be sold at the premises.
- 6. In the event of any refusal of a sale of alcohol a log shall be kept including the date and time of refusal and the staff member who refused the sale. The log shall be made available to the City of London police or an authorised officer of the City of London Corporation.
- 7. Doors and windows of the premises shall be kept closed from 9.00 p.m. each day until the end of permitted hours for licensable activities that day, except for the purposes of egress and access.
- 8. Notices will be prominently displayed at the exits of the premises requesting customers to respect the needs of local residents and to leave the premises and area quietly.
