Annex 3 - Conditions attached after a hearing by the licensing authority

The following conditions/resolutions were agreed by the City of London Licensing Sub-Committee at a hearing held on 5th April 2011

- 1. No promoted events are to be held on the premises, such events being defined as those involving music and/or dancing and where the musical entertainment is provided at any time between 23.00 and 07.00 by a disc jockey or disc jockeys, one or some of whom are not employees of the premises licence holder (or, where different, the permanent premises operator) and the event is promoted to the general public.
- 2. The premises licence holder shall install and maintain a comprehensive digital colour CCTV system as per the minimum requirements of the City Police Crime Prevention Officer. All entry and exit points shall be covered enabling frontal identification of every person entering in any light conditions. The CCTV system shall continue to record whilst the premises are open for licensable activities and at all times when customers remain on the premises. All recordings shall be stored for a minimum period of 31 days with date and time stamping. Recordings shall be made available immediately upon request to a constable or authorised officer of the Common Council at any time during the said 31 day period and to this end a staff member who is conversant with the operation of the CCTV system shall be on the premises at all times when the premises are open to the public in order to show any constable or authorised officer such recordings with the minimum delay
- 3. Save for alcohol supplied to *bona fide* guests by way of minibars in their rooms or by way of room service from a hotel staff member directly to a *bona fide* guest in his or her room, there is to be no supply of alcohol to any person under this licence between 02.00 and 08.00 on any day
- 4. Save for alcohol intended to be consumed in the Courtyard or by *bona fide* hotel guests in their rooms, no supply of alcohol for consumption off the premises shall be permitted after 21.00
- 5. Recorded music, live music, and facilities for making music and dancing are to be provided in the Function Room in the East basement only
- 6. Clearly legible notices shall be displayed at all exits from the premises requesting patrons to respect the needs of local residents and to leave the premises and surrounding area quietly
- 7. A direct telephone number for the duty management of the premises shall be publicly available at all times the premises are open
- 8. No use shall be made of the 'beer-drop' in Silk Street before 08.00 Mondays to Fridays or before 09.00 on Saturdays, Sundays and Bank Holidays
- 9. No new customers (save *bona fide* guests staying overnight in the hotel) shall be admitted to the Hotel Bar (being that part of the premises on the ground floor at the iunction of Silk Street and Chiswell Street) after 24.00 on any night

- 1. There shall be no sale or supply of alcohol for consumption off the premises, except within the terrace area adjoining the property.
- 2. CCTV shall be installed, maintained and operated in full working order.
- 3. Notices shall be displayed requesting guests to be respectful of local residents as they leave the premises.
- 4. No children shall be allowed on the premises without complete adult supervision.
- 5. When music is being played after 22:00 hours the front doors leading onto the garden terrace shall be closed.
- 6. A Noise limiting device shall be installed, fitted and maintained at the premises in such a manner as to control the volume of all amplified music or speech at the premises. The noise limiter shall be calibrated and secured to the satisfaction of the City of London's Environmental Health Service.
- 7. A comprehensive colour CCTV system shall be maintained in working order at the premises to monitor all public areas of the licensed premises, including all entry and exit points. This must enable facial identification of every person entering in any light condition. All cameras shall continually record whilst the premises are open to the public and recordings shall be kept available for a minimum of 31 days with time and date stamping. All recordings shall be made available to the Police and the Licensing Authority together with facilities for viewing.
- 8. A staff member who is conversant with the operation of the CCTV system shall be present on the premises at all times when they are open to the public. This staff member shall be able to show the Police or Licensing Authority recent data or footage with the absolute minimum of delay when requested.

- 1) On no more than 15 occasions per calendar year, the terminal hour on Sunday shall be 3.00am for the purposes of private pre-paid functions to which the public shall not be admitted following a minimum of 10 days notice of such function to the Police and Licensing Authority and subject to their consent.
- 2) Permission is given for the premises to open for all licensable activities from the commencement of trading on New Years Eve to the end of trading on New Years Day.
- 3) The following activities are permitted under the terms of this licence:
 - a) Consumption of alcohol on the premises or the taking or supply of alcohol to any person residing in the licensed premises
 - b) The ordering of alcohol to be consumed off the premises, or the despatch by the vendor of the alcohol so ordered.
 - c) The supply of alcohol for consumption on the premises to any private friends of a person residing there who are bona fide entertained by him at his own expense, or the consumption of alcohol by persons so supplied.
