Dear Fellow Clerk,

I write to inform you about the work of the relatively newly established Sub-Committee of the Court of Aldermen, namely the Magistracy and Livery Sub-Committee (General Purposes Committee of Aldermen). You will recall in the past a Livery Company has contacted me as Clerk of the Chamberlain's Court regarding such issues as applying for a Royal Charter or a supplemental Charter; amending Company Ordinances, By-Laws; having an independent examination of accounts as opposed to a full audit or increases to the size of a permitted Livery. I acted as a form of conduit between the Livery and the Court of Aldermen. I would liaise with the Chairman of the General Purposes Committee of Aldermen who until he retired as an Alderman was Sir David Howard Bt.

When Sir David retired it was decided that a new Sub Committee should be established to deal with such issues. The Chairman of the Magistracy and Livery Sub-Committee is Alderman Alison Gowman and the membership of the Sub-Committee consists of the following Aldermen: Charles Bowman, David Graves, Timothy Hailes, Peter Hewitt, Ian Luder and Sir David Wootton. It is also attended by Paul Double, the City Remembrancer, me and the Clerk is Edward Gilbert.

The process has not changed greatly; I remain the first point of contact regarding such queries and discuss them with Alderman Alison Gowman and report back to the Sub-Committee. If the issue is a major one such as applying for a Royal Charter then a petition to the Court of Aldermen is required but if it is a minor change then I on behalf of the Chamberlain in conjunction with the Chairman of the Magistracy and Livery Sub-Committee can authorise it under delegated authority or (if necessary) the Chairman may refer it to the Sub-Committee . An annual report will be produced for the Sub-Committee detailing approvals granted without its intervention. I can advise as to whether changes are likely to be treated as minor or major. It is worth noting here that all such changes in ordinances and charters do need approval from the Court of Aldermen which takes its oversight role very seriously.

I also write to inform you that the Chamberlain's Court is now carrying out a vetting process to all candidates who apply for the freedom without the intervention of a Livery Company. This is to ensure that there is no reputational damage to the City of London should an undesirable candidate be awarded the Freedom. This has not been extended to applicants who are put forward by Livery

Companies because the City relies on the individual Companies to carry out their own vetting procedures. I am aware that many Companies already have a robust vetting procedure either by interview, a membership sub-committee or by recommendation of existing Liverymen so this is a gentle reminder to ensure that such standards are maintained.

Summary

At the meeting of the Freedom Applications Committee on 9th June 2017, the Committee considered a report regarding how to increase diversity and inclusion in respect to the Freedom of the City. The Committee endorsed the suggestion that City of London Academies and family schools, as well as cadets organisations, should be written to by the Clerk to the Chamberlain's Court to encourage them to apply for the Freedom of the City.

To this end, a letter has been drafted (Appendix A) which the Committee is asked to review and agree. Members are asked to note that the appended letter (which is written as if addressed to an academy) will be used as a template, and therefore will be tailored to the intended recipient as relevant.

Recommendation

• It is recommended that the Committee comments on the draft letter and agree for the content of the letter (with any necessary amendments made) to be circulated to City academies and family schools, and cadets organisations.

APPENDIX A

As a way of strengthening the ties between the Academy and the City of London, Sir David Wootton, on behalf of the Freedom Application Committee, would like to extend the Freedom of the City to 4 of your senior students.

The Freedom is an ancient custom dating back to the thirteenth century which the City of London is very proud of and we are keen to maintain it as a living tradition. Despite it being largely symbolic today it still represents a unique slice of London history. It is a vibrant institution which may be an Honorary Freeman like Professor Stephen Hawking or a member of one of the 110 Livery Companies of the City of London or someone who lives or works in the City.

The Freedom for your students would be a special affair as they are to be *invited* to receive the Freedom rather than applying for it. The Chamberlain of London would conduct the ceremony in person and the pupils selected can invite family of friends to attend. Sadly it is no longer a privilege to take sheep over London Bridge but the experience will be a memorable one and away of marking their achievements at the Academy. At a later date we plan to hold a reception for all the recipients from our various Schools and Academies.

As to how you select the candidates this is up to you. It might be that the Head Boy or Head Girl be put forward; it may be the pupils who achieved the highest grades in their A-levels; or a pupil who has contributed to the life in another way through sporting endeavour or charitable work or you might hold an essay writing competition with the Freedom being the prize for the pupil who writes the best essay. The choice is yours.

The only proviso is that the candidates must be 18 and above and of good character.
