In this condition, permitted hours means: a. On weekdays, other than Christmas Day, Good Friday, 10 a.m. to 11 p.m. b. On Sundays, other than Christmas Day, 12 noon to 10.30 p.m. c. On Good Friday, 12 noon to 10.30 p.m. d. On Christmas Day, 12 noon to 3 p.m. and 7 p.m. to 10.30 p.m. The above restrictions do not prohibit: (a) Consumption of alcohol on the premises or the taking or sale or supply of alcohol to any person residing in the licensed premises; (b) The ordering of alcohol to be consumed off the premises, or the despatch by the vendor of the alcohol so ordered; (c) The supply of alcohol for consumption on the premises to any private friends of a person residing there who are bona fide entertained by him at his own expense, or the consumption of alcohol by persons so supplied. 2) SOURCE: S.168, 171, 201 LA 1964 TYPES OF PREMISES: On-licence, no children's certificate TYPE OF RESTRICTION: Children in bars. WORDING OF CONDITION: No person under fourteen shall be in the bar of the licensed premises during the permitted hours unless one of the following applies: (a) He is the child of the holder of the premises licence. (b) He resides in the premises, but is not employed there. (c) He is in the bar solely for the purpose of passing to or from some part of the premises which is not a bar and to or from which there is no other convenient means of access or egress. (d) The bar is in railway refreshment rooms or other premises constructed, fitted and intended to be used bona fide for any purpose to which the holding of the licence is ancillary. In this condition "bar" includes any place exclusively or mainly used for the consumption of intoxicating liquor. But an area is not a bar when it is usual for it to be, and it is, set apart for the service of table meals and alcohol is only sold or supplied to persons as an ancillary to their table meals. 3) SOURCE: S.166 LA 1964 TYPES OF PREMISES: On-licence. TYPE OF RESTRICTION: Credit Sales. WORDING OF CONDITION: Alcohol shall not be sold or supplied unless it is paid for before or at the time when it is sold or supplied, except alcohol sold or supplied: (a) with and for consumption at a meal supplied at the same time, consumed with the meal and paid for together with the meal. (b) for consumption by a person residing in the premises or his guest and paid for together with his accommodation. (c) to a canteen or a mess. 4) Permission is given for the playing of Recorded Music. 5) The premises may be used for the provision of private entertainment as previously permitted under the Private Places of Entertainment (Licensing) Act 1967. 6) Late Night Refreshment may be provided between the hours of 11.00pm and 5.00am. 7) Substantial food to be available at all times. 8) No use of external seating after 9pm.
