1. THE CHAIR

It was moved by Deputy Everett, duly seconded and

RESOLVED – that Alderman Graves takes 'the chair' until the election of a Chairman for the 2018/19 year.

2. APOLOGIES

The Committee noted the appointment of 2 further Members (Alderman Mainelli and Jeremy Simons) since the publication of the agenda for its meeting. Apologies for absence had been received from Caroline Addy and Alderman Mainelli.

3. MEMBERS' DECLARATIONS UNDER THE CODE OF CONDUCT IN RESPECT OF ITEMS ON THE AGENDA

Judith Barnes, Mark Greenburgh and Dan Large declared non-pecuniary interests in the items relating to Co-opted Members declarations of interest and appointment to the Committee. Deputy Lord declared an disclosable pecuniary interest in the item on dispensation requests insofar as he had submitted a request for determination.

4. ORDER OF THE COURT OF COMMON COUNCIL

The Committee received as information the Order of the Court of Common Council.

RECEIVED.

5. ELECTION OF CHAIRMAN

The Town Clerk having read the names of those Members eligible to stand for election as Chairman for the ensuing year, and Oliver Lodge being the only Member to put himself forward for election, it was

RESOLVED – That Oliver Lodge be appointed as Chairman of the Committee for the ensuing year.

On taking his seat, the Chairman thanked Members for his election and welcomed Caroline Addy, Alderman Mainelli, Oliver Sells and Jeremy Simons to the Committee.

6. ELECTION OF A DEPUTY CHAIRMAN

The Town Clerk having read names of those Members eligible to stand for election as Deputy Chairman, Alderman Graves, Mark Greenburgh, Ann Holmes and Michael Hudson put themselves forward for election.

A ballot was held and there was found to be 3 votes for Mark Greenburgh and Ann Holmes, 2 votes for Michael Hudson and 1 vote for Alderman Graves.

A further ballot was then held under the provisions of the Standing Orders and there was found to be 4 votes for Ann Holmes, 3 votes for Mark Greenburgh and 2 votes for Michael Hudson.

A final vote was then held and there was found to be 4 votes for Mark Greenburgh and 5 votes for Ann Holmes.

RESOLVED – That Ann Holmes be duly elected Deputy Chairman for the ensuing year.

On taking her seat, Ann Holmes thanked Members for her election.

7. MINUTES OF THE PREVIOUS MEETINGS

Members had before them the public minutes of the Standards Committee's meetings on 6 October 2017 and 26 January 2018 (inquorate).

RESOLVED – That the minutes be confirmed and signed as a correct record. **Matters Arising**

Barbican Residential Committee

The Committee noted that, on 14 December 2017, the Policy & Resources Committee had asked for the governance of the City Corporation's residential housing to be examined on a more strategic level with the aim of producing

proposals which consolidate the governance arrangements of the City Corporation's residential housing offer. It was also noted that, at its inquorate January 2018 meeting, the Standards Committee had considered a report of the Comptroller and City Solicitor on potential conflicts of interest on the Barbican Residential Committee and had subsequently submitted views to the Policy and Resources Committee, under the urgency provisions of Standing Order No. 41(a), to ensure that these comments could be considered as part of that Committee's review of the governance of the City Corporation's residential housing.

Members were informed that a further report on the matter had not yet come before the Policy and Resources Committee and Members asked that a resolution be forwarded to that Committee for an update on when this matter would be considered.

8. MINUTES OF ASSESSMENTS SUB (STANDARDS) AND DISPENSATIONS SUB COMMITTEES

Members had before them the public minutes of the Assessment Sub (Standards) Committee and Dispensation Sub (Standards) Committee's recent meetings.

9. OUTSTANDING ACTIONS

The Committee considered the report of the Town Clerk on outstanding actions. The following matters were raised:-

On the Members' Code of Conduct and associated documents visibility on the Corporation's website, Members asked that the appropriate committee be notified that its view was that the Code documents should be easy to find and readily accessible (under 'C' for Code; 'M' for Member, for example). A Member also said that this reminder to the appropriate committee should further request that the details of how the public make a complaint under the Code should also be easy to locate.

(Action: TC)

10. OUTCOME OF STANDARDS FRAMEWORK REVIEW

Members had before them the report of the Town Clerk on the outcome of the Standards framework review. The following matters were raised:-

Noted that the Town Clerk had delegated authority to determine the start
of the new complaints process following training for Standards Appeal
Committee members. The Chairman asked that officers ensure that the
timing of new process commencement avoids any gaps or duplication of
arrangements for appeals to maintain confidence in the system.

(Action: TC / CCS)

- Noted that complaints now in the system would continue to be dealt with under the current arrangements rather than the revised arrangements.
- A Co-opted Member made a point about the informal resolution of disputes (paragraph 14 to 17 of the complaints procedure, pages 50-51 of the agenda pack) and her views (detailed below) that this element of the procedure needs to be clearer:
 - paragraph 15 refers to the Chief Commoner/Aldermanic Chairmen being effective in resolving disputes between members. If it is intended that they can also be asked to informally resolve a complaint by a member of the public, this should be explicit.
 - either the complainant or the subject of the complaint can at any time during or after informal resolution withdraw their consent to informal resolution and ask for the complaint to be referred to the Standards Committee. This is an important safeguard and needs to be made explicit. Currently paragraph 17 only refers to the right of a member (presumably the member complained about, though that is not clear) to refer a matter to the Standards Committee if aggrieved by any proposed course of action.

Another Member put forward the view that paragraph 63 (iv) on page 60 of the agenda pack on sanctions did not make reference to the possible withdrawal of an appointment to an outside body.

On these points, the Chairman said that a review of current wording of the documents should be undertaken at the end of the year, by when there should have been opportunity to identify shortcomings. The Town Clerk to maintain a list of points for consideration as they emerge.

11. REVIEW OF TERMS OF REFERENCE ARISING FROM OUTCOME OF STANDARDS FRAMEWORK REVIEW

The Committee considered the Town Clerk's report on the review of terms of reference. The following matters were raised:-

- On terms of reference of the Standards Committee, the Chairman and other Members suggested amendments be made to the draft wording set out on pages 83 and 84 of the agenda pack as set out below:-
 - Amend (d) and (e) to include reference to committee ownership (Establishment)
 - Amend (g) to read "Monitoring all complaints referred to it and dealing with assessment...."
 - Amend (h) to read "Prepare an annual report on its activity for submission to the Court of Common Council."

• Noted that the Comptroller and City Solicitor would offer appropriate training to Committee Members on revised standards arrangements.

(Action: CCS)

 On terms of reference of the Sub Committees, the Town Clerk confirmed that the listed changes to quorums on pages 85 and 87 reflected decisions taken by the Court on the review at its March meeting. Noted that there would be provision for late substitution of members listed as serving at the meeting on the agenda papers.

RESOLVED – That

(a) the draft terms of reference of the Committee be approved for submission to the Court of Common Council, as set out below:-

Standards Committee – Draft Terms of Reference

To be responsible for:-

- (a) promoting and maintaining high standards of conduct by Members and Co-opted Members of the City of London Corporation and to assist Members and Co-opted Members to observe the City of London Corporation's Code of Conduct;
- (b) preparing, keeping under review and monitoring the City of London Corporation's Member Code of Conduct and making recommendations to the Court of Common Council in respect of the adoption or revision, as appropriate, of such Code of Conduct;
- (c) keeping under review, monitoring and revising as appropriate the City of London Corporation's Guidance to Members on the Code of Conduct and the complaints procedure and relevant paperwork, reporting any changes on these documents to the Court of Common Council in the Committee's annual report.
- (d) keeping under review by way of an annual update by the Director of HR, the City of London Corporation's Employee Code of Conduct and, in relation to any revisions, making recommendations to the Establishment Committee;
- (e) keeping under review and monitoring the Protocol on Member/Officer Relations and, in relation to any revisions, making recommendations to the Establishment Committee;
- advising and training Members and Co-opted Members on matters relating to the City of London Corporation's Code of Conduct;
- (g) monitoring all allegations referred to it and dealing with assessment of and any hearing into any allegations of breach of the City of London Corporation's Code of Conduct in respect of Members and Co-opted

Members, and in particular:

- to determine whether any allegation should be investigated by or on behalf of the Town Clerk or the Monitoring Officer and their findings reported to the Committee;
- (ii) in relation to any allegation that it has decided to investigate, to determine whether there has been a breach of the Code of Conduct, taking into account the views of an Independent Person appointed under the Localism Act 2011;
- (iii) where there has been a breach of the Code of Conduct, to determine the appropriate sanction, and where this involves removal of a Member or Co-opted Member from any committee or sub-committee, to make an appropriate recommendation to the relevant appointing body;
- (iv) to determine any appeal from a Member or Co-opted Member in relation to a finding that they have breached the Code of Conduct and/or in relation to the sanction imposed; and
- (h) monitoring all complaints referred to it and To prepare an annual report on its activity for submission to the Court of Common Council.
- (b) The draft terms of reference of the Sub-Committees be approved, as set out below:-

Standards Committee - Sub-Committees' Draft Terms of Reference

Assessment Sub Committee

- a) The Assessment Sub-Committee is established to receive and assess allegations that a Member or Co-opted Member of the City has failed, or may have failed, to comply with the Code of Conduct.
- b) Upon receipt of each allegation and any accompanying report by the Monitoring Officer, the Sub-Committee will make an initial assessment of the allegation and will then do one of the following:-
 - (i) refer the allegation to the Monitoring Officer, with an instruction that s/he arrange a formal investigation of the allegation; or
 - (ii) direct the Monitoring Officer to arrange training, conciliation or other appropriate alternative steps; or
 - (iii) decide that no action should be taken in respect of the allegation.

- c) The Sub Committee will consist of any three elected Members (voting) and one Co-opted Member (non-voting) to be drawn from the membership of the Standards Committee.
- d) The quorum shall consist of any three elected Members.
- e) The Sub Committee will take into account the views of an Independent Person appointed under the Localism Act 2011.

Hearing Sub Committee

- a) To hear and determine any allegation that a Member has failed, or may have failed, to comply with the Code of Conduct for Members;
- b) Following the hearing, to make one of the following findings:-
 - (i) that the subject Member has not failed to comply with the Code of Conduct;
 - (ii) that the subject Member has failed to comply with the Code of Conduct but that no action needs to be taken in respect of the matters considered at the hearing;
 - (iii) that the subject Member has failed to comply with the Code of Conduct and that a sanction should be imposed.
- c) If the Sub-Committee makes a finding under paragraph b) (iii), it may impose any one of or any combination of sanctions that are available:

If the Hearing Sub-Committee finds that a subject Member has failed to follow the Code of Conduct and that they should be sanctioned, it may impose any one or a combination of the following:-

- censure of that Member;
- withdrawal of City hospitality for an appropriate period;
- removal of that Member from a particular committee or committees.

The option of removal from a particular committee or committees includes sub-committees. The Hearing Sub-Committee will make a recommendation to the relevant appointing body in each case.

The Hearing Sub-Committee has no power to impose any alternative sanctions, although the willingness of a member to co-operate in the

matters listed below may have a bearing on any sanction that is imposed:-

- that the Member submits a written apology in a form specified by the Hearing Sub-Committee;
- that the Member undertakes such training as the Hearing Sub-Committee specifies;
- that the Member participates in such conciliation as the Hearing Sub-Committee specifies.
- d) The Sub Committee will consist of any three elected Members (voting) and one Co-opted Member (non-voting) to be drawn from the membership of the Standards Committee, provided that Members should not be selected to sit on the Hearing Sub Committee if they sat on the Assessment Sub Committee in relation to the same complaint.
- e) The quorum shall consist of any three elected Members.
- f) The Sub Committee will take into account the views of an Independent Person appointed under the Localism Act 2011.

Appeal Sub Committee

Appeal process

If a Member is aggrieved by a decision of the Hearing Sub-Committee to impose one or more sanctions against him/her, either because he/she does not accept that he/she has breached the Code of Conduct, or because he/she considers that the sanction or sanctions imposed are disproportionate, he/she is entitled to appeal to the Appeal Sub-Committee.

Any such request must be sent in writing to the clerk to the Appeal Sub-Committee and received by him/her within 20 working days from the date that the subject Member is informed of the decision of the Hearing Sub-Committee. The Appeal Sub-Committee will normally complete its review of the decision within an average of 30 working days following receipt of the request.

Appeal Sub Committee Terms of reference

b) To determine any appeal from a Member in relation to a finding of the Hearing Sub-Committee that they have breached the Code of Conduct and/or in relation to the sanction imposed.

b) Having due regard to the decision of the Hearing Sub-Committee, to substitute any alternative decision for that decision that the Appeal Sub-Committee considers is appropriate, being a decision that the Hearing Sub-Committee had the power to make.

Dispensations Sub (Standards) Committee

- a) The Dispensations Sub Committee is established to determine written requests for dispensations from Members or Co-opted Members to take part in any discussion and/or vote on a matter in which they have a disclosable pecuniary interest in accordance with section 33 of the Localism Act 2011.
- b) Upon receipt of a written request for a dispensation, a meeting of the Sub Committee will be convened (unless a meeting of the Standards Committee is scheduled to take place within a reasonable timeframe), to consider the details of the request and will then do one of the following:-
 - (i) grant a dispensation (in whole or in part) for a specified period not exceeding four years;
 - (ii) reject the request for a dispensation; or
 - (iii) seek further information regarding the request ahead of further consideration at a newly convened meeting, or in accordance with the City Corporation's urgency provisions (Standing Order No. 41).
- c) The Town Clerk will advise the Member seeking a dispensation of the Sub Committee's decision upon the conclusion of the meeting and will retain a list of action taken in respect of all written requests considered by the Sub Committee.
- d) The Sub Committee will consist of any three elected Members (voting) and one Co-opted Member (non-voting) to be drawn from the membership of the Standards Committee.
- e) The quorum shall consist of any three elected Members.

12. CO-OPTED MEMBERS AND DECLARATIONS OF INTERESTS

The Committee considered the Town Clerk's paper on Co-opted Members and declarations of interest. The following matters were raised:-

 Noted that the annual update is underway and that co-optees' declarations of interest would be published. The Committee expressed frustration at the delays to date in publishing this information and requested that declarations received be published on-line by the end of June.

(Action: TC)

 Noted that all co-optees (except on consultative committees) would also be obliged to use a City email address from 25 May 2018. A Co-opted Member commented that this needed to be made clearer to co-optees.

RECEIVED.

13. APPOINTMENT OF CO-OPTED MEMBERS OF THE COMMITTEE

The Town Clerk reported on the appointment of Co-opted Members to the Committee.

Mark Greenburgh and Dan Large left the room during Members' consideration of the paper insofar as it covered their possible reappointment as Co-opted Members of the Committee. It was also

RESOLVED – That under Section 100A(4) of the Local Government Act 1972, the public be excluded from the meeting for the item of business on the grounds that they involve the likely disclosure of exempt information as defined in Paragraph 3 of Part I of Schedule 12A of the Local Government Act.

After the contents of the report had been discussed, Mark Greenburgh and Dan Large returned to the Committee room.

The meeting returned to public session.

With the agreement of Members, the Chairman drew a name out of the ballot bowl and declared that Dan Large would be recommended to the Court for appointment as a Co-opted Member of the Committee for a 4 year term of office, with Mark Greenburgh to be recommended for a 3 year term of office.

The Committee then considered the matter of the outstanding vacancy for a Co-opted Member and it was agreed that this vacancy be advertised with an initial term of office of 2 years.

RESOLVED - That

- (a) the re-appointments of Dan Large and Mark Greenburgh as Co-opted Members of the Standards Committee, for a 4 year and a 3 year term of office respectively, to commence from the expiry of their current terms in December 2018, be recommended to the Court of Common Council for approval at its July meeting.
- (b) The Town Clerk make the necessary arrangements for advertising the outstanding vacancy for a Co-opted Member with an initial term of office

of 2 years commencing from the date of appointment by the Court of Common Council.

14. DISPENSATIONS GENERAL POLICY

The Committee considered the report of the Comptroller and City Solicitor on the general policy on granting dispensations under the Localism Act 2011.

A Co-opted Member put forward the view that some additional relevant information is required by committee members when assessing dispensation requests, such as committee composition, quorum, number of conflicted members, etc if that information was known. He asked that these details be added to the usual dispensations report 'template' going forward. The Co-opted Member put forward the view that a dispensation to vote needed to clear a 'higher hurdle' than a dispensation for speaking rights only.

It was noted that a number of recent dispensation requests had been approved for speaking only rights and for a specific meeting. A Member commented that a blanket exemption until next ward elections would usually seem less appropriate than one for 'specific meetings only' in the vast majority of instances and that although the boxes currently contained on the application form for 'until next ward election' should probably be retained, encouragement should be given to using them sparingly.

RESOLVED – That the report be received and contents noted.

15. **DISPENSATIONS GUIDANCE FOR CHAIRMEN**

The Comptroller and City Solicitor gave an oral update on guidance to Chairmen and explained that guidance to chairmen on committee interests and decision-making required some further research and consideration and that, given the time constraints and priority work commitments, it had not been possible to produce a paper for this meeting.

The Committee considered the joint report of the Comptroller and City Solicitor and the Town Clerk on recently received dispensation requests.

Partially granted (speaking rights only – voting rights refused)

A dispensation be granted to speak at Barbican Residential Committee on 4 June 2018 on (i) car park charges and stores and (ii) concrete repairs.

The request to vote and speak on (iii) (any discussion which may arise on a possible review of the current composition and terms of reference of the Barbican Residential Committee) was refused as no proposal for this currently exists, and therefore it was not possible to know what form any proposal might take.

1. QUESTIONS RELATING TO THE WORK OF THE COMMITTEE

1. ELECTION OF A CHAIRMAN

It was proposed, duly seconded and

RESOLVED – That Deputy Edward Lord be elected as Chairman for the duration of the meeting.

2. QUESTIONS ON MATTER RELATING TO THE WORK OF THE COMMITTEE

The Sub Committee noted that there are a number of disclosable pecuniary interests that prevent a Member from participating in any discussion or vote on a connected item of business. The disclosable pecuniary interest that is engaged in these cases is:

(a) any beneficial interest in land which is within the area of the relevant authority.

Members also noted that the Localism Act 2011 does not provide any additional guidance on judging whether a disclosable pecuniary interest is engaged or not and states that the prohibition on speaking or voting on a matter is engaged where a Member:

- (a) is present at a meeting;
- (b) has a disclosable pecuniary interest in any matter to be considered, or being considered, at the meeting; and
- (c) is aware that the condition in paragraph (b) is met.

A relevant authority may, on a written request made to the proper officer of the authority by a Member of the authority, grant a dispensation relieving the Member from either or both of the restrictions on speaking or voting in cases

described in the dispensation. A dispensation must specify the period for which it has effect, which may not exceed four years. The relevant criteria for a City of London dispensation are:-

- (a) that without the dispensation the number of persons prohibited from participating in any particular business would be so great a proportion of the body transacting the business as to impede the transaction of the business;
- (b) that granting the dispensation is in the interests of persons living in the authority's area;
- (c) that it is otherwise appropriate to grant a dispensation.

It was further noted that subject to the specific statutory grounds for granting a dispensation, Members may also wish to take into account the following (non-exhaustive) additional factors:

- (i) whether the nature of the Member's interest is such that to allow them to participate would risk damage to public confidence in the conduct of the City Corporation's business;
- (ii) whether the interest is common to the Member and a significant proportion of the general public;
- (iii) whether the Member was elected on a platform that they would specifically address the item or items of business for which the dispensation is sought;
- (iv) whether the participation of the Member in the business that the interest relates to is justified by their particular role or expertise;
- (v) whether the request is for a dispensation to (a) speak at the meeting with the same rights as a member of the public; (b) participate fully in the debate as a Member of the decision-making body in question; or (c) participate fully in the debate as a Member of the decision-making body in question and vote on the business.

During discussion, a Co-opted Member again put forward the view expressed at the recent Standards Committee that some additional relevant information would be of assistance for committee members when assessing dispensation requests, such as committee composition, quorum, number of conflicted members, the situation regarding other ward members, etc if that information was known. He asked that these details be added to the usual dispensations report 'template' going forward. The Town Clerk apologised for the absence of this requested information.

3. **DISPENSATIONS**

The Sub Committee then proceeded to consider each request including, with the agreement of the Chairman, 3 requests received after the agenda papers had been published. The Sub Committee asked that it be recorded that previous dispensations requests granted should not be considered 'as precedent' going forward. The Sub Committee emphasised that the default position was that a Member with a disclosable pecuniary interest in a matter could not speak or vote, and that the onus was on the Member concerned to satisfy the Sub Committee that one of the relevant grounds for granting a dispensation had been met. All requests would be considered on merit based on the information provided and with due regard to all relevant circumstances.

The Sub Committee noted that in this case all of the requests for dispensations related to the same item of business to be heard by the Barbican Residential Committee, on the charging policy for car parking and stores. The Sub Committee considered that a distinction should be made between those resident Members who actually had a car parking space or storage space at present and those that did not – with the latter being allowed to speak, but not the former. The Sub Committee also considered that, where a Member was being refused a dispensation, another Ward Member on the Barbican Residential Committee who did not have a disclosable pecuniary interest, or did have a dispensation to speak, could effectively represent the views of constituents.

Arising from the Sub Committee's detailed consideration of the dispensation requests, and with Members having only taken account of all relevant issues in their determination including committee composition and details of the individual disclosable pecuniary interest and any comments of the Comptroller and City Solicitor, it was

It was noted that Mr Sells had requested a dispensation to speak on a planning application for temporary structures at the Inner Temple which was currently expected to be considered by the Committee on 11th September 2018 but may, in due course, be considered at a later date. It was further noted that the request for a dispensation had arisen due to Mr Sells' disclosable pecuniary interest arising from his residential and business connection with Inner Temple.

The Sub-Committee agreed that Mr Sells had a disclosable pecuniary interest in respect of the future application to the Planning and Transportation Committee and considered whether, as per the request, Mr Sells' knowledge and experience of the Inner Temple area was such that not granting the dispensation to enable him to speak on the matter would limit the debate at the relevant meeting of the Planning and Transportation Committee and prevent the views of the Temple residents from being taken into consideration.

In noting the grounds on which a dispensation could be granted by the authority (as set out under the Localism Act 2011), the Sub-Committee determined that Mr Sells' request for a dispensation to speak on the future planning application for temporary structures at the Inner Temple (on 11th September 2018 or thereafter) should be refused as it did not satisfy any of the criteria on which a request could be granted. It was agreed that other members of the Planning and Transportation Committee could be lobbied by Mr Sells with a view to them making known, during a debate on the application, the views of residents of Inner Temple.

RESOLVED:- That the request for a dispensation from Oliver Sells, to speak on a planning application for temporary structures at the Inner Temple (currently expected to be considered by the Planning and Transportation Committee on 11th September 2018 or at a later date), be refused on the grounds that it did not meet the criteria set out under the Localism Act.

5. **ANY OTHER BUSINESS THAT THE CHAIRMAN CONSIDERS URGENT**At the Chairman's request, the following item of urgent business was considered:-

(i) Request for a dispensation – Mr Shravan Joshi

The Town Clerk tabled a written request for a dispensation from Mr Shravan Joshi, Common Councilman for the Ward of Bishopsgate and a member of the Board of Governors of the City of London Freemen's School, which had been received earlier that morning.

It was noted that Mr Joshi was the parent of two pupils at the City of London Freemen's School and therefore, as a City Corporation appointed Governor serving on the Board of Governors to the School, Mr Joshi had a disclosable pecuniary interest and could not, without a dispensation to speak and/or vote on any of the business considered by the Board of Governors, participate in the business of the Board.

The Sub-Committee considered Mr Joshi's written application and his grounds for a dispensation to allow him to serve as a Governor (to speak/vote on all core strategic business), principally that (i) the Board will be left with a further vacancy and this may impact on its ability to transact its business; and (ii) it is common practice for parents to serve on school governing bodies in both independent and maintained schools and to withdraw from the business when a

specific pecuniary interest arises. It was noted that as a Common Council appointment, Mr Joshi's role as a Governor was different to that of a parent governor and therefore his disclosable pecuniary interest was such that a dispensation could only be granted if it met with the criteria set out under the Localism Act 2011. The Sub-Committee acknowledged Mr Joshi's request to participate only in core strategic business and where no direct pecuniary interest arose. However, Members felt that it was not possible to determine what business before the Board was or was not relevant to Mr Joshi's interest and on that basis, the request should be refused as it was not appropriate for him, in light of his disclosable pecuniary interest, to serve on the Board of Governors as a City Corporation Member.

RESOLVED:- That the request for a dispensation from Mr Shravan Joshi, Common Councilman for the Ward of Bishopsgate and a member of the Board of Governors of the City of London Freemen's School, to speak and vote on the business considered by the Board of Governors of the City of London Freemen's School (excluding matters where there is a direct pecuniary interest) until his term of appointment comes to an end, be refused on the grounds that it did not meet the criteria set out under the Localism Act.

3. **DISPENSATION REQUESTS**

The Sub Committee had before them the report by the Town Clerk on dispensation requests, along with 2 tabled late further applications received from Susan Pearson and Vivienne Littlechild. It was noted that the vast majority of the applications related to the Corporation's housing governance review.

The Sub Committee proceeded to discuss the applications, taking account of advice from the Comptroller and City Solicitor and also noting representations received from the Chairman of the Barbican Residential Committee and the Chairmen of the Barbican Association and Residents' Consultation Committee.

Members were mindful of the legal prohibition on any participation by members in matters where there is a conflict of interests and the member has a DPI. In those circumstances Parliament has provided that members must not participate unless one of the statutory grounds are met. The public perception of participation is a very relevant matter to be born in mind.

The Sub Committee also considered carefully the legitimate expectations of the relevant electorates in electing representatives to the Corporation and the ability of those representatives, who may share common interests with their electors, to nevertheless, make the electors voices heard. Members reminded themselves that the prohibition would not, for example, apply to a member

writing to a committee with a constituent's views, on any matter. It was also open to members to nominate another ward colleague or indeed any member of the Court of Common Council to speak on behalf of electors in circumstances where a DPI would preclude participation in any matter.

The Sub Committee considered whether to allow any application to vote in any matter before them. Members concluded, that the very high threshold of allowing a member to vote even though they had a DPI, was not met in any of the cases before them. The Sub Committee also noted that it was not possible for affected Members to vote on housing matters in any event by virtue of section 618 of the Housing Act 1985.

Having taken account of all relevant matters, the Sub Committee concluded that it was a legitimate expectation for members representing the Barbican who have a DPI because they live in the Barbican, that they should nevertheless be permitted to speak at the Barbican Residential Committee in relation to the housing governance review. The BRC constitution and terms of reference provided for resident member representation and the requirement for 'local democracy to be seen to be being done' weighed heavily. The Sub Committee were also persuaded by the representations from the Chairman of the Barbican Residential Committee, and also by the fact that the decisions on the outcome of the review itself would not rest with that Committee. This dispensation would be granted until 31 December 2019 or the conclusion of the current housing governance review, whichever is the earlier.

Members were not persuaded that requests to speak at other committees or sub committees on the housing governance review was made out, even for Chairmen of Committees concerned. Those applications were rejected.

In the case of application (k) below, the Sub Committee was of the view that the applicant had a significant interest as a leaseholder and occupier of a property affected by the matters in relation to which a dispensation had been requested and that it would therefore be inappropriate to grant a dispensation. It was again noted that opportunity would exist for the Member in question to communicate their constituent's views on a matter in writing or ask an alternate Member to speak.

DISPENSATIONS

Members experienced a rather edifying example of a Member attempting to comply with the Standards Committee's suggestion that residents, and electors, can be adequately represented by communicating their views through another Member. Members agreed that this proved to be something of a farce, when responses to comments led to further questions conveyed via that Member who eventually came to refer to himself as a 'ventriloquist dummy'.

Given that Community and Children's Services addresses many matters of substantial interest to residents in the City, it was the Committee's view that precluding those Members who represent residents from speaking on these issues leads inevitably to an inability to fully consider residents' interest.

Further, the Committee did not believe that hearing from Members who live in the City would cause any harm which the Standards laws and rules are intended to avoid. Members believe the current position causes harm to residents, particularly in the context of the City where many Members are not resident in the City and represent wards predominated by non-residents. Members also expressed concern that the breadth of the denial of dispensations contrasted unfavourably with the way in which apparently similar concerns related to Temple's commercial residents were dismissed. Therefore the Committee resolved to request, THAT -

the Standards Committee craft a set of dispensations that ensures that residents' interests can be fully represented by their elected representatives. To this end, Members of the Community and Children's Services Committee urge the Standards Committee to research the dispensations policies of nearby London Boroughs that seek to address this issue.

DISPENSATIONS

Members who were also residents of the Barbican Estate had not been granted dispensations to speak or vote in respect of today's item of urgent business in respect of the Housing Governance Review.

The Town Clerk explained the rationale behind the above decision as follows:

After consultation with the Chairman and the Deputy Chairman of the Standards Committee, the Town Clerk rejected the request for a dispensation under urgency provisions to speak in connection with the housing governance review at the Housing Management and Almshouses Sub Committee.

At its meeting on Monday 10/9, the Dispensations Sub (Standards) Committee considered a number of dispensation requests, the vast majority of which related to the Housing Governance review. In summary, having taken account of all relevant matters, Members considered that applications to speak at the Barbican Residential Committee on the Housing Governance Review should be granted in view of the strong resident representation included in that Committee's constitution, the requirement for 'local democracy to be seen to be being done' on such a fundamental issue, and also as the final decision on the review itself would not rest with that Committee.

Members were not persuaded that requests to speak at other committees on the Housing Governance Review made as strong a case and considered that these should be rejected. The Sub Committee also noted that Members with a disclosable pecuniary interest could communicate their views on a matter to a committee or chairman in writing, or request an alternate member of that committee to put forward their views.

The Policy & Resources Committee expressed a desire to consult with and receive the views of those Committees which would be affected by any change. Potential options included the disbandment of the Housing Sub Committee, as it currently exists. However, because only half the Members of the Sub-Committee were allowed to speak on this, a proper and complete view could not be formulated by the Sub-Committee, on its own future, for a report to Policy and Resources. The Chairman therefore intended to seek the permission of the Chairman (of the Policy and Resources Committee) to address the Committee when they take a decision on Housing Governance; reflecting the views of those Members who were not granted a dispensation to speak at today's meeting of the Housing Management and Almshouses Sub Committee.

The Chairman expressed his concern at what he perceived to be an over-zealous interpretation of the Localism Act, unique to the City Corporation, resulting in only half of the Members of the Committee being able to speak and potentially disenfranchising residents. Members strongly endorsed this view and asked for their comments to go on

record and for it to be RESOLVED, that – these views be reported to the next meeting of the Standards Committee

Summary

At its last meeting in May the Committee considered a report on registration of interests by Co-opted Members and their online publication. It was noted that an annual update was underway and that co-optees' declarations of interest would then be published.

In August, the returned declaration of interest forms were published on the Corporation's website.

This report sets out details of outstanding forms by Committee and Members are asked to consider these details and decide what future steps to take on this matter.

Recommendations

The Committee is asked to consider the information set out in the report and decide what future steps to take on this matter.

Main Report

Background

- 1. The City Corporation's Code of Conduct for Members, adopted in its latest iteration by the Court of Common Council on 8 March 2018, applies to any Member of the City Corporation and any Member of a Committee of the City Corporation. The Code requires the registration of disclosable pecuniary interests, as specified in regulations made by the Secretary of State, together with certain non-pecuniary interests.
- 2. The Committee has considered previous reports concerning the registration of interests by Co-opted Members. In May 2015 the Committee noted that whilst the statutory provisions in relation to online registration only applied to those Co-opted Members who were entitled to vote on matters relating to the City Corporation's local authority or police authority functions, this did not preclude the register of interests of all Co-opted Members being made available online as a matter of policy. It was agreed that all Co-opted Members should be required to submit a register of interests' form, which

would be published online to promote greater consistency and transparency. The need to make Co-opted Members fully aware of the new approach to managing and publishing interests, and to afford them ample time to raise any queries, was acknowledged.

- 3. Subsequently, in October 2015, the Committee was advised that over 50% of Co-opted Members had not submitted a response and that many of those contacted had also expressed concern at plans to publish their interests, with some suggesting that they might resign over the matter. With regard to the technicalities around publishing the responses received, the Town Clerk reported that this had now been trialled and would be technically possible if the Committee were minded to proceed with this exercise. The Committee requested a paper for the following meeting detailing how each of the various Sub/Consultative/Grand Committees concerned were constituted and providing Members with some advice on how best to proceed in each case. The Committee requested that, in the interim, the Town Clerk contact all relevant Committee Chairmen requesting that they remind their Co-opted Members of the need to submit responses.
- 4. Further details of Co-opted Members by Committee were then considered by the Committee in May 2016. This included the number of Co-opted Members on each Committee, whether they were a legal requirement, whether they were involved in City Fund functions, whether they had voting rights, and the number of forms returned. The Committee requested that the Town Clerk write to all Co-opted Members as a final reminder regarding the completion of their declaration of interests forms before publishing all information received by the end of the calendar year. Following the Committee's decision in July 2016 to recommend to the Court that a review of the standards regime be undertaken, work on some associated framework issues, including interests' publication as detailed above, was temporarily paused pending the review's outcome.

2018 update on registration of interests

- In May 2018, the Town Clerk commenced the annual exercise to contact Elected and Co-opted Members to remind them to review and update their existing declarations. Co-opted Members whose declarations were not currently held on file were invited to complete and return a form within 28 days. The Town Clerk informed Co-opted Members that declarations would be published on the City Corporation's webpages and completed returns were then published online during August.
- 6. The Committee were previously informed that they would receive a report back at its October meeting with an update on progress, together with the latest statistics on response rates for each Committee, to consider whether to review the overall policy and how best to address any non-compliance. The breakdown of outstanding numbers of disclosable pecuniary interest forms (out of 82) is set out below:-

Summary

A Member has requested a dispensation to speak and/or vote on matters where they would otherwise have a disclosable pecuniary interest.

Recommendation

Your Committee is asked to determine the applications for a dispensation.

Main Report

Background

1. A Member has submitted a request for a dispensation. Your Committee has requested that all such applications are accompanied by a covering report.

Disclosable pecuniary interests under the Localism Act 2011

- Under the Localism Act 2011, The Relevant Local Authorities
 (Disclosable Pecuniary Interests) Regulations 2012 and the City
 Corporation's Member Code of Conduct there are a number of
 disclosable pecuniary interests that prevent a Member from participating
 in any discussion or vote on a connected item of business.
- 3. The Localism Act 2011 does not provide any additional guidance on judging whether a disclosable pecuniary interest is engaged or not. It simply states that the prohibition on speaking or voting on a matter is engaged where a Member:
 - (a) is present at a meeting;

- (b) has a disclosable pecuniary interest in any matter to be considered, or being considered, at the meeting; and
- (c) is aware that the condition in paragraph (b) is met.
- 4. It is up to individual Members to make a judgement whether they have a disclosable pecuniary interest in relation to any particular item of business. This will be the case where a decision would materially affect a Member's interest in land, for example by materially affecting the value of that land, the prospects of selling that land, or the use and enjoyment of that land.
- 5. A Member also commits a criminal offence if, without reasonable excuse, they participate in any discussion or vote on any City Fund matter in which they have a disclosable pecuniary interest. For this reason we would always advise a Member to err on the side of caution. A Member who is found guilty of such an offence can be fined up to £5,000 and disqualified from holding office for up to five years. A prosecution may only be instigated by or on behalf of the Director of Public Prosecutions (DPP).

Granting dispensations under the Localism Act 2011

- 6. A relevant authority may, on a written request made to the proper officer of the authority by a Member of the authority, grant a dispensation relieving the Member from either or both of the restrictions on speaking or voting in cases described in the dispensation. A dispensation must specify the period for which it has effect, which may not exceed four years. The granting of such dispensations is a function of this Committee and its Dispensations Sub-Committee. A relevant authority may only grant a dispensation if, after having had regard to all relevant circumstances, the authority:
 - (a) considers that without the dispensation the number of persons prohibited from participating in any particular business would be so great a proportion of the body transacting the business as to impede the transaction of the business:
 - (b) considers that without the dispensation the representation of different political groups on the body transacting any particular business would be so upset as to alter the likely outcome of any vote relating to the business;*
 - (c) considers that granting the dispensation is in the interests of persons living in the authority's area;

- (d) if it is an authority operating executive arrangements, considers that without the dispensation each Member of the authority's executive would be prohibited from participating in any particular business to be transacted by the authority's executive;* or
- (e) considers that it is otherwise appropriate to grant a dispensation.
- * Grounds (b) and (d) are not directly applicable to the City Corporation but are included for completeness and context.

Additional factors

- 7. Subject to the specific statutory grounds for granting a dispensation, Members may also wish to take into account the following (non-exhaustive) additional factors:
 - (i) whether the nature of the Member's interest is such that to allow them to participate would risk damage to public confidence in the conduct of the City Corporation's business;
 - (ii) whether the interest is common to the Member and a significant proportion of the general public;
 - (iii) whether the Member was elected on a platform that they would specifically address the item or items of business for which the dispensation is sought;
 - (iv) whether the participation of the Member in the business that the interest relates to is justified by their particular role or expertise;
 - (v) whether the request is for a dispensation to (a) speak at the meeting with the same rights as a member of the public; (b) participate fully in the debate as a Member of the decision-making body in question; or (c) participate fully in the debate as a Member of the decision-making body in question and vote on the business.
- 8. As previously stated, the onus is on individual Members to decide whether they have a disclosable pecuniary interest in any given matter. Therefore, the Committee should assume for present purposes that any dispensation being sought is required in order to participate, and you should not refuse a request simply on the basis that a dispensation is not thought to be necessary. Any dispensation granted is entirely permissive in nature and does not impose any restrictions on speaking or voting where no such restrictions otherwise exist.

The applications and specific considerations

9. The request for a dispensation that has been received is listed below and the relevant application form appended. This report does not seek to duplicate the information that is contained in the application form. However, where there is additional relevant information this is set out below.

Deputy Robert Merrett

10. A request for a dispensation from Deputy Robert Merrett is attached as an Appendix. He is a Common Councilman for the Ward of Bassishaw and a Common Council appointed member of the Board of Governors of the City of London School for Girls (CLSG). The request is to speak and or vote on all CLSG matters, but not vote on any matter that has a direct financial impact to himself as a parent of a pupil, such as school fees. Deputy Merrett's daughter has recently become a pupil at the school in September 2018.

Recent decision of the Dispensations Sub (Standards) Committee

- 11. At its meeting in August 2018, the Dispensations Sub (Standards) Committee considered a request from a Common Councilman, and the parent of two children at City of London Freemen's School, for a dispensation to speak and vote as a member of the Board of Governors of the School on all business before the Board except the setting of school fees, and the award of bursaries from the City of London Freemen's School Bursary Fund.
- 12. In considering that application it was noted that as a Common Council appointment, the applicant's role as a Governor was different to that of a parent governor and therefore his disclosable pecuniary interest was such that a dispensation could only be granted if it met with the criteria set out under the Localism Act 2011. The Sub-Committee acknowledged the request to participate only in core strategic business and where no direct pecuniary interest arose. However, Members felt that it was not possible to determine what business before the Board was or was not relevant to the disclosable pecuniary interest and on that basis, the request should be refused as it was not appropriate for the applicant, in light of his disclosable pecuniary interest, to serve on the Board of Governors as a City Corporation Member.

Conclusion

13. Your Committee is asked to determine the application in accordance with the criteria set out under the Localism Act 2011.

REQUEST FOR DISPENSATION – DISPENSATIONS FOR MEMBERS TO SPEAK AND VOTE WHERE THEY HAVE CERTAIN DISCLOSABLE PECUNIARY INTERESTS

The new Standards regime does not replicate the former statutory exemptions which allowed Members to vote on a number of matters in which they would otherwise have had a prejudicial interest. However, the City of London Corporation may, following a written request, grant a dispensation for a Member or a Co-opted Member to take part in any discussion and vote on a matter in which they have a disclosable pecuniary interest, in some circumstances

It is anticipated that the principal matters likely to require dispensations are those relating to the following, where a Member has a beneficial interest in land within the City:-

• Housing (where the Member holds a lease or tenancy from the City, as long as the matter does not relate to their particular lease or tenancy).

However, dispensation may be granted in relation to any matter so long as a relevant criterion is met. The criteria that are relevant to the City of London Corporation are as follows:

- Without the dispensation the proportion of Members and Co-opted Members prohibited from participating in any particular business would be so great as to impede the transaction of the business; or
 - Granting the dispensation is in the interests of persons living in the City;
 or
 - It is otherwise appropriate to grant a dispensation.
