### 1. APOLOGIES

# 2. MEMBERS' DECLARATIONS UNDER THE CODE OF CONDUCT IN RESPECT OF ITEMS ON THE AGENDA

Mr Jamie Ingham Clark and Mr Simon Duckworth declared general, non-pecuniary interests in respect of agenda items; (12) Analysis of Grants agreed for the five years 2011/12 – 2015/16 and; (13) Benefits in Kind reporting.

### 3. MINUTES

The public minutes and non-public summary of the meeting held on 21 July 2016 were approved.

### Matters arising

Members noted that, as yet, the City of London Corporation had not awarded the £10,000 grant, agreed by the former Finance Grants Sub Committee in respect of the Sylvia Pankhurst statue, as the match funding target had not been met.

### 4. OUTSTANDING ACTIONS LIST

The Sub Committee received its outstanding actions list and noted particularly the importance of communicating how support could be fulfilled to those organisations previously assisted by the Finance Grants Sub Committee and redirected to other sources, where appropriate.

### 5. **CENTRAL GRANTS PROGRAMME - 360GIVING**

The Sub Committee considered a report of the Chief Grants Officer which provided information on the 360Giving initiative. Members also received an external presentation from Katherine Duerden, Partnerships and Engagement Manager, 360Giving.

During the presentation and questions, the following points were noted:

- The system aligned with the minimum requirements of the Local Government Transparency Code which was not mandatory in respect of the funds being distributed through the Central Grants Unit and within the remit of the Sub Committee (being charitable or from City's Cash only). Therefore, there was no obligation on the City of London Corporation to join the scheme but it demonstrated good practice relating to transparency in the grant-making sector. Publication of relevant information was discretionary and the system allowed for the redaction of any sensitive data; donations to womens' refuges being given as an example by Ms Duerden.
- Ms Duerdin had met with some of the Livery Companies and the Chief Grants Officer agreed to contact all Members of the Livery Committee, which was due to meet before the end of the year.
- Given that the first round of grants were due to be awarded early in the New Year, the Chairman suggested, and Members agreed, that the report be shared with the relevant Service Committees and to ensure the trustees of the charities that form part of the Central Grant Programme were consulted.
- The City Bridge Trust had joined the scheme in September this year and several local authorities have expressed an interest.
- The system had been designed for easy use with spreadsheets, with simple searching tools and could be over-layed with other data sets, such as indices of deprivation. There had been positive feedback from existing users.

 That the Livery Committee be provided with information about the system with a view to drawing this best practice tool to the attention of those Livery Companies which had not yet arranged to meet with 360Giving.

RESOLVED, that - As a matter of policy the Central Grant Programme grants data be published bi-annually on a discretionary basis using the 360Giving Standard subject to any decision not to publish on a case-by-case basis in respect of a grant.

### 6. **CENTRAL GRANTS PROGRAMME**

The Sub Committee received a report of the Chief Grants Officer, which provided an update on the Central Grants Programme (CGP). Members noted the outcome of a report submitted to the Policy and Resources Committee in October 2016, at which Members had agreed to (1) a secondment from the City Bridge Trust (CBT) to manage the CPG for a 6 month period; (2) to receive a follow up report in March 2017 to approve resources for 2017/18; and (3) that the CGU could recharge up to £41,000 to manage the CGU over a 6 month period.

### RESOLVED, that:

- 1. The interim staffing and management fee proposal agreed by the Policy and Resources Committee in October 2016 be noted.
- 2. The update on the CGP be noted.

### Summary

This report provides an update on the CGP. The report includes the outcomes of the first CGP grant round delivered in 2016/2017; an update on the Senior Grants Officer's (SGO) workshops for grantees; an overview of the grants that no longer align with the eligibility criteria of the CGP and an update on the historical grants previously managed by the Finance Grants Sub-Committee.

### Recommendations:

- a) To note the CGP progress update.
- b) To discuss the out of scope grants.

### **Main Report**

### Background

- 1. In March 2016, the Resource Allocation Sub-Committee and the Policy and Resources Committee received a report outlining the work that had been undertaken to date to implement the recommendations of the Effectiveness of Grants Service Based Review (SBR). The aim of the review was to increase the strategic impact of grant-making, ensure that the grants are managed more efficiently and effectively, improve the consistency and quality of the customer experience and so bring consequential reputational benefits. The report recommended a consolidated CGP be implemented.
- 2. In order to manage the CGP effectively a new CGU was proposed. The CGU would be responsible for the management of all grant applications, monitoring and evaluation processes and committee reporting procedures.
- 3. It was agreed that the CGU would be co-located with City Bridge Trust (CBT) in order to facilitate consistency of approach and harmonise service standards. The Chief Grants Officer, responsible for the grant-making activities of CBT will maintain an overview of the CGU, with relevant input from the Head of Charity and Social Investment Finance.

- 4. The four CGP funding themes were agreed in March 2016 by the Policy and resources Committee, and the eligibility criteria subsequently agreed by each respective grant-giving committee.
- 5. The CGP started accepting grant applications from 15 August 2016 and was managed by an interim resource until the SGO secondment from CBT started in October 2016.

### **CGP Update**

6. An update on the progress of the first CGP grant round is provided in the below table:

### **Workshops for prospective grantees**

8. In order to ensure that prospective grantees are given the opportunity to discuss potential applications with the Senior Grants Officer (SGO), a series of one to one advice sessions have been delivered at the Guildhall. Two have been delivered to date with an average of six organisations attending each session. Feedback from those attending has been positive. Additional sessions will be held, at appropriate times before established grant deadlines.

### Out of scope grants

Members requested an update on which organisations had in the past received a grant from the CoLC and which do not align with the existing CGP eligibility criteria:

<u>Christmas Grants</u> - As part of the Effectiveness of Grants Review, the Finance Committee Chairman's Discretionary Fund was discontinued by the Policy and Resources Committee. In previous years, this Fund and the Combined Relief of Poverty Charity (1073660) funds had been used to make small donations at Christmas to charities based around London, up to a total of £10,000.

There is currently no additional funding available for the CGP to agree Christmas grants in 2017/2018. As an interim solution in 2016 the Finance Committee agreed a one off payment to four charities (The Parent House, Crisis, The Stuart Low Trust, Solace Women's Aid) along with the request that a permanent solution to be determined for future years.

- a) <u>St Paul's Bells</u> An initial request was received for the repair of the bells. Advice was provided by the SGO that it was unlikely to be eligible, particularly given that the amount to be requested would exceed the funding cap of £10,000. However, an application is due to be discussed at Policy and Resources Committee on 16<sup>th</sup> February.
- b) Sheriffs and Recorders Fund This Fund was allocated £25,000 in 2014/2015 by the Finance Grants Sub-Committee, which was in turn allocated as small grants to ex-prisoners and their families in London. It is unlikely that they would be eligible for a grant under the existing CGP eligibility criteria.
- c) Prisoners of Conscience Appeal Fund This Fund received support from Finance Grants Sub-Committee since 2007 with two separate three-year grants for bursaries and one core grant in 2015. A recent application was made to the 'Education and Employment' programme of the CGU. The project did not align closely enough with the objects of the City Educational Trust and was therefore not approved for support.

- d) <u>Spitalfield's Music</u> Funding is currently issued to this organisation through the City Educational Trust fund at a level of £45, 000 per year (until 2017/2018). The Education and Employment programme eligibility criteria is currently under review and it is unlikely that the same level of funding would be available. However, the project may still fit the criteria of this theme.
- e) Thames Festival The festival received an annual £15,000 contribution from the Economic Development Office (EDO) in previous years. This festival will no longer be supported by EDO and so the festival will be applying to the Inspiring London through Culture theme. It is potentially eligible but grants from this theme are capped at £10,000.
- f) Dr Johnson's House This organisation is currently funded until 2017/2018 by a grant awarded by the Finance Grants Sub-Committee and is in receipt of £10,000 per year. This grant is overseen by this Sub-Committee until it comes to an end. The grant currently goes towards running expenses and the cost of providing education and public engagement work. It is anticipated that when the current grant ends in 2018, that an application could be submitted to the Inspiring London through Culture theme. Whether grants that span more than one year would be considered by Culture, Heritage and Libraries Committee is yet to be determined.
- g) St. Paul's Chorister Trust This Trust received a reducing grant over three years £15,000; £12,500 and £10,000 to support choristers of limited means, who otherwise might not be able to take up a place in the choir. This grant ended in 2016/2017. This Trust may be eligible to apply on behalf of their pupils to the Education and Employment theme, however, the funds available from The City of London Corporation Combined Education Charity to distribute are limited and funding may not be awarded at the same level as previously agreed.

### **Finance Grants Sub-Committee: Historical grants**

- 10. In March 2016, the Policy and Resources Committee agreed that all on-going funding commitments formerly managed through the Finance Grants Sub-Committee (FGSC) would be transferred to the most appropriate Committee for on-going administration. For those that had no set review date, it was requested that they be reviewed and reported back to the Policy and Resources Committee for approval.
- 11. Each funding commitment (except The Guildhall School Trust payment for which a report is currently being prepared by Education Policy Officers for submission to the Education Board in May 2017) has been reviewed and reported to the Policy and Resources Committee. The Committee agreed that all future reviews would be undertaken regularly, be submitted to the responsible Committee and that each payment would incorporated into the responsible Department's budget.

### Summary

An overview of the CGP budget for the current financial year 2016/2017 and a forecast for 2017/18 has been provided in order to update Members on the financial position of the CGP.

As two of the four CGP funding themes have yet to award funding and time and resource will be committed by the Senior Grants Officer (SGO) and other officers between now and the end of March 2017 to support this work; a full report will be issued to Members at the next meeting of this Sub-Committee.

### Recommendations

- To note the CGP management fee to be recharged to each of the four funding themes.
- To note the CGP budget report.

### **Main Report**

### **Background**

### **CGU Staffing and management fee**

1. In September 2016, Members of the Policy and Resources Committee agreed to endorse an approach, which allowed City Bridge Trust to second staff in to manage the CGP until 31st March 2017 agreed an interim resource of up to £41,000 to support the Central Grants Unit (CGU) during this time (equivalent to 10% of the CGP's total budget allocation).

- 2. The Central Grants Unit (CGU) has implemented a time recording system so that each of the four funding themes can be recharged for the actual time and resource spent by officers on each theme.
- 3. A breakdown of the officer time spent managing each CGP theme between October 2016 and January 2017, the overhead costs incurred by City Bridge Trust relating to this and the amount that will be recharged to each CGP theme is shown at Appendix 1.
- 4. Members are requested to note that two officer panels responsible for allocating funds from the CGP in financial year 2016/2017 will not have met by the time that this report has been written (Enjoying Green Spaces and the Natural Environment and Stronger Communities). A verbal update will be provided at the Sub-Committee meeting on 21<sup>st</sup> February 2017.
- 5. A report will be submitted to the Policy and Resources Committee in March 2017 to agree the CGP management approach post March 2017.

### **CGP Budget 2017/2018**

- 6. The CGP budget for the current financial year, (which includes a breakdown of how the funds are distributed across all four funding themes) and a forecast for 2017/18 are provided at Appendix 2.
- 7. Members are requested to note that the level of funding available to distribute through the CGP is less for 2017/2018. This is because of the reduced carry forward funding and a slight reduction in investment income across all in scope charities see below.

### **Investment Income overview for in scope charities**

- 8. The funding available to distribute from the City Educational Trust Fund and The City of London Corporation Combined Education Charity (312836) is generated on an annual basis through investment income from the charitable assets. The charities do not have an express power to accumulate income. An overview of the investment income generated for both charities over the past 5 years is provided below in Table 1 and 2 below.
- 9. In respect of 2016-2017, the first half dividend income has been received and amounts to £22,645. The 2nd half dividend income will be paid at the end of the financial year along with interest on the cash balance.
