#### 5. CENTRAL GRANTS PROGRAMME (CGP) - UPDATE

The Sub Committee considered a report of the Chief Grants Officer, which provided an update on the Central Grants Programme. At the last meeting, Members requested an update on previous recipients of City of London Corporation Grants, which fell outside the scope of the new criteria, and this information was set out in paragraph 9 of the report.

Members were asked to consider whether any of these organisations might warrant further discussion; both in terms of their historic relationships with the City of London Corporation and the social-economic value of previous and future grants. The Chairman asked Members to consider visible patronage rather than just quantum. The Chief Grants Officer suggested that, for some recipients, it might be more appropriate to insert new budget lines, subject to agreement by the relevant Service Committee/Resource Allocation Sub Committee, as opposed to encouraging a reliance on grants.

Members noted that if they were to consider a case for on-going support for any or all of the previous grant recipients, falling outside the scope of the new criteria, they could report this to the relevant Service Committees to consider, as appropriate, in any review of the policies which had been adopted to guide grant-making. The Chief Grants Officer advised that the outcome of these reports could provide the Finance Grants Oversight and Performance Sub Committee with a further gap analysis and inform a decision of the Service/Resource Allocation Sub Committee, if appropriate.

RESOLVED, that – The Finance Grants Oversight and Performance Sub Committee receive a report at their next meeting addressing any funding gaps which have been identified under the current criteria and, if appropriate, the report may include a recommendation relating to funding gaps and reference to the relevant service committees.

#### Summary

This report provides an update on the CGP. The report includes the outcomes of the first CGP grant round delivered in 2016/2017; an update on the Senior Grants Officer's (SGO) workshops for grantees; an overview of current grant deadlines and an update on the implementation of the monitoring and evaluation systems for the CGP.

#### Recommendations:

a) To note the CGP progress update.

#### **Main Report**

#### Background

- 1. In March 2016, the Resource Allocation Sub-Committee and the Policy and Resources Committee received a report outlining the work that had been undertaken to date to implement the recommendations of the Effectiveness of Grants Service Based Review (SBR). The aim of the review was to increase the strategic impact of grant-making, ensure that the grants are managed more efficiently and effectively, improve the consistency and quality of the customer experience and so bring consequential reputational benefits. The report recommended a consolidated CGP be implemented.
- 2. In order to manage the CGP effectively a new CGU was proposed. The CGU would be responsible for the management of all grant applications, monitoring and evaluation processes and committee reporting procedures.
- 3. It was agreed that the CGU would be co-located with City Bridge Trust (CBT) in order to facilitate consistency of approach and harmonise service standards. The Chief Grants Officer, responsible for the grant-making activities of CBT will maintain an overview of the CGU, with relevant input from the Head of Charity and Social Investment Finance.

- 4. The four CGP funding themes were agreed in March 2016 by the Policy and Resources Committee, and the eligibility criteria subsequently agreed by each respective grant-giving committee.
- 5. The CGP started accepting grant applications from 15 August 2016 and was managed by an interim resource until the SGO secondment from CBT started in October 2016.

#### **Workshops for prospective grantees**

- 8. In order to ensure that prospective grantees are given the opportunity to discuss potential applications with the Senior Grants Officer (SGO), a series of one to one advice sessions have been delivered at the Guildhall. Two have been delivered to date with an average of six organisations attending each session. Feedback from those attending has been positive. Additional sessions will be held, at appropriate times before established grant deadlines.
- Four additional one to one meetings have been delivered in the build up to the last Inspiring London through Culture deadline either face to face or over the phone.

#### Overview of current deadlines

- 10. The Inspiring London through Culture programme of the CGU had a recent deadline on 29<sup>th</sup> June 2017. 8 applications have been received with an Officer Panel arranged for 28<sup>th</sup> July 2017. Decisions for this round of funding will be agreed at Culture, Heritage and Libraries Committee in September.
- 11. The eligibility criteria for the Education and Employment theme of the CGU is being revised. The Education Charity Sub-Committee met on 14 February 2017. Members received and approved the revised eligibility criteria for the City Educational Trust Fund (Charity Number 290840) and the City of London Corporation Combined Education Charity (Charity Number 312836).
- 12. At the time of writing a joint report with the revised eligibility criteria is being considered by the Community and Children's Services Committee and then for approval by the Education Board. A verbal update will be provided at this meeting. Once the new criteria has been approved application for the Education and Employment programme will re-open with decisions to be made at the Education Charity Sub-Committee in October.
- 13. Stronger Communities and Enjoying Green Spaces and the Natural Environment are currently closed and your Officer is consulting with departments on new deadlines.

#### Monitoring

14. Since the last meeting of the Sub-Committee the SGO has set up and implemented and online monitoring and evaluation system in line with best

practice from the City Bridge Trust. Analysis of the first grant awards will be provided the next time this Sub-Committee meets.
