17. PORT HEALTH AND ENVIRONMENTAL SERVICES DEBTORS -PERIOD ENDING 30 SEPTEMBER 2020

The Committee received the joint report of the Director of the Built Environment, the Director of Markets and Consumer Protection, and the Director of Open Spaces.

The Committee was informed that the report sets out the position as of September 2020 at which time the 120 days debts were over £160K, mainly in light of COVID-19. However, over £63K of this has subsequently been cleared, and the position is expected to continue to improve.

The Chairman and Deputy Chairman noted that it is a difficult time for everyone. The Deputy Chairman commented that a number of local authorities had not paid their outstanding debts. This was followed by another who commented that the London Borough of Croydon is on the list of debtors and Croydon has effectively just been declared as being bankrupt.

The Chamberlain's Department responded that Officers are working on chasing the outstanding payments.
