The minutes of the Court of Common Council were laid upon the table of the Court.

Vote of Thanks to the Late Lord Mayor, Alderman Peter Kenneth Estlin **Resolved unanimously:-** That this Court wishes to convey to Alderman Peter Kenneth Estlin its warmest thanks for the exemplary manner in which he has carried out the role of Lord Mayor of this City and its pleasure in having this opportunity to acknowledge that the Lord Mayor has at all times performed the duties of the office with commitment, dignity and great skill.

Throughout Peter's year, he has rigorously championed his Mayoral Theme, Shaping Tomorrow's City Today. This has been at the centre of his year and has been of enormous benefit to the City, to London as a whole and indeed, the country, helping to ensure the U.K. remains a global hub for digital innovation and at the forefront of competitiveness. The significant efforts of the 'Digital Lord Mayor', as he is now known, have produced a lasting legacy in the establishment of Future.NOW which is designed to ensure a unified approach to digital skills across the country and will undoubtedly be a testament to his work in the coming years.

The Lord Mayor's extensive travel to more than 25 countries during his time in office has included three trips each to the United States and to China as well as leading business delegations to a number of regions such as the Gulf, Latin America, and Africa. These overseas visits have succeeded in fostering mutual trade and good will – invaluable in light of Brexit – and in generating commercial

opportunities and strengthening bonds with global partners.

Peter has also worked ceaselessly here at home, successfully promoting and strengthening the City's relationship with cities and economic centres outside of London, where two-thirds of the country's financial services are based. He has given more than 40 speeches a month at towns and cities across the nation, emphasising the need for businesses across the country to share best practice and to support one another better.

The Lord Mayor has hosted many extraordinary occasions in Guildhall and Mansion House during the past year, including the high-profile Business and Industry Dinner and the International Trade Dinner. Both highly significant occasions, with the latter attended by the Vice President of the United States, I know these special occasions will have left Peter with many cherished memories.

During this very busy year, the Lord Mayor has been fortunate to receive unending support in all endeavours from the Lady Mayoress, Lindy, whose efforts helped to ensure that the Digital Lord Mayor's year was a success. As the Mayoral year draws to a close, the Court of Aldermen unite in thanking Peter for all that he has done as Lord Mayor of the City of London and send to him, Lindy, and their children, their very best wishes for their future good health and happiness.

Vote of Thanks to the Late Recorder of London, The Honourable Mr Justice Hilliard **Resolved Unanimously:-** That, upon his retirement from the office of The Recorder of London, this Court wishes to express to The Honourable Mr Justice Hilliard, its sincere appreciation of his services to the City of London Corporation and to the public he has served with commitment, energy and expertise.

Called to the Bar in 1981, as a barrister Nicholas was Junior and Senior Treasury Counsel at the Central Criminal Court before taking Silk in 2008. He specialised in serious criminal cases and inquests and, amongst others, was involved in the inquests into the deaths of Diana, Princess of Wales, and Jean Charles de Menezes. He was Chair of the Criminal Bar Association and Leader of the South Eastern Circuit. Having served for two periods on Common Council for the Ward of Farringdon Without, firstly between 1994 and 1996, and later between 2005 and 2009, Nicholas was no stranger to the inner workings of the City Corporation when, in 2013, he came to the Old Bailey as Common Serjeant before being appointed as Recorder of London in 2015: both appointments reflective of his illustrious legal career.

Since his arrival at the Old Bailey, he has overseen a very significant transformation of the judicial team and of the work that is done at the Old Bailey. There is now a more diverse team of judges than hitherto and the Old Bailey is once again dealing with the most high-profile and serious criminal cases, as well as with some inquests, several of which Nicholas conducted in his capacity as Deputy Coroner.

As well as carrying out the many ceremonial duties of the Recorder, he successfully expanded the range of duties into a broader community role which resulted in many school and university groups, charities and community groups visiting and experiencing the Old Bailey on a frequent basis. Of note, as an active and

passionate Parton of the Ben Kinsella Trust, which works to promote awareness of the effects of knife crime, Nicholas delivered regular sessions at the Old Bailey for young people thought to be at risk of becoming involved in gang and knife crime.

In thanking him for his service as The Recorder of London over the past five years, this Court offers The Honourable Mr Justice Hilliard and his wife Jane, who has also devoted a large amount of her own time and energy to the civic City, very good wishes for the future and great success in his new role as a High Court Judge.
