Audio-visual Participation in Formal Meetings

Following the outbreak of COVID-19 together with restrictions on gatherings and travel in Spring 2020, the Government had introduced temporary emergency measures (the *Local Authorities and Police and Crime Panels (Coronavirus)* (Flexibility of Local Authority and Police and Crime Panel Meetings) (England and Wales) Regulations 2020) enabling local authorities to undertake formal decision-making meetings virtually until 6th May 2021. Virtual meetings had introduced more flexibility, helped to facilitate greater public scrutiny and aided Members and officers in conducting business more efficiently; however, the Ministry of Housing, Communities and Local Government (MHCLG) had confirmed that these measures would not be extended beyond 6th May 2021 and that local authority meetings would not therefore be able to continue virtually or in a hybrid format.

Part 5A of the Local Government Act 1972 covered public access to meetings, agendas and reports, the inspection of minutes and background papers, etc. and applied to the Common Council in its capacity as a local authority and police authority. Without the modifications introduced by the 2020 Regulations the legislation prohibited formal meetings taking place virtually. This meant that in order to participate in discussions and vote on decisions or recommendations, Members must be present physically at the meeting at which the matter is considered. The legislative framework did not apply to informal meetings such as call-overs and working parties. The Court of Common Council had in the past voluntarily chosen

to apply Part 5A to all its formal meetings including those with non-local authority and non-police authority functions. The need for public access to meetings in accordance with Part 5A was referred to in Standing Orders No. 4 and 32 but the Standing Orders also give the Court and its Committees scope to disapply those provisions in respect of non-local authority and non-police authority functions. Notwithstanding the fact that committees can, if they so choose, change the way the legislation was applied, the Committee was of view that rather than leaving this to individual committees and addressing the issue in a piece-meal manner, any change is best dealt with holistically, with a corporate, policy, decision being taken and applied across the board.

The Chair, introducing the report, proposed two minor amendments to recommendations 4 and 5, to reflect more accurately the decisions of the Policy & Resources Committee in respect of the proposed delegation to officers nominated by the Town Clerk, the inclusion of the Court, and to require the bringing forward of chairmanship elections for committees with local or police authority functions.

McGuinness, C.S., Deputy; Hayward, C.M., Sheriff Amendment - That:-

- recommendation 4 be amended such that the words "a committee or subcommittee" be deleted and replaced with the words "the Court or its Committees" and the words "or other officer nominated by him" be inserted following the words "Town Clerk"; and
- recommendation 5 be amended such that the first sentence be deleted and replaced with "Where necessary, Committees exercising local and police authority functions be requested to bring forward the process for the election of Chairs and Deputy Chairs so that the elections take place before 6th May."

Upon the Amendment being put, the Lord Mayor declared it to be carried.

Members proceeded to debate the report as amended. During debate, the following positions were expressed:

- A Member expressed their significant concern in relation to aspects of the proposals, observing that the paper proposed effectively to circumvent the current law requiring physical meetings through the use of mechanisms which placed final decision-making in the hands of unelected officials. The Member outlined their doubts that this process would survive the scrutiny of the courts in respect of planning or licensing matters and added that it should not, in any event, survive the scrutiny of a democratic organisation.
- Several Members also argued that the proposed approach sent the wrong message to the wider City, one of timidity and hesitancy, when at the same time the City Corporation was proclaiming that the City was open and was advocating for visitors and businesses to come back. Reservations were expressed as to how the Corporation could on the one hand tell others they should return whilst not doing so itself and it was urged that such mixedmessaging be avoided, with the Corporation having the confidence to lead from the front in returning to business-as-normal.
- Other Members suggested that it was highly unlikely that City businesses were waiting to see what the City Corporation did with its own staff or

meetings before coming to a conclusion as to their own arrangements. They argued that the Court should consider what was best for the Corporation in terms of decision-making and transparency thereof, observing that the proposals represented a sensible and pragmatic attempt to navigate through the very difficult position imposed over the short to medium-term by the Government's decisions in this area.

- Members also observed that a large proportion of staff and Members were not yet vaccinated and that the pandemic was still very real, urging caution in respect of the potential risks of exposure. It was noted that Government advice remained to work from home where possible and, in any event, as people did return to the office, social distancing requirements meant that most would not be in the office the full working week for some time.
- A Member commented that it was likely that many business would cease to have employees in offices full-time following the pandemic, with increased working from home arrangements. As the business world evolved, the Member urged that the Corporation should endeavour to keep pace and not hold exclusively to the idea of meeting in person, as this might be somewhat self-destructive in terms of its ability to operate in a modern and effective fashion.
- With reference to social distancing requirements, a Member observed that a fully physical return would lead to difficulties in terms of attendance at larger meetings, as it would not always be possible to accommodate all Members in the available space. This would have the undesirable effect of a two-tier system which excluded some Members from being able to attend and participate at meetings. Conversely, the proposals here represented a pragmatic solution which gave all Members an equal opportunity to participate.
- A Member urged that exploratory work be undertaken to look at other City venues beyond the Guildhall that might be used for physical meetings, where there was a larger space footprint so as to accommodate greater numbers with social distancing arrangements in place.
- It was also observed that the Secretary of State for Housing, Communities & Local Government had suggested powers should be delegated to the executive to allow for decision-making to continue unimpeded in the interim; what was proposed here was much more democratic in that it allowed for debate and Member scrutiny in a public setting in the interim period.
- Several Members reflected on the need to place a "sunset clause" on the interim arrangements proposed, whilst also keeping measures under review and revisiting the position if and when restrictions were eased.

Luder, I.L., Alderman; Hailes, T.R., Alderman Amendment – That, in recommendation 4, the words "For the time being, while certain restrictions are still in place" be deleted and replaced with the words "Until Thursday 7 October".

Upon the Amendment being put, the Lord Mayor declared it to be carried.

The Chair of Policy and Resources spoke to close the debate, observing that many

other councils faced the same challenges in trying to find a solution at this difficult time and arguing that the proposals represented a practical way forward for the City Corporation.

Resolved - That:-

- Members should continue to have the flexibility to participate in Court and committee meetings remotely, when exercising non-local authority and nonpolice authority functions;
- 2. For non-local authority committees, Part 5A of the Local Government Act be retained to enable public to continue to have access to meetings and public papers and, in order to retain the ability to meet virtually or in hybrid format, the City Corporation continues to apply Local Authorities and Police and Crime Panels (Coronavirus) (Flexibility of Local Authority and Police and Crime Panel Meetings) (England and Wales) Regulations 2020 as if they continue to be in force after 6th May 2021.
- 3. A change to the wording on the title page of non-public committee reports which relate to the Common Council's non-local authority and non-police authority functions be authorised to make it clear that Part 5A of the Local Government Act 1972 is being voluntarily applied:
- 4. Until Thursday 7th October 2021, it be agreed that formal local and police authority business be dealt with via a "Covid" ratification process, i.e. by holding an informal virtual meeting in the first instance to ascertain the general view of the Court of its committees, with the public being given access to the informal meeting to maintain transparency via live streaming and recording. A formal decision, which accurately reflects the mood of the informal meeting, can then be taken by the Town Clerk, or other officer nominated by him, who is hereby given delegated authority to formally approve such decisions pursuant to s.101(1) of the Local Government Act 1972.
- 5. Where necessary, Committees exercising local and police authority functions be requested to bring forward the process for the election of Chairs and Deputy Chairs so that the elections take place before 6th May. This could be done via a special, one item meeting if necessary, using the current balloting arrangements. This way the elections will not require ratification under the Covid decision making process.
- 6. All Members (elected or otherwise) who need to return to Guildhall for face-to-face meetings should be encouraged to undertake regular lateral (rapid) flow tests prior to coming into Guildhall in the same way staff, who have to attend the workplace to perform duties that they cannot do at home, are being encouraged to do;
- 7. Any decision take by the Court this day be communicated to external co-optees and other non-CoCo Committee Members; and,
- 8. The Town Clerk be authorised to make such amendments to Standing Orders and related corporate governance documentation as is required to give effect to the above decisions.

8. ESTABLISHMENT COMMITTEE

(Deputy Edward Lord, O.B.E., J.P.)

26 March 2021

(A) Election of Chamberlain and appointment of other Senior Officers

Following Dr Peter Kane's decision to demit from the office of Chamberlain with effect from 30th April 2021, the Establishment Committee commenced the process of recruiting a successor, alongside the Finance and Investment Committees. At the same time, the Corporation also launched a recruitment campaign for eight other senior officer roles which had been created as part of the Target Operating Model endorsed by the Court of Common Council in December 2020.

Following an exhaustive search process, including significant public advertising, the recruitment panels appointed by the Establishment Committee had concluded their activities and a number of appointments were made together with the recommendation for a candidate for election as Chamberlain.

In respect of the election of Chamberlain, it was advised that the candidate would appear before the Court of Common Council (in private session) and give a presentation. Upon the candidate's withdrawal from the Court, a ballot by Members would be held for the appointment and, on completion of that, the public would be re-admitted and the decision of the Court made known.

Lord, C.E., O.B.E., J.P., Deputy, McGuinness, C.S., Deputy Resolved – that the public be excluded from the meeting for the interview of the candidate for Chamberlain on the grounds that it involved the likely disclosure of exempt information as defined in Paragraph 1 of Part 1 of the Local Government Act, 1972.

Summary of the exempt item considered whilst the public were excluded The candidate for the Chamberlain, having been called in, addressed the Court on a given subject and then withdrew.

The Court proceeded to ballot on the appointment.

The ballot for the Chamberlain having been taken up and cast, the Lord Mayor declared Caroline Al-Beyerty to have been elected.

Whereupon the Court resolved that strangers be re-admitted.

The Town Clerk reported that the Court of Common Council had, in accordance with Standing Order No. 61(1), elected Caroline Al-Beyerty to be Chamberlain.

Whereupon The Right Honourable The Lord Mayor declared Caroline Al-Beyerty to be duly appointed to the Office of Chamberlain on the usual terms and conditions relating to the appointment of Chief Officers and subject to such other regulations as this Court has adopted or may hereafter adopt in respect of the said appointment, and to all other orders and regulations of this Court with reference to its Officers.

Caroline Al-Beyerty accepted the appointment, thanked the Court and withdrew.

Resolved - That:

- 1. Caroline Al-Beyerty be elected to the office of Chamberlain of London & Chief Financial Officer with effect from 1 May 2021; and
- 2. The appointment of the following additional senior officers be noted:

(B) Recruitment Panels for Tier 1 and 2 positions

The new Target Operating Model would bring about departmental changes which would affect which Committees (and, therefore, which Members) would be involved in the recruitment process for Senior Officers. As some committee responsibilities were likely to change following consideration of Lord Lisvane's recommendations in the Governance review and any changes in Tier 2 and further layers of the Target Operating Model, an interim position had been proposed for the recruitment of Tier 1 or Tier 2 roles.

Applications for Hospitality

(a) Industry and Parliament Trust Programme 2021

It was proposed that the City Corporation continue to collaborate with the Industry and Parliament Trust on a series of meetings in 2021 related to areas of interest to the City Corporation. Guests and speakers would include a City representative such as the Lord Mayor or Policy Chair, parliamentarians, policy makers, and prominent business, academic and industry representatives.

These events would support the following Corporate Plan outcomes: to influence UK and global policy and regulations, and international agreements to protect and

grow the UK economy; and to preserve and promote the City as the world-leading global centre for financial and professional services, commerce and culture.

It was, therefore, **recommended** that hospitality be granted and that arrangements be made under the auspices of the Policy and Resources Committee; the costs to be met from City's Cash within approved parameters.

Resolved – That hospitality be granted for a series of meetings delivered in collaboration with the Industry and Parliament Trust in 2021, with arrangements made under the auspices of the Policy and Resources Committee; the costs to be met from City's Cash and within the approved parameters.

(b) Pride Flag Raising Ceremony 2021

The 2021 Pride in London Parade was planned to take place on Saturday 4th September, subject to COVID restrictions in place at that time, and it was proposed that the Pride Flag be raised at Guildhall on Friday 3rd September 2021.

If a reception was possible, it was proposed that the City Corporation host a reception in Guildhall as in previous years. Should COVID restrictions preclude a reception taking place in the normal format, alternative formats would be considered including an outdoor reception and/or a virtual hybrid event. Guests would include representatives of the LGBTQ+ networks, businesses and firms within the City and leading LGBTQ+ charities.

The event would support the following Corporate Plan outcomes: to promote and champion diversity, inclusion and the removal of institutional barriers and structural inequalities (outcome 2a) and to bring individuals and communities together to share experiences and promote wellbeing, mutual respect and tolerance (outcome 4a).

It was, therefore, **recommended** that hospitality be granted for an early evening reception or other event following the Pride Flag raising and that arrangements be under the auspices of the Establishment Committee; the costs to be met from City's Cash within approved parameters.

The host element would be Establishment Committee, Hospitality Working Party and Members with relevant interests.

Resolved – That hospitality be granted for an early evening reception or other event following the Pride Flag raising, with arrangements made under the auspices of the Establishment Committee; the costs to be met from City's Cash and within the approved parameters.

Mayhew, J.P.; Mooney, B.D.F., Deputy Joyce Carruthers Nash, O.B.E.

for her unstinting dedication and extraordinary service to the Ward of Aldersgate, the City Corporation, and the City of London over the past thirty-six years.

Joyce has been granted a leave of absence and stepped down as Deputy for the Ward of Aldersgate, having served in that role since 1988 – namely, well over 30 years.

For many decades, Joyce was a teacher in her native Yorkshire – for most of that time, serving as a head teacher. She was, also, an independent local councillor.

During one vacation, she attended an education conference and met Roy Nash, an education correspondent for the BBC. Not long afterwards, Joyce married Roy, left her native Yorkshire, moved into the Barbican and, in 1983, was was elected to this Honourable Court.

Joyce quickly established herself as an extremely committed Member of the Court. Indeed, her contribution has been so far-reaching that it is difficult to do justice within the confines of a single Vote of Thanks.

As a resident of the City, Joyce has championed and represented residents' interests, the success of which is best-evidenced by the remarkable consistency of her support at the ballot box by the voters of Aldersgate, as well as through her committed service for so many years on the Barbican Residential Committee.

During her time on the Court, Joyce has played an active role in a wide array of committees, reflecting the extremely broad spectrum of business conducted by this City Corporation.

Indeed, it might be quicker to list the Committees on which she has not served, or the areas on which she has not made a lasting impact.

However, to name but a few, these include a remarkable 34 years on the Policy & Resources Committee, playing a constant role in shaping the direction of our City; 35 years on the Establishment Committee, closely involved in ensuring the Corporation's own workforce was cared for and nurtured; 17 years on the City Bridge Trust, using her knowledge and compassion to help those in need across London and make a difference to the lives of so many.

Joyce's professional background as a former headteacher also proved extremely valuable during her many years as a Governor on the City's independent Schools and Education Board.

Amongst the Grand Committees and Boards Joyce chaired include the City of London School for Girls; Port Health; the Barbican Centre; the City Bridge Trust; and City Lands – in which role, she was, of course, Chief Commoner, during which she was called upon to assist the Lord Mayor on official visits to Brunei, Australia, and the Philippines.

In the context of the COVID-19 pandemic, it is worth reflecting on Joyce's most recent Chairmanship – namely, of the Health & Wellbeing Board. Having overseen the launch and implementation of the Social Wellbeing Strategy, the Suicide Prevention Action Plan, and the Business Healthy Strategy (to name but a few initiatives), Joyce's work has clearly enhanced the City's commitment to safeguard its residents and workers. This will, no doubt, be one of a number of lasting legacies left by Joyce on our organisation and demonstrates the fundamental difference she has made to the lives of so many, right up to the present day.

Unsurprisingly, for such a powerful character in the Court's life, Joyce acquired a number of nicknames, all of which communicated genuine regard. One past (sadly departed) Chief Commoner, John Barker, called her "Reuters" – adding that you could save yourself a lot of time if you wanted something to be known – by just telling Joyce; and Auntie Joyce and / or mother of the Court – said with real affection.

As a new and relatively young Common Councillor, one could testify to the regular weekend calls when she would offer wise advice – typically, a judicious mix of caution and encouragement, combined with some new intelligence and/or gossip, often starting with the words: "I was told in confidence". One colleague recalls how Joyce helped him to begin "to understand the mysteries of the Corporation". Fellow Aldersgate colleagues could recall similar stories of support and advice.

In short, throughout her career, Joyce has demonstrated remarkable stamina, comradeship, and commitment to this Court; to this Corporation; and to this City.

In receiving this vote, this Honourable Court, therefore extends to Joyce its greatest and sincerest thanks, together with its deep appreciation for her advocacy of and commitment to the City Corporation over the past over thirty-six years.

for her tireless dedication and outstanding service to the Ward of Aldgate, the City Corporation, and the City of London over the past twenty years.

Elected to the Court of Common Council in 2001, Sylvia has been an industrious, diligent and reliable Member of the Court. Sylvia has been associated with the Ward of Aldgate throughout her working life, and her career with Lloyd's Register meant she understood the Ward's unique identity as the Maritime Ward of the City. Her background proved immeasurably valuable to the City Corporation over the years and the City benefited greatly from her wealth of knowledge and experience.

Sylvia will be particularly remembered for her time as Chairman of the Board of Governors of the City of London School for Girls, during which the school saw some of its best results, together with record application numbers. She also oversaw vital infrastructure improvements and presided over difficult and emotive issues such as teachers pay negotiations and the Reduction in School Fees for teaching staff. The dedication and support that Sylvia committed to the Girls' School, as indeed to the City of London School, whose Board she served on for over a decade, was unmatched. Her proactive and unfailing advocacy for the Schools' activities is fondly remembered.

Beyond the Schools, Sylvia has been an active and willing Member of the Court of Common Council who applied her considerable skills and knowledge across the range of the City Corporation's activities, including long tenures on the Finance, Planning and Transportation, Establishment, Culture, Heritage and Libraries, and Epping Forest and Commons Committees, in addition to her invaluable work with our schools and on other committees. The many ways in which Sylvia contributed were rightly recognised when she was awarded an MBE in 2018, for her service to the City of London Corporation and to education in Croydon.

In taking its leave of her, this Honourable Court therefore extends to Sylvia its sincerest thanks and deepest appreciation for her hard work and many achievements over the past twenty years, as well as its very best wishes for the future.

12. Petition

The Court received a petition submitted by Mark Bostock pursuant to Standing Order No.20, relative to the City Corporation's planning processes.

A number of Members took the opportunity to ask questions of the presenter of the petition, in the interest of obtaining clarity. The following points arose through this process:-

• In response to a query, the Petitioner suggested that, should the City

Corporation ignore the petition and residents' strongly held views, it would see further concerted action from them such as was witnessed through the recent standards issues and proposed City of London School for Girls expansion project. Given its local authority role and responsibilities, the City Corporation would be wise to heed the views of its residents.

- A Member sought clarity as to whether the petition represented an objection to panels in principle, irrespective of format, or whether the objection was to their currently-mooted potential constitution and seeking to highlight that more attention needed to be paid to ensuring the resident voice was heard. The Petitioner advised that the petition articulated opposition to the introduction of panels in any form so as to avoid any corrosion of democratic accountability, which they suggested was already weak due to the anomaly of the business vote in the City.
- A Member asked if the Petitioner would accept that the Corporation should be representing the full and diverse range of the City's communities, including business, schools, and employees, all of which deserved equal representation. The Petitioner replied that this petition dealt with the interests of a significant proportion of the residential community and, as a Member of a residential Ward, they were very much guided by their electorate and felt their views need to be taken very seriously.
- In response to a request for specificity in respect of the proportion of the petition's signatories who were City residents, the Petitioner advised that of the 1270 signatures to date, around 50% were believed to be from City residents, so far as could be identified.
- A Member commented on the second paragraph of the petition, which called for Members of committees responsible for the Corporation's property interests to be prohibited from service on the Planning & Transportation Committee. They observed that nearly all service committees would have an involvement in property interests and sought clarity as to which committees would not be so affected.

Resolved – That the petition be referred to the Policy & Resources and Planning & Transportation Committees for consideration.

Covert Human Intelligence Sources (Criminal Conduct) Act 2021

The Act makes provision for the authorisation of criminal conduct by a covert human intelligence source (CHIS). It inserts new provisions into the Regulation of Investigatory Powers Act 2000 which enable officers of certain public authorities, including designated officers of the City of London Police, to grant a criminal conduct authorisation to a CHIS. The Act's substantive provisions will be brought into effect by regulations which have yet to be made.

Statutory Instruments

The Restriction of Public Sector Exit Payments (Revocation) Regulations 2021 No. 197

19 March 2021

These Regulations revoke the Restriction of Public Sector Exit Payments Regulations 2020, which imposed a cap of £95,000.00 on relevant exit payments by local authorities. Under these Regulations, where a local authority reduced the amount of an exit payment as a result of the operation of the cap, whether this was paid to a person or a relevant public sector scheme, it must pay an amount (including interest) such that the recipient of the capped payment is treated as if the cap had never applied. These

Regulations apply to the City of London Police and the Common Council in its capacity as a local authority, police authority or port health authority.

The Business Tenancies (Protection from Forfeiture: Relevant Period) (Coronavirus) (England) Regulations 2021 No. 283

30 March 2021

The Coronavirus Act provides that a right of re-entry or forfeiture under a relevant business tenancy for non-payment of rent, may not be enforced for a specified period. This period has been extended from its original end date of 30 June 2020 by a series of Regulations. These Regulations now extend the end of the period from 31 March 2021 to 30 June 2021.

The Coronavirus Act 2020 (Residential Tenancies: Protection from Eviction) (Amendment) (England) Regulations 2021 No. 284

30 March 2021

The Coronavirus Act 2020 provided that, during a specified period, landlords are required to provide at least three months' notice of intention to seek possession of housing let under a Rent Act 1977 protected or statutory tenancy, a secure tenancy, a flexible tenancy, an assured tenancy, an assured shorthold tenancy, an introductory tenancy or a demoted tenancy let by a local authority or housing action trust. Previous Regulations extended the end of the specified period from 30 September 2020 to 31 March 2021 and suspended the three months' notice requirement where the landlord is seeking possession on grounds related to anti-social behaviour. These Regulations extend the end of the specified period from 31 March to 31 May 2021.

The Public Health (Coronavirus) (Protection from Eviction) (England) (No. 2) (Amendment) Regulations 2021 No. 362

30 March 2021

These Regulations extend provisions in previous Coronavirus Regulations and prevent, except in specified circumstances, attendance at a dwelling-house for the purpose of executing a writ or warrant of possession or delivering a notice of eviction. The specified circumstances are where the court is satisfied that the claim is against trespassers who are persons unknown or where it was made wholly or partly on the grounds of anti-social behaviour, nuisance, domestic abuse in social tenancies, false statements, substantial rent arrears exceeding 6 months' rent or, in cases where the person attending is satisfied that the dwelling-house is unoccupied at the time of attendance, the death of the occupant. The amended Regulations will expire at the end of 31st May 2021.

The Health Protection (Coronavirus, Restrictions) (Steps) (England) Regulations 2021 No. 364

29 March 2021

These Regulations impose restrictions on gatherings and businesses in England, according to a system of three "Steps", in order to implement the Government's "roadmap out of lockdown" into law. The restrictions are at their most severe in Step 1 which, under the Regulations, currently applies to every area of England. The restrictions on businesses include the closure of certain businesses, and restrictions on the service of food and drink for consumption on the premises of a business. The Regulations also impose restrictions on leaving the United Kingdom without a reasonable excuse. The need for the restrictions in these Regulations must be reviewed by the Secretary of State every 35 days.

Report of the Independent Persons Appointment Panel Appointment of Independent Persons

To be presented on Thursday, 13th May 2021

To the Right Honourable The Lord Mayor, Aldermen and Commons of the City of London in Common Council assembled.

SUMMARY

Following the submission of Lord Lisvane's Review of the City Corporation's Governance in September 2020, a resolution of the Court of Common Council (8 October 2020) had the effect that consideration of aspects of the Review relating to the Standards Regime would need to be taken first and, as such, following extensive engagement with Members, the Court were able to consider and approve a number of proposals in relation to Standards made by Lord Lisvane at its 14 January 2021 meeting and authorised the Town Clerk to take such actions as were required to give effect to the decisions taken and facilitate their implementation.

One such action was around the recruitment and appointment of a panel of nine Independent Persons. It was agreed that an open and transparent recruitment process should be employed, with the Chair of Policy & Resources, the Chief Commoner, and the Chair of the General Purposes Committee of Aldermen (or their representatives) acting as an interview panel and empowered to put recommendations for appointment to the Court.

The purpose of this report is therefore to seek the Court's approval of the recommendations of that appointment panel, namely, to appoint the seven individuals named within this report as Independent Persons.

It should be noted that a further, second round of recruitment is now underway in order to appoint a further two Independent Persons and to ensure that the desired panel of nine individuals is achieved. A future report on any subsequent recommendations for appointment will be put to this Court in due course.

RECOMMENDATION

The Appointment Panel would be pleased to secure the valued services of Ms Miranda Carruthers-Watt, Mr Robert Coyle, Ms Christine Fraser, Mr Tom Ketteley, Ms Amanda Orchard, Mr Gary Rogers and Ms Atiyyah Younis and would, therefore, **recommend** their appointment as Independent Members of the City of London Corporation.

MAIN REPORT

Creation of an Independent Panel

- 1. Lord Lisvane's recommendations pertaining to Standards included a recommendation "that the Corporation should set up an Independent Panel composed only of independent persons, and charge that Panel with:
 - receiving allegations of misconduct referred to it by the Monitoring Officer;
 - deciding whether any allegation should be investigated;
 - on the basis of the allegation, determining whether there has been a breach of the code of Conduct;
 - reporting that determination, together with a full report of the facts, to the Court for endorsement;
 - hearing any appeal (the appeal function will of course need to be separated rigorously from the assessment and determination function)
 - after determination, and appeal if necessary, recommending an appropriate sanction, giving reasons, as necessary."

Process

- 2. This Court, at its 14 January 2021 meeting, endorsed this proposal as well as the adoption of Lisvane's recommendations in the form of a three-stage process, to be operated by the Independent Panel:
 - The first stage to be a more informal / conciliatory nature, seeking to resolve swiftly those issues which might be addressed through dispute resolution or a conversation and apology (with external dispute resolution advice to be made available to the Panel as it deems appropriate and a suitable protocol produced for such stage to be produced).
 - The second stage to then be the formal Hearing process, utilising the Independent Panel, as outlined by Lisvane (i.e. determination of investigation and breach and reporting to the Court of Common Council for endorsement).
 - The third stage to be the Appeal stage, the Panel for which should also include a minority of Members of the Court of Common Council, to help provide any relevant internal context.

It was decided that the Panel should be supported by the Comptroller & City Solicitor, as the Monitoring Officer, including in respect of the production of rules and procedures as time progresses, with clerking or administrative support also provided by the Town Clerk's department in the usual way.

Composition

3. This Court agreed with Lisvane's comments in relation to the need for a membership of sufficient size, to ensure that the sub-panels at the hearing and appeal stages could be comprised of entirely different Panel Members, although drawn from the same overall pool and directed that a panel of nine individuals, ought to be secured, utilising staggered terms to provide for both continuity and turnover.

Dispensations

- 4. Whilst distinct from the complaints process, the Court also reflected on the recent experiences concerning dispensations and the significant benefits of applications being determined independently. Consequently, it was agreed that responsibility for considering dispensations should also be granted to the new Independent Panel. It was noted, however, that responsibility for decision-making must legally remain with the Court of Common Council, or one of its committees, subcommittees, officers, or another local authority or joint committee; therefore, the Independent Panel could only make recommendations as to whether or not dispensations should be granted or refused. Your Court recommended, therefore, that authority be vested in the Town Clerk, on behalf of the Court of Common Council, to make determinations regarding applications for dispensations upon the recommendation of the Independent Panel (i.e. exercising a ratification function).
- 5. Further, it was observed that an urgent decision in respect of an application may be required from time-to-time, the timescales such that it was not possible for the Independent Panel to consider the application. To that end, it was recommended that the Comptroller and City Solicitor also be authorised to make determinations as to urgent applications, should they arise.

Recruitment and Appointment

6. It was agreed that an open and transparent recruitment process should be employed, with the Chair of Policy & Resources, the Chief Commoner, and the Chair of the General Purposes Committee of Aldermen (or their representatives) acting as an interview panel and empowered to put recommendations for appointment to the Court, with the Town Clerk authorised to advertise and undertake a recruitment process in consultation with the Chair of the Policy & Resources Committee, the Chief Commoner, and the Chair of the General Purposes Committee of Aldermen (or their nominated representatives).

Appointment Process

- 7. The appointment process for the new Independent Panel was commenced in February 2021 and ran until March 2021. Following discussion with the Appointment Panel, advertisements were placed on the City of London's webpages, in City AM online and also in the Law Gazette.
- 8. Applicants were informed that the City were seeking to appoint a panel of individuals with relevant experience in the private or public sectors and individuals who would both promote and maintain high standards of conduct by the Corporation's elected Members and co-opted Members when dealing with the business of the Corporation.

It was also made clear that an Independent Person cannot be someone who, at the time of appointment:

- has been a Member, Co-opted Member or officer of the City of London Corporation in the previous five years; or
- is a relative or close friend of a Member or officer of the City of London Corporation.

- 9. This Court was also supportive of remuneration for Independent Persons recommending the utilisation of the standard rate for public appointments, to help ensure strong candidates could be attracted and retained. The position was, therefore, advertised with a daily attendance allowance of £300 and reasonable travel expenses also reimbursed. Attendance depends on the number and complexity of cases to be dealt with as well as any necessary briefing and training sessions.
- 10. Following a shortlisting process and assessment by the Panel, seven candidates were shortlisted and invited to attend interview in April 2021.
- 11. The Panel were unanimously of the view that all seven of the candidates interviewed were particularly strong and that all would be a great asset to the City of London's Standards Regime in terms of the breadth and relevance of their knowledge and experience.
- 12. The purpose of this report is, therefore, to seek the Court's formal approval for the recommendations of the Appointment Panel – that seven candidates (Ms Miranda Carruthers-Watt, Mr Robert Coyle, Ms Christine Fraser, Mr Tom Ketteley, Ms Amanda Orchard, Mr Gary Rogers and Ms Atiyyah Younis) be appointed as Independent Persons.
- 13. The Committee on Standards in Public Life had recommended that Independent Persons be appointed for a fixed term of two years, renewable once. The Court considered this at their 14 January 2021 meeting and resolved that a fixed term of office of two years, renewable twice, be adopted for the City Corporation's Independent Persons. It was also felt that the terms of the Independent Persons should, ideally, be staggered.
- 14. As the Court has directed that a Panel of nine Independent Persons be recruited, and in line with the directive around staggered terms, we would therefore recommend that the Town Clerk is authorised to draw lots to ensure that five of the nine be appointed for an initial two year term and the remaining four for initial one year terms.

Details of Recommended Appointees

15. **Miranda Carruthers-Watt** qualified as a Solicitor in 1987 and is currently registered with the SRA as a Freelance Solicitor. She has over 30 year's experience in providing strategic leadership, legal advice, and senior management support to both the public and private sectors. She has an extensive governance and regulatory background and has been involved in the development and delivery of complex transformation projects and organisational change.

She has extensive experience delivering training on governance, strategy and transformational change at a local regional and national level. She has substantial experience as a Monitoring Officer in dealing with Standards matters and related complaints in Local Authorities, Police Authorities and relating to Policing and Police and Crime Commissioners. Since her retirement as the City

Solicitor and Monitoring Officer of Salford Council, she has built a non-executive portfolio, supporting local authorities with both strategic support and a focus on standards and governance matters.

16. Robert Coyle is an experienced Chartered Accountant and business executive, now building a portfolio of part time roles. As part of this he now works with organisations either in or closely connected to local government and is also heavily involved in issues of good governance. He is a Member of the Independent Remuneration Panel for Reigate & Banstead Council, he sits on the Board of a large multi academy trust – dealing a lot with both the DfE and Surrey County Council and is a NED/Audit Committee Member on various corporate entities. All this has built a strong interest in issues of how local government works, what it is trying to do and why it is important. In this context he has a good understanding of the demands and pressures placed upon those in public service.

He has over twenty-five years' experience of working in senior roles in the City – at Coopers & Lybrand/PwC, KPMG and Capita.

17. **Christine Fraser** is a law graduate, admitted solicitor and holds a current Practising Certificate. In recent years she has worked for a number of professional regulators and in areas of dispute resolution. She is currently working as an Ombudsman at the Financial Ombudsman Service. She has a wide range of experience at both senior management, board level, in dispute resolution and professional regulation.

She has held senior management roles, such as Head of Registration at the RCVS, where she was a member of the senior management team. She was also Town Clerk and Chief Financial Officer at a Town Council, so working as the Senior Executive Officer in a political environment. Her role as Town Clerk together with her earlier career in Local Government has provided a good understanding of the roles and work of Members of Council and issues that relate to this work. In more recent years, she has been involved in dispute resolution and is a panel member on the Referrals Panel at the SSRO.

18. **Tom Ketteley** is a Solicitor by profession. He was admitted to the profession in 2012. In 2016 he secured his Higher Rights of Audience enabling him to advocate in certain civil courts in England & Wales. He joined Bates Wells Braithwaite LLP in 2010 to complete his training. In 2012 he qualified into the firm's leading immigration department. In 2014 he moved to the Government Legal Department. He joined the Litigation Directorate where he advised the Home Office in connection with immigration judicial review proceedings and also statutory appeal proceedings in the Court of Appeal and Supreme Court.

In 2017, he transferred to the Home Office to design and introduce professional career development opportunities and oversee an operational legal team. He also holds operational responsibility for the multisite legal team which manages most of the complex cases that reach the Court of Appeal and Supreme Court.

He is also currently serving as an Independent Panel Member for the Greater London Authority, and has a track record in supporting fair, open and transparent recruitment processes at a senior level.

19. **Amanda Orchard** currently serves as an Independent Person at Kings Lynn Borough Council, a Lay Invited Review Member of the Royal College of Surgeons a Disciplinary Panel Member of England Netball and British Canoeing and is also a JP.

Her professional background is in marketing and communication where she has demonstrable experience, dealing with personnel at all levels, leading cross functional teams.

20. *Gary Rogers* has spent over 30 years dealing with, and conducting investigations into, complaints of a variety of allegations.

Throughout his career he has worked with the City of London in varying degrees, from assisting City of London Police in criminal investigations, undergoing training by the City of London Economic Crime Academy and assisting the Corporation of London in dealing with staff misconduct.

Mr Rogers was previously employed by Transport for London managing a team of 200 staff, dealing with misconduct, behavioural complaints and allegations, complaints from customers and also conducting criminal investigations into staff fraud and theft.

21. **Atiyyah Younis** has served as a member on the Independent Advisory Group to Bedfordshire Police for a number of years. She has worked in the City for several years and qualified as a solicitor in 2017. In her current role she works as a legal case manager for NHS Resolution in London defending the NHS against medical negligence claims.

In previous roles, she has gained ample experience working for Regulatory Bodies investigating high profile fitness to practise concerns relating to competence, misconduct and health. She has conducted numerous investigations involving large corporations and high-profile individuals.

Conclusion

22. The Appointment Panel mandated by this Court to oversee the recruitment of a panel of Independent Persons and put forward recommendations for appointment hereby recommend that the seven persons named within this report (Ms Miranda Carruthers-Watt, Mr Robert Coyle, Ms Christine Fraser, Mr Tom Ketteley, Ms Amanda Orchard, Mr Gary Rogers and Ms Atiyyah Younis) be appointed as Independent Persons of the City of London Corporation for initial terms of either one or two years so that appointments may be staggered in line with the wishes of this Court. It is recommended that authority be delegated to the Town Clerk to determine the varying terms of office for each Independent Person by drawing lots.

All of which we submit to the judgement of this Honourable Court.

Report – City of London Police Authority Board Appointment of Independent External Member

To be presented on Thursday, 13th May 2021

To the Right Honourable The Lord Mayor, Aldermen and Commons of the City of London in Common Council assembled.

SUMMARY

The constitution of your City of London Police Authority Board allows for the recruitment of four external individuals (i.e. not Members of the Common Council) to the Board, through an open process. In August 2017, a selection panel recommended one candidate for appointment to the position – Andrew Lentin. Mr Lentin was subsequently appointed by the Court to the City of London Police Authority Board (then Police Committee) for a four-year term, commencing 21 September 2017.

Following the unanimous support of Members of the Police Authority Board, the Court's approval is now sought for the re-appointment of external member, Andrew Lentin, to the City of London Police Authority Board for a four-year term commencing 21 September 2021.

RECOMMENDATION

The Court of Common Council is **recommended** to approve the re-appointment of Andrew Lentin to the City of London Police Authority Board for a four-year term, commencing on 21 September 2021.

MAIN REPORT

Background

- 1. The constitution of your City of London Police Authority Board now allows for the recruitment of four external individuals (i.e. not Members of the Common Council) onto the Committee, through an open process.
- 2. Andrew Lentin was appointed to a vacancy on the Board in September 2017 for this first term. Effective from April 2021, the Court approved a maximum continuous service limit of three terms of four years. Mr Lentin is therefore eligible to stand for a further two terms. After four-years of dedicated service to the Police Authority, including leadership on behalf of the Authority in the Force's Transform programme, Members of the Board unanimously agreed to recommend Andrew for re-appointment.

Proposal

3. It is proposed that the Court of Common Council be asked to appoint Andrew Lentin to the City of London Police Authority Board for a further term of four-years commencing 21 September 2021.

Conclusion

4. In agreeing to the recommendation of this report, and approving the appointment of an external Member to the City of London Police Authority Board, the Court of Common Council will enable the Board to fill a forthcoming vacancy, and to continue to benefit from the insight and expertise of a candidate that has valuable knowledge of the City, working with the community, businesses and public service bodies.

Report – Hospitality Working Party of the Policy and Resources Committee

Applications for Hospitality

To be presented on Thursday, 13th May 2021

To the Right Honourable the Lord Mayor, Aldermen and Commons of the City of London in Common Council assembled.

(a) Emergency Services Day Flag Raising 2021

It is proposed that the City Corporation hosts a flag raising and breakfast reception on Thursday 9th September 2021 to mark Emergency Services Day. Emergency Services Day is a nationally recognized annual event to show public support for those who work and volunteer in the emergency services.

The event would support Corporate Plan outcomes: to prepare our response to natural and man-made threats (outcome 1a); to tackle terrorism, violent and acquisitive crime, fraud, cyber-crime and anti-social behaviour and facilitate justice (outcome 1b); to protect consumers and users of buildings, streets and public spaces (outcome 1c); and to safeguard children, young people and adults at risk (outcome 1d).

It is **recommended** that hospitality be granted for a flag-raising ceremony followed by light refreshments and that arrangements are made under the auspices of the Hospitality Working Party; the costs to be met from City's Cash within agreed parameters.

(b) Reverend Canon David Parrott Retirement Reception

It is proposed that the City Corporation hosts a late afternoon reception in the Old Library in Autumn 2021 to mark the retirement of the Reverend Canon David Parrott.

The Reverend Canon David Parrott will retire as Guild Vicar of St Lawrence Jewry Church this autumn. He was appointed in 2009 and throughout his tenure in office has played an active role in the City and supported both the City Corporation and Livery. In recognition of his service, it is proposed a reception be held to mark his retirement.

The event would support Corporate Plan outcomes: to provide access to world-class heritage, culture and learning to people of all ages, abilities and backgrounds (outcome 3b); to bring together individuals and communities to share experiences and promote wellbeing, mutual respect and tolerance (outcome 4a); and to advocate and facilitate greater levels of giving time, skills, knowledge, advice and money (outcome 5d).

It is **recommended** that hospitality be granted and that arrangements are made under the auspices of the Hospitality Working Party; the costs to be met from City's Cash within agreed parameters.

(c) Launch of EY report on the impact of major sporting events on soft power, trade and investment.

It is proposed that the City Corporation hosts a presentation and panel discussion on Wednesday 9th June 2021 to launch the EY report on the impact of major sporting events on soft power, trade and investment. The intention would be for the event to be delivered in a hybrid (in person and virtual) format.

In November 2020, the City Corporation commissioned EY to carry out a study to analyse how major sporting events can produce soft power, trade and investment benefits. A key aim of the report was to make recommendations about how such events might be better harnessed in the future by Government, business and event organisers.

The event would support Corporate Plan outcomes: to strengthen local, regional, national and international relationships to secure new opportunities for business, collaboration and innovation (outcome 7b); to preserve and promote the City as the world-leading global centre for financial and professional services, commerce and culture (outcome 7c); and to protect, curate and promote world-class heritage assets, cultural experiences and events (outcome 10d).

It is **recommended** that hospitality be granted and that arrangements are made under the auspices of the Policy and Resources Committee; the costs to be met from City's Cash within agreed parameters.

(d) The Royal Hospital of St Bartholomew – 900th Anniversary reception

It is proposed that the City Corporation hosts an early evening reception at Guildhall on Wednesday 10th May 2021 following a service at St Paul's Cathedral to celebrate the 900th Anniversary of the Royal Hospital of St Bartholomew.

The Event would support Corporate Plan outcomes: that people enjoy good health and wellbeing (outcome 2); bring people, individuals and communities together to share experiences and promote wellbeing, mutual respect and tolerance (outcome 4a); and contribute to protecting, curating and promoting world-class heritage assets, cultural experiences and events (outcome 10d).

It is **recommended** that hospitality be granted and that arrangements are made under the auspices of the Hospitality Working Party; the costs to be met from City's Cash within agreed parameters.

To the Right Honourable The Lord Mayor, Aldermen and Commons of the City of London in Common Council assembled.

SUMMARY

The City of London Policing Plan 2020-23 informs the community, stakeholders and staff how the City area is to be policed. The Force and Court of Common Council (in its capacity as a police authority) are required to continue to publish a policing plan by the Police Act 1996 due to being exempt from the legislative requirement to publish a police and crime plan.

Policing plans must have regard to any national strategic policing priorities stipulated by the Home Secretary. Such priorities are currently articulated by the Strategic Policing Requirement; the Force's approach to this appears in the Plan. Additionally, the Plan takes account of Government policy statements regarding reducing crime, addressing antisocial behaviours, supporting the vulnerable, accountability and value for money.

The original 2020-23 Plan was approved by the Police Authority Board in March 2020, but there is a requirement to review and republish the Plan annually. In order to inform this year's version, wide ranging consultation was undertaken, including a Court of Common Council Member Briefing held on 8 March 2021, and the annual community survey. The Plan was refreshed in response to this consultation and approved by the Police Authority Board in March 2021 and is hereby submitted to the Court for information.

Measures introduced into Parliament which may have an effect on the work and services provided by the City Corporation

<u>Bills</u> <u>Date in force</u>

Non-Domestic Rating (Lists) Act 2021 c. 8

15th March 2021

This Act sets the date of the next business rate revaluation at 1 April 2023 and moves the latest date for publishing the draft rating list from 30 September to 31 December in the year preceding the revaluation.

Statutory Instruments

The Corporate Insolvency and Governance Act 2020 (Coronavirus) (Change of Expiry Date) Regulations 2021 No. 441

1st April 2021

Section 20 of the Corporate Insolvency and Governance Act 2020 (the 2020 Act) grants the Secretary of State powers to amend or modify the effect of specified corporate insolvency or governance legislation in Great Britain by Regulations. Under the 2020 Act, the power to make Regulations under section 20 was due to expire on 30 April 2021. These Regulations substitute the date so that Regulations made using that power may not be made after 29th April 2022.

The Health Protection (Coronavirus, Restrictions) (Steps and Local Authority Enforcement Powers) (England) (Amendment) Regulations 2021 No. 455

12th April 2021

These Regulations amend the Health Protection (Coronavirus, Restrictions) (Steps) (England) Regulations 2021, to relax Coronavirus restrictions by moving England from the Step 1 area to the Step 2 area. The change took effect on 12th April 2021. The Regulations also make minor amendments to the definition of "linked household" and clarify that customers may enter premises serving alcohol to pay for their food and drink, in addition to other minor amendments.

The Town and Country Planning (General Permitted Development) (England) (Amendment) (Coronavirus) Order 2021 No. 467

16th April 2021

This Order amends the Town and Country Planning (General Permitted Development) (England) Order 2015 (GPDO). The GPDO provides for the granting of permission for certain classes of development without the requirement for a planning application to be made. This Order is intended to support hospitality businesses and historic visitor attractions to utilise outdoor space as coronavirus restrictions are lifted, by introducing a new temporary permitted development right in force from 16 April 2021 until 1 January 2022 to allow, subject to specified limitations and restrictions, for the provision of moveable structures on land within the curtilage of cafes, restaurants and drinking establishments including where these are listed buildings, and historic visitor attractions only where they are listed buildings.

The Town and Country Planning (Consultation) (England) Direction 2021

21 April 2021

This Direction replaces The Town and Country Planning (Consultation) (England) Direction 2009 and requires local planning authorities in England to consult the Secretary of State before granting planning permission for Green Belt development, development outside town centres, World Heritage Site development, playing field development, flood risk area development or commemorative object development, where the application is received on or after 21 April 2021.
