Background

An increased budget for the City of London Police IT modernisation programme was requested in order to facilitate accelerated delivery of the programme in light of COVID-19. Background

The Gateway 1/2/3/4 report for the City of London School for Girls Summer Works 2020 was approved by Projects Sub-Committee in January 2020 and the Board of Governors of the City of London School in March 2020. The project was subsequently affected by the outbreak of COVID-19 which led to slippage in the project. In light of this a revised list of works was drawn up for delivery during Summer 2020. Urgency procedure was utilised to ensure works could be delivered during Summer 2020.

Action Taken

The Town Clerk, in consultation with the Chairmen and Deputy Chairmen of the Board of Governors of the City of London School for Girls and the Projects Sub-Committee,

- Approved an additional budget for works and consultant fees to reach the next Project Gateway.
- Approved the placement of orders for works packages.
