Summary

The City of London Corporation has received confirmation that the start date for the process of filling the vacancy at St Lawrence Jewry is 31 January 2022. The City Corporation as registered patron of the Guld Vicarage of St Lawrence Jewry, has the right to fill the vacancy, and must appoint a representative to discharge these functions.

Recommendation(s)

Members are asked to:

1) appoint the Chairman to act as the patron's representative during the vacancy.

Main Report

- 1. The City of London Corporation received notice on 28 January 2022 that the Guild Vicarage of St Lawrence Jewry had become vacant on 31 October 2021 by the resignation of the Reverend David Wesley Parrott.
- 2. The Bishop of London has stipulated that the start date for the process of filling the vacancy will be 31 January 2022.
- 3. As Patron, the City Corporation must appoint an individual as its representative and discharge its functions as registered patron. This individual must be able and willing to make a declaration that they are a communicant member of the Church of England (or a Church in communion with it).
- 4. As stated in the Sub-Committee's Terms of Reference, the Chairman of the Sub-Committee is usually appointed as the City Corporation's representative, and it is proposed to continue with this precedent.
- 5. The Chairman is a communicant member of the Church of England, Deputy Chancellor of several Diocese and is appointed to the Panel of Chairs for Bishops' Disciplinary Tribunals. He has confirmed he is willing to serve in this role.

Summary:

This report provides details of a decision taken under urgency since your last meeting in consultation with the Chairman and Deputy Chairman, in accordance with Standing Order No. 41(a).

Main Report

Request for Decision Under Urgency (Standing Order 41A) – 1. Proposed Suspension of Presentation at St Albans with St Augustine, Fulham

- The City of London Corporation, in its role as patron of St Alban with St Augustine, Fulham, received a letter from Kensington Area Council of the Diocese of London advising of a proposal to suspend the right of presentation to the benefice for up to 5 years. The Bishop of London intends to work with the PCC to look at alternative ways of providing appropriate ministries to the parish.
- 2. As required under section 85 of the Mission and Pastoral Measure 2011, the Church must consult with interested parties. The consultation has two parts: seeking the views of interested parties, and giving the registered patron the option of consulting with the Bishop or his representative.
- The deadline for responses to the consultation did not fall within the Committee's meeting schedule. The Sub Committee were, therefore, consulted via email to seek their views, so as to inform any decision to be taken under urgency procedures.

- 4. Members indicated that they did not have objections to the proposal, but asked for responses to a number of questions. Responses to these questions were subsequently received and circulated to the Sub Committee.
- 5. The Town Clerk therefore agreed, in consultation with the Chair and Deputy Chair of your Committee, the City Corporation's response to the diocese and to a meeting taking place between the Bishop's representatives and the Chairman of the Benefices Sub-Committee (as provided for within section 85 of the Mission and Pastoral Measure 2011).
- 6. Confirmation of the suspension of presentation was subsequently received and circulated to Members of the Sub-Committee.
