- **Keaveny:** Throughout Vincent's year, he has rigorously championed his Mayoral Theme, People and Purpose. This has been at the centre of his year and also led to the launch of Progress Together, seeking to create a financial services sector in the United Kingdom in which everyone working in it, from all socio-economic backgrounds, is both enabled and has the opportunity to achieve their full potential.

Hailing from Dublin, Vincent has served as the 693rd Lord Mayor, and has been the first Irishman to take up this mantle. Fortunately, his Mayoral year has seen the return of so many of our customary events, and so many of our traditions coming back to life, starting of course with the Lord Mayor's Show. Many banquets, dinners and summits were held for the first time in several years and the Lord Mayor's extensive travel, taking in Europe, North and South America, and Asia have enabled him to fly the flag for UK financial and professional services, and to make valuable new connections as well as strengthening old ones, in person once more.

Vincent has also worked ceaselessly here at home, successfully promoting and

strengthening the City's relationship with cities and economic centres outside of London, where two-thirds of the country's financial services are based. The Lord Mayor has hosted many important occasions in Guildhall and Mansion House, including the Net Zero Delivery Summit, attended by the then Prime Minister and the Finance For Impact Summit. I know these special, significant occasions both at home and further afield will have left Vincent with many cherished memories and a rightful sense of pride.

You might think that there are not many opportunities to do things that are truly unprecedented and unique being the latest in the long line of almost 700 hundred Lord Mayors but Vincent's has been a Mayoralty undoubtedly touched by history. Firstly, he had the great honour of welcoming the Royal Family to Guildhall this summer as part of the City's celebrations of Her Late Majesty's Platinum Jubilee - a truly historic and special experience the likes of which we have not seen before and will likely never see again.

Sadly, just a few months later, he then had the solemn duty of taking part in the accession council for His Majesty the King, the City proclamation on the steps of the Royal Exchange, and the state funeral.

During this very busy year, Vincent has been fortunate to receive unending support in all endeavours from the Lady Mayoress, Amanda, whose efforts helped to ensure that the Lord Mayor's year was a success. As the Mayoral year draws to a close, the Court of Aldermen unite in thanking Vincent for all that he has done as Lord Mayor of the City of London and send to him, Amanda, and of course India, their very best wishes for their future good health and happiness.

Resolutions of thanks – The Town Clerk & Chief Resolved Unanimously:- That, on the occasion of his retirement, Members of this Court take great pleasure in conveying to John Barradell OBE their gratitude and sincere appreciation for the distinguished manner in which he has carried out the role of Town Clerk and Chief Executive of the City of London Corporation over the past decade.

Executive

John joined the Corporation in 2012, appointed as the City's 50th Town Clerk since 1274. Over the course of the past decade, his stewardship has included a plethora of significant and indeed historic events.

Having extensive experience and networks in the resilience and emergency management fields, he was key to leading the response to the COVID pandemic, not only within the City but Pan-London and also headed up work on the Government Grenfell Recovery Taskforce. John went on to play a key role in the Grenfell Inquiry and, as Deputy Chair of the London Resilience Partnership, regularly brings together all relevant agencies, private and public, to ensure that the City is planning for, well-prepared and able to respond to disruptive events.

John's tenure has also allowed for much celebration and pageantry. John has attended numerous Lord Mayors Banquets, the most recent of these taking place just last week, multiple State Banquets and was also fortunate enough to play a key role in not one but two Royal Jubilee celebrations – the likes of which many are

unlikely to ever witness again. More sombrely of course, John also joined this Court in the Proclamation of our new King on the steps of the Royal Exchange and represented the City at the funeral of her late Majesty, Queen Elizabeth the Second.

Closer to home, John has successfully overseen the agreement of a number of Major Projects that will radically alter what the City is and does for the coming century, enabling us to be more agile, responsive and able to make the best use of our resources to create a vibrant and thriving City, supporting a diverse and sustainable London. These include the agreement of the new state-of-the-art combined Courts and Police Headquarters building on Fleet Street, agreement for the relocation of two of the City's historic Markets to a purpose-built site in Dagenham Dock and the relocation of the Museum of London to West Smithfield.

John has also overseen enormous changes to the City's built environment and streetscape during his time in office with increased pedestrianisation, on-street greening and the opening of the new Elizabeth Line – all key components in terms of making the City a more desirable spot for residents, workers and visitors alike.

Internally, John has overseen the smooth transition between multiple changes in political leadership within the organisation as well as the introduction of a new and diverse Senior Leadership Team at the City to ensure the future of the organisation – one which is agile and responsive.

It's fair to say that John has a possibly unique range of experience across private, public and volunteer leadership roles and will be keenly missed here at the City. In thanking him for his most distinguished service, his dedication and professionalism, the Court wishes to express to both him, Maggie and their daughters their sincere wishes for a lengthy, happy and healthy retirement.
