That as the proposed Constitution and Ordinances conform to the law and custom of the City, the Company of Nurses be constituted a Livery Company of the City with the title "The Worshipful Company of Nurses," that the formal grant be embodied in Letters Patent under the Mayoralty Seal and that the proposed Constitution and Ordinances be approved and enrolled among the records of the Court of Aldermen as the 111th Livery Company of the City.
