its warmest thanks for the exemplary manner in which he has carried out the role of Lord Mayor of this City. Nicholas' Mayoralty came immediately after his year as Sheriff and the Court of Aldermen take the greatest of pleasure in having this opportunity to acknowledge the sheer energy and commitment that this requires as well as the fact that the Lord Mayor has, at all times, performed the duties of this office with dignity, enthusiasm and great skill.

Throughout Nicholas' year, he has rigorously championed his Mayoral Theme, *Financing our Future* promoting a resilient, resourceful and responsible city, deploying capital and expertise to supercharge economic growth nationwide and grow our global competitiveness. This has been at the centre of his year and has encompassed a great range of initiatives. Particular mention must be made of the Mansion House Compact where, having worked closely with the Chancellor of the Exchequer, Nicholas was able to convene at the Mansion House nine major U.K. companies who committed to a key target which, once achieved, will unlock over £50 billion of capital by 2030, in turn helping high-growth U.K. companies in fintech,

life sciences, biotech and clean energy to scale-up domestically – an incredible and far-reaching accomplishment.

Nicholas has served as the City of London's 694th Lord Mayor. Fortunately, his Mayoral year has been the first of many to be untouched by any travel restrictions and he has certainly capitalised on this in his extensive travels both home and abroad to destinations such as the US, China, India, Japan, Australia, Singapore, Hong Kong and the Gulf. These visits have enabled him to meet with an enormous range of people and, in doing so, to fly the flag for UK financial and professional services and to further the City's cause.

Nicholas has also worked tirelessly here at home, successfully promoting and strengthening the City's relationship with cities and economic centres outside of London. In April, the Lord Mayor demonstrated his passion for inclusion by hosting a Financial Literacy and Inclusion Summit, bringing together speakers and panellists, including the Minister for Financial Inclusion, from across financial services, education and the charitable sector. As a result, he established a Financial Literacy and Inclusion Steering Group of leaders and experts to help the 13 million people in the U.K. who have been identified with low financial resilience. Following this, in May, the Lord Mayor hosted the City's Net Zero Delivery Summit, attended in person by 200 leaders in climate finance and with a further 2,600 participants taking part virtually. I hope that these key, significant occasions both at home and further afield will have left Nicholas with many cherished memories and a rightful sense of pride.

You might think that there are not many opportunities to do things that are truly unique being the latest in the long line of almost 700 hundred Lord Mayors but Nicholas' has been another Mayoralty undoubtedly touched by history. He had the great honour of being the first Lord Mayor in over 70 years to take part in a Coronation where he was called upon to play an important part, attired in the Lord Mayor's Coronation robes and carrying the historic Crystal Sceptre as he proudly represented the City once more on the world's stage. More recently, Nicholas was the first Lord Mayor to host His Majesty King Charles III at Mansion House.

During this very busy year, Nicholas has been fortunate to receive unending support in all endeavours from the Lady Mayoress, Felicity, whose efforts helped to ensure that the Lord Mayor's year was a real success. As the Mayoral year draws to a close, the Court of Aldermen unite in thanking Nicholas for all that he has done as Lord Mayor of the City of London and send to him, Felicity, and their wider family, their very best wishes for their future good health and happiness.

their gratitude and sincere appreciation for the distinguished manner in which he has carried out the role of Remembrancer of the City of London over the past twenty years.

Paul first joined the Corporation in 1985 as Counsel to the City Remembrancer. He was Assistant Remembrancer 1994-1998 and Director of the Office from 1998-2003. He was elected as the City's 45th Remembrancer in July 2002 and took office the following January. Over the course of the past two decades, his stewardship of this unique and ancient role has covered a plethora of significant and indeed historic events.. The City Remembrancer is the official channel of communication between the City, the Royal Households, Parliament and the London Diplomatic Corps – something that Paul has fulfilled with great professionalism, level-headedness but also good humour and kindness.

Paul studied at the Universities of Bristol and Aston, and at University College, London. He was called to the Bar by Middle Temple in 1981 and became a Bencher in 2017. Paul has been a Freeman of the City of London since 1985. Between 1983 and 1997 he was a visiting lecturer for London University's undergraduate law programmes. He became the City's Parliamentary Agent in 2004 and has served as consulting editor for Halsbury's Laws of England on London Government and, as an active member of the Financial Markets Law Committee, has developed strong and enduring links with the legal sector.

Paul's time at the Corporation has spanned thirty-eight Lord Mayors, nine UK Prime Ministers and two Monarchs – a period, therefore, of much change. There is scarcely any part of the Corporation that hasn't benefitted from legislative change during Paul's time at Guildhall but perhaps one of his greatest achievements was the City of London (Ward Elections) Act 2002 which extended the franchise for City elections. Paul will also have a continuing role to play in the promotion of the City of London (Markets) Bill that is currently making its way through the House of Commons. Also notable among Paul's achievements during his time here was his directorship of the Global Law Summit held in London in 2015 to coincide with the 800th anniversary of the sealing of Magna Carta – the very document that enshrined the City of London's already-ancient liberties.

Paul's tenure has also seen much celebration and pageantry. Paul has overseen numerous Lord Mayor's Shows and Lord Mayor's Banquets, multiple State Banquets and many other occasions that have put the City of London on centre stage nationally and internationally. Under Paul's direction, the City Corporation celebrated Her Late Majesty's 80th and 90th Birthdays and played its joyous part in the Diamond and Platinum Jubilees. More sombrely of course, Paul joined this Court in the Proclamation of our new King on the steps of the Royal Exchange. Paul's appointment as a Commander in the Royal Victorian Order this year, following his earlier appointment as a Lieutenant of the same Order in 2012, illustrates the esteem in which he is held. This Court owes Paul a debt of gratitude for his dedication to strengthening this City's links with the Royal Household and the Diplomatic Corps.

The Aldermen very much welcome this opportunity to pay a personal and sincere tribute to Paul for his significant contribution to the work of this Court, his wise counsel and for the extremely capable way in which he has carried out the role of City Remembrancer over the past twenty years. They warmly express the hope that he will enjoy a long and happy retirement and, with his wife Glynis and their

wider family, will have fond memories of his time spent with the City of London Corporation.

The Voluntary Hospital of St Bartholomew

The Court of Aldermen considered recommendations of its General Purposes Committee of Aldermen relative to a governance review undertaken by The Voluntary Hospital of St Bartholomew charity and noted that the Board of Governors of this charity were now pursuing a restructure to update its constitution, governance and charitable purposes, and to address some governance complexities.

It was highlighted that the changes are intended to be made by a Charity Commission Scheme and will result in the establishment of a new charity with modern governance. As the changes affect the City Corporation's historic connection to the charity, including its historic Trustee appointments rights, the

charity is required by the Charity Commission to consult with the City Corporation to ensure that there are no objections to their proposals.

Resolved: - That the court of Aldermen:

- (a) endorse the proposed restructure, subject to the City Corporation being granted a right to nominate to the board of trustees of the new charity a suitably qualified Member of the Court of Common Council to serve as a trustee; and
- (b) delegated authority to the Town Clerk, in consultation with the Chairman and Deputy Chairman of the Policy and Resources Committee and the Chairman of the General Purposes Committee of Aldermen, to take any further actions or decisions necessary to implement the decision.
