### **1. APOLOGIES**

Apologies for absence were received from Matthew Frith (London Wildlife Trust) and Merlin Fox (Heath Hands). Karin Oleinkova was in attendance for Heath Hands.

### **2. DECLARATIONS BY MEMBERS OF ANY PERSONAL AND PREJUDICIAL INTERESTS IN RESPECT OF ITEMS ON THIS AGENDA**

There were none.

### **3. MINUTES**

The Committee considered the minutes of the previous meeting of the Consultative Committee, held on 24 January 2022.

A Member (Friends of Kenwood) suggested that the final sentence in item 12 be corrected to read 'should *not* be sited on the Heath'.

RESOLVED, that – the minutes of the Hampstead Heath Consultative Committee held on 24 January 2022 be agreed as a correct record, as corrected.

#### MATTERS ARISING:

A Member (London Council for Sport and Recreation) suggested that the style of minutes should reflect that Members were giving views rather than asking questions. They also requested that the name of the body the Members were representing be included in the minutes, as had been the previous practice.

A Member (Hampstead Rugby Club) raised concerns about the format of the Wellbeing Forum. They felt that the change from the Sports Forum to the Wellbeing Forum could lose the voice of the Clubs . The Chair suggested that the Committee continue to monitor the Forum's performance.

#### 4. **HAMPSTEAD HEATH, HIGHGATE WOOD & QUEEN'S PARK COMMITTEE DRAFT MINUTES**

Members noted the draft minutes of the Hampstead Heath, Highgate Wood & Queen's Park Committee meetings held on 9 February and 4 May 2022.

#### MATTERS ARISING:

A Member (London Council for Sport and Recreation) expressed their concern that the current timetable to the developments being carried out on the Parliament Hill Athletics Track would risk the loss of the entire 2024 athletics season. They asked if the timetable if the project team could consider moving the timetable forward by a couple of months to allow more flexibility and reduce the risk. They also suggested that it would be helpful if future works after the project could be included in the cyclical maintenance programme, or have a reserve fund developed, rather than having it return as a major project each time. Officers replied that preventative maintenance through cyclical works are preferred from reactive maintenance, but there is a limited budget for assets and infrastructure and a priority system is in place. The Assistant Director said that the upcoming investment in the athletics track would hopefully allow for better resilience in the future. The Gateway 2 Report was going to the Operational Property and Projects Sub Committee for approval on Monday 30 May. This was the final step in drawing down the funds for the project. Once this approved, officers would consult with the City Surveyor's Department on procuring the design team and reviewing the programme. A Member (Representative of Clubs using facilities on the Heath) said that the Representatives were a distance away from understanding the procurement timetable and programme of works, and that once out to tender contractors might come back with their own preferences. They agreed that it was vital to

avoid losing the athletics season and that once there was greater clarity on the project, they would welcome further discussions on how to minimise disruption.

## 5. **ASSISTANT DIRECTOR'S UPDATE**

Members received a report of the Executive Director, Environment, providing the Assistant Director's Update.

### **Night of 10,000 PBs**

A Member (London Council for Sport and Recreation) said that the Heath should be considering how to build on this event, particularly with the forthcoming resurfacing of the Parliament Hill Athletics Track. They suggested that further events should look into the possibility of sponsorship.

### **Constabulary**

A review of the constabulary was carried out to respond to the changes brought by the pandemic with the aim of having a more effective and responsive service that is guided by data. A Member ((London Council for Sport and Recreation) commented that it was important to make sure that there was a Constabulary presence by the Model Boating Pond over the summer, as this was a popular spot for unauthorised swimming and barbecues.

### **Placards**

A Member (Highgate Conservation Area Advisory Committee) raised the issue of the number of signs on the Heath, and said that it was important that the vision of the Heath as a piece of countryside in London was not abandoned. They gave the example of signage at the Kenwood Ladies' Bathing Pond. In reply, the Assistant Director said that signage was due to be included in the Swimming Review, and invited the Member to contact her with other examples of signage and issues encountered on the Heath.

## 5.1 **Draft Divisional Plan 2022-25**

A Member (Heath & Hampstead Society) said that they were pleased that archaeological interpretations were going to be included, and suggested that some of the projects can be listed to clarify the outcomes.. They said that there was a need to produce a full survey of known archaeological monuments across the Heath. They would also like to see a commitment to maintaining long-term ecological commitments. In regards to item 10, they hoped that they would be able to work with others on that item. With regards to item 14, they hoped that visitor engagement would be accompanied by a public information and communication programme.

The Assistant Director said the Natural Environment Department was conducting a wide survey and heritage audit at a Divisional level, which would help to develop appropriate plans. With regards to visitor engagement, this

would underpin new ways of working for Natural Environment, which was looking to conduct a more strategic approach.

A Member (Hampstead Garden Suburb Residents Association) asked for an update on fundraising. The Assistant Director replied that fundraising was one of a number of focused workstreams for how the Natural Environment Department could work strategically and joined up.

## **5.2 HomeRun App data**

A Member (Hampstead Conservation Area Advisory Committee) commented that the data set on journeys round the Heath from schools was taken from private schools rather than general schools local to the Heath. For private schools to expand, they need to have proposals for green ways for pupils to get to school. The Chair asked if any further data was expected. In reply, the Assistant Director said that this was the data that had been provided by the London Borough of Camden and she would feed back to Camden on possible further data from other schools.

A Member (Heath & Hampstead Society) expressed their view that the data was inadequate and was biased towards certain schools and socio-economic classes. They felt it should contain further information on all the schools neighbouring the Heath, and consider all the ways in which students travelled across the Heath.

A Member (London Council for Sports and Recreation) said that the scheme was a valid way to contribute towards the reduction of rush hour traffic.

## **5.3 Project on a Page (Swimming Capital Project)**

The Assistant Director reported in the progress of the ponds improvement programme. The engagement with users and stakeholders was completed and there has been an overwhelming support for the proposed improvements. The next stage will be to submit a planning application and, pending approval, works are due to start in the autumn.

## **5.4 Draft Swimming Annual Review 2021/22**

A Member (Hampstead Rugby Club) commented that they were pleased to see from the paper that the team had been reaching out to groups who might not normally use the facilities, and praised the staff for the job they were doing.

A Member (London Council for Sport and Recreation) asked if the income from 2021/22 covered the costs, when compared to the budget, and commented that swimming would always require a subsidy. In reply, an Officer said that the subsidy had decreased by 6% from the previous year, and that this exceeded the expectations in the budget.

A Member (Hampstead Garden Suburb Resident's Association) asked if the aim of ensuring that all customers pay for swimming had been successful. An



Officer replied that they had introduced methods and systems that will allow to monitor payments.

#### **5.5 Murphy's Yard Representation letter (February 2022)**

The Chair commented that, although the developer's had withdrawn the application, it seemed that development on the site was still likely, and said that it was important for the Committee to continue to monitor the impact potential development could have. A Member (Heath & Hampstead Society) said that the development was one of the largest proposed adjacent to the Heath for some time, and provided a chance to enhance the impact of the Heath's biodiversity on the local community.

#### **5.6 Biodiversity Interpretation Boards**

A Member (Friends of Kenwood) expressed their hope that the wording for the Summer Biodiversity Interpretation Board had been agreed. Officers confirmed that the summer boards will be ready to be installed shortly. They also asked for further clarification on the information on grazing livestock, as she was not aware of any plans to introduce grazing at Kenwood. A Member (Heath & Hampstead Society) replied to say that they were responsible for the statements, along with English Heritage. With regards to grazing, trialling had been carried out on Hampstead Heath using sheep, and there were plans to repeat this. Longhorn cattle were not being used, but were included on the Board to highlight historic methods.

### **6. PROPOSED SUSTAINABLE MANAGEMENT OF THE GOLDER'S HILL PARK ZOO**

Members received a report of the Executive Director, Environment relative to the proposed sustainable management at Golder's Hill Park Zoo.

A Member (Heath & Hampstead Society) said that the direction being taken by the Zoo was a good one, as was a strong case for a zoo focused on a conservation and education remit rather than putting wild animals in cages. They said that they hoped that the report author could make it clear that, during the transitional period, the Zoo had a duty of care to the exotic animals in its collection. An Officer replied that as part of the Licences Act, the Zoo was required to have an ethics committee. This committee meets twice a year and its members have substantial experience. All decisions on stock management go through the committee.

A Member (Hampstead Rugby Club) asked if there were any plans on concessions for the zoo experiences to engage people who otherwise could not afford them. An Officer replied that there was a volunteering programme open to everyone that will allow participation no matter the backgrounds. .

RESOLVED, that – Members of the Hampstead Heath Consultative Committee provide feedback on the preferred option and ancillary plans to include the change of use of the Butterfly House and the income generation options.

7. **WEDDINGS AND CIVIL CEREMONIES - ASSISTANT DIRECTORS UPDATE**

Members received a report of the Executive Director, Environment, relative to the Assistant Director's update on the hosting of weddings and civil ceremonies on Hampstead Heath.

A Member (South End Green Association) expressed concern about the number of weddings to be organised, as they did not want to see the pergola frequently closed to accommodate these.. In reply, an Officer said that the main issues would be keeping the capacity and frequency of events in balance.

A Member (Friends of Kenwood) asked for further information on the costs of weddings and the revenue they brought in, and for clarification on the maximum capacity for weddings. An officer confirmed that capacity was capped at 120 guests at the pergola. With regards to the financial elements, the fees and charges is information in the public arena, and ranges depending on the type of wedding. These will be reviewed with the contractor according to market. With regards to revenue, this was commercially sensitive information.

A Member (Hampstead Conservation Area Advisory Committee) suggested that thought should be put in to creative ways to increase revenue when the contracts were put out for procurement and ideas such as for example sponsorship from the couples could be considered

RESOLVED, that - Members provide feedback in relation to the proposal set out in para 12 of the report.

8. **HEATH HANDS UPDATE**

Members received an update from Heath Hands.

A Member (London Council for Sport and Recreation) congratulated the fficer and said that Heath Hands were doing superb work, in particular on their Health and Wellbeing agenda.

9. **QUESTIONS**

A Member (Highgate Society) referred to the mention in the Assistant Director's update report of the research conducted by the University of Exeter which listed the Heath in the top four most valuable recreation sites in the Country, and said that this should be given further publicity.

In reply to a question from a Member (Hampstead Rugby Club), an Officer said that they were aware of continuing issues with night fishing and they were working with all parties to ensure that the behaviours don't continue.

10. **ANY OTHER BUSINESS THAT THE CHAIRMAN CONSIDERS URGENT**

The Assistant Director provided Members with an update on dog licences. Members heard that the scheme introduced in 2020 had set a cap of 70 licences. 89 applications had been received, and there was an issue with a possible appeal on how the cap had been identified. The appeal process is complicated, and the Assistant Director said they would prepare a paper for

review by the Management Committee which will focus more on targeted intervention and an holistic approach rather than focusing just on numbers of commercial dog walking businesses. They said that the information provided by licences could be used to ensure there was a proactive approach to mitigating the impact of dog walkers on sensitive areas of the Heath.

A Member (Heath & Hampstead Society) asked if all the received applications would now be accepted, as this might make it harder to potentially reduce numbers in future. The also noted that there was anecdotal evidence that dog owners have doubled during the pandemic and that pressures from dog walking have increased on the Heath. The Assistant director noted this and stated that it is even more important to consider an holistic approach focusing on the sensitive areas rather than just numbers. Another Member (Hampstead Conservation Area Advisory Committee) said that the issue with high numbers of dogs under the control of one walker was the amount of faeces that resulted from their presence on the Heath, as it was difficult for walkers to clear up after too many dogs.

Two Members (representing the London Council for Sport and Recreation and the Hampstead Garden Suburb Resident's Association) felt that it would have been useful to know the criteria for the setting the cap at 70 licences.

#### **11. DATE OF NEXT MEETING**

The Chair commented that he felt that the hybrid method of holding meetings was valuable, but that he would continue to think on the best manner of holding them.

The Chair announced that it was Simon Taylor's last meeting as a representative of Hampstead Rugby Club, having participated in the Committee for nine years. The Chair and the Committee thanked Simon for his contributions. Simon Taylor thanked fellow Members for all they brought to the Committee.

The Chairman welcomed to the Committee those Members newly elected and thanked those Members attending the meeting in person, who were to be elected by the Court of Common Council on the 16th. In addition those Members who had stood down were thanked for their time on the Committee.

### **2. MEMBERS DECLARATIONS UNDER THE CODE OF CONDUCT IN RESPECT OF ITEMS ON THIS AGENDA**

### **3. MINUTES**

The Committee considered the public minutes and non-public summary of the meeting held on 4 May 2022.

RESOLVED - That the public minutes of the Hampstead Heath, Highgate Wood and Queens Park Committee meeting held on the 4th of May be approved as an accurate record.

### **4. OTHER MINUTES**

The Committee agreed to appoint John Foley to the Hampstead Heath Consultative Committee. It was noted that Jason Groves would be appointed to the Highgate Wood Consultative Committee once he was formally elected by the Court of Common Council to the Hampstead Heath, Highgate Wood and Queen's Park Committee.

5. **ASSISTANT DIRECTORS UPDATE**

The Committee considered a report of the Executive Director Environment on the Assistant Director's Update.

The Chairman thanked the staff for their work supporting the successful events over the jubilee.

RESOLVED - That: -

- I. The report be noted; and
- II. That the content of the Swimming Annual Review 2021/22 be approved.

6. **SWIMMING CAPITAL PROJECT GATEWAY 3 /4 REPORT**

The Committee considered a report of the Executive Director Environment regarding the Safety, Access and Security Improvements to the Hampstead Heath Swimming Facilities.

The Committee were informed of the context of the project and noted that the final report on this would be prepared for Member approval in October.

Replying to a Member's query the improvements to the site were explained and it was confirmed that there would be no significant impact to the natural surroundings of the site caused by the works. The Chairman observed that the full details of this potential impact would be provided in the planning application which, as confirmed by Officers, had been completed on the 7th of June.

RESOLVED- That: -

- I. That an additional budget of £30,700 be approved to reach the next Gateway; and
- II. That the revised project budget of £163,700 (excluding risk) be noted; and
- III. That the total estimated cost of the project at £691,245 (excluding risk) be noted; and
- IV. A Costed Risk Provision of £27,000 be approved to reach the next Gateway (to be drawn down via delegation to City Surveyor); and
- V. That the Committee approved Option 2 be progressed as the only viable option; and

VI. That it was noted that a minor planning application was submitted on 7th June 2022

**7. SUB-DIVISIONAL PLAN 2022-25**

The Committee considered a report of the Executive Director Environment on the Sub-Divisional Plan 2022-25.

Replying to a Member's query it was confirmed that the enforcement and administration of car parking charges would be continuously reviewed for their effectiveness. The Chairman requested regular updates on this matter going forward.

RESOLVED- That the Hampstead Heath, Highgate Wood & Queen's Park Sub-Divisional Plan 2022-2025 be approved.

**8. PROPOSED SUSTAINABLE MANAGEMENT OF THE GOLDER'S HILL PARK ZOO**

The Committee considered a report of the Executive Director on the Proposed sustainable management of the Golder's Hill Park Zoo. The Chairman observed that the Hampstead Heath Consultative Committee had reacted positively to this report.

The Superintendent informed the Committee that options were being explored to make the Golder's Hill Park Zoo more financially stable in the long term and that the report's recommendations were produced to this end. The Chairman noted that the Zoo was a highly valued community asset.

Members encouraged Officers to expedite work on the contactless donations to ensure this was in place for the summer. Following explanation from Officers that there was ongoing issue with the wireless internet at the site the Chairman requested a update on the progress of the contactless donation posts at the next meeting of the Committee.

Replying to a Member's concern it was explained that the Zoo's charges were based on the benchmarks of the British & Irish Association Of Zoos and Aquariums and were at the lower end of these benchmarks.

It was confirmed, in response to a Member's query, that the Zoo had appropriate links with local schools and the University of London but that communication of these links could be better managed.

RESOLVED- That the preferred option and ancillary plans, including the change of use of the Butterfly House be approved.

**9. REGISTERING HAMPSTEAD HEATH, HIGHGATE WOODS AND QUEEN'S PARK FOR GIFT AID DONATIONS**

The Committee considered a report of the Executive Director Environment on the Registering of Hampstead Heath, Highgate Woods and Queen's Park for Gift Aid donations.

The Committee noted that the Hampstead Heath charity was the pilot for the use of Gift Aid across the City of London Corporation's Charities.

Responding to the Member's question it was explained that the use of third parties was not favoured by the Chamberlain as the Value Added Tax position was not preferable but confirmed that it would be explored further, if the pilot was successful.

RESOLVED- That the Chamberlain be authorised to open dedicated bank accounts in order to register with HMRC the Hampstead Heath charity (803392), and the Highgate Wood and Queen's Park Kilburn charity (232986) for Gift Aid status.

**10. FUTURE ARRANGEMENTS FOR WEDDINGS AND CIVIL CEREMONIES AND HAMPSTEAD HEATH AND QUEEN'S PARK**

The Committee considered a report of the Executive Director Environment on the Future arrangements for Weddings and Civil Ceremonies and Hampstead Heath and Queen's Park.

The Committee observed that it was important to balance achieving income through holding events and maintaining public usage of the open spaces. It was confirmed that a report from the City Surveyor would be prepared, and brought to the Committee for consideration accordingly, on the repairs to the pergola.

In response to a Member's query it was confirmed that income from filming fees paid in relation to the filming at Hampstead Heath was received by the Hampstead Heath Charity.

## **Meeting Action Points & notes**

### Outstanding Actions from the last meeting (11.01.2022) & matters arising

#### *Angling –*

- ACTION – RGG to follow up with the Heath Conservation Manager to confirm if funding has been sought from the Environment Agency to support angling infrastructure, such as platforms. RGG will follow up with RGi in relation to funding opportunities.

UPDATE: Heath Ecologist has sought platform costs, which are around £7k. Looking at ways to fund with support from the HAHAS. Need to consider how many platforms can accommodate.

#### *Walk Talk Walk –*

- ACTION – COL to provide an further update on discussions with Walk Talk Walk regarding a Hampstead Heath event at the next meeting.

UPDATE: Heath Hands are recruiting additional volunteers, with the intention to introduce weekly sessions on the Heath moving forward.

#### *Parks for Health –*

- ACTION – COL to meet with Camden to discuss opportunities regards Social Prescribing.

UPDATE: SH will be meeting with a member of the Parks of Health team. Additional funding sources, such as CIL funding, to be considered, with the support of Stakeholders.

### Swimming Capital Project

The project is focusing on improving access to the bathing ponds. Designs have been discussed with the bathing pond associations. Planning application was submitted in June 2022 and comments can be made via Camden's planning website. A number of surveys are planned. The project is currently on track for works on site to commence during autumn 2022, subject to planning approval.

MP noted that members of the KLPA felt that they had not been consulted on two aspects of the design which required planning approval, including the back fence and the steward hat.

SH clarified that the stewards hut not a change of current use and the plans were to reduce the footprint of the existing space used. Comments can be submitted as part of the planning consultation process.

PJ clarified that the changes to the fencing had been discussed in the past and was mentioned at the engagement workshop held with swimmers. Comments can be submitted as part of the planning consultation process.

SH outlined the process of engagement focused on ensuring the design met the access needs of users of the facility which is the purpose of the project. Details of the proposals were now available on Camden's planning portal, and comments/feedback on proposals could be logged via the panning portal.

- ACTION – Link to Camden's Planning portal to be circulated.

### Athletics Capital Project

SH funding has been agreed in principle. The project is on track in relation to the COL Gateway process, Once the project board is set up, the stakeholders will be engaged to fully contribute to the project. A review of the project programme will be undertaken, following stakeholder feedback.

JL welcome COL's commitment to resurfacing the track. There is potential for the 2024 Night of Personal Bests event to incorporate the Olympic trials. In order to achieve the 2024 event, re-surfacing will need to be completed in 2023. Highgate Harriers would like additional power outlets to be installed along the back straight as part of the scope of works. DW surface would need to be completed during autumn 2023 to be ready for a 2024 event, noting a current shortage of raw materials

RS would support Stakeholders involvement in the Project Board. The project should be driven by the needs of Athletics, as opposed to the Gateway process.

SH clarified that the Gateway process is the City of London Corporation process to deliver projects, and projects needs to go through a series of approvals. This cannot be changed and every capital project needs to go through this process. The last approval was given at the end of July and the Project Board cannot be formed until all approvals have been granted. Once the Project Board is set up, there is the intention to involve a wider range of Stakeholders moving forward. SH understood the concerns around the programme, which need to be discussed with the Project Board once established.

EM noted that the Rugby Club were supportive of the resurfacing project and requested advanced notice of works so that alternative training locations should be arranged during the period of works on site.

GJ outlined the importance of Stakeholder support and additional external funding to support the sporting facilities on the Heath.

- ACTION – KR to arrange a for SH to meet with Track Stakeholders so that discussions can continue to take place.

#### Update from COL

SH has met with the London Cricket Trust, who are proposing investment in a number of cricket facilities across the COL open spaces, including Parliament Hill and the Heath Extension. Stakeholders will be engaged to ensure the proposals meet the needs of users.

A Sports Engagement Report has been prepared by the City of London Corporation. The report sets out the value of the COL's sporting facilities and includes locations in the City as well as locations across the Natural Environment. The report highlights the benefit of a clear strategy in relation to sports and wellbeing. The Natural Environment is preparing a strategic framework, which will include a visitor and community engagement strategy.

RS Cricket proposal has a potential to engage a number of communities. Early Stakeholder engagement in relation to the Strategies is key, as the Heath plays a key role in sport and recreation.

GJ consideration will need to be given as to how to involve representatives of sports activities at Highgate Wood & Queen's Park moving forward.

#### Heath Hands Update

KO Heath Hands have been busy across all areas, including conservation, interpretation, schools and corporate volunteering. Visits with Social Prescribing Navigator Teams from Voluntary Action Camden and Age UK have been held. The navigators are based at local GP practices and help people to access facilities which may be beneficial to them. A range of activities are available across the Heath. A green social prescribing taster session is planned for the coming week via the Mental Health Foundation. Following visits from the navigator teams, two less mobile individuals have been supported to start volunteering at Kenwood House. A number of groups have been facilitated to access swimming on the Heath. There are a wide range of on-going wellbeing sessions taking place,

including a newly established Nordic Walking group. Activities available to support mental health include forest bathing (sessions throughout the summer).

### Updates from Clubs

MP the KLPA have had an on-going discussion with COL Officers in relation to the dog tethering area at the Ladies' Bathing Pond. An agreement has been reached which accommodates all users. The request to amend the current free swim times to align with the free swim timings offered by LB Camden needs to be considered now that the Judicial review has concluded.

SH highlighted that this needs to be part of the annual review of fees & charges, which will take place during the autumn.

The Pink plaque awarded to the Ladies' Bathing Pond by the Highgate festival has been installed. The plaque celebrates the lifeguards and swimmers.

The centenary of the Ladies' Bathing pond is coming up in 2025/6. A celebratory event will be discussed to mark the centenary. The COL would like to join the KPLA in the celebrations.

- Action: KLPA to send more information to the Sports & Wellbeing Forum Chair.

The KLPA has an archive at the Bishopsgate institute. A year will be settled on to mark the centenary and further discussions can be progressed outside of the Forum.

RGi the HAHAS have produced a short video, which can be viewed at: [HAHAS - A short film | My Site \(thehahas.co.uk\)](http://thehahas.co.uk). the prices quoted for fishing platforms seem very high. There was a disappointment that the reopening of the north bank for fishing has still not been considered. SH reassured HAHAS that she supports the re-opening but risks need to be mitigated for other pond users. Representatives from the Highgate Men's Bathing Ponds needs to meet on site with representatives from the Hampstead & Highgate Angling Society (HAHAS). Discussions needs to focus on co-use of the Bathing Pond, taking into account swimmers concerns around angling, safety and impacts on wildlife.

- ACTION: KR to organise a site meeting,

KS raised a query around the current parking hourly rates at the Lido car park and whether they can be lowered. A concern around a recent spate of bike thefts was raised. This is impacting on Lido users, using the cycle racks.

SH confirmed that parking charges needs to be considered as part of the annual fees and charges review.

PJ noted that this is a wider issue in Camden and reassured Lido Users that a number of interventions were put in place in relation to the bike thefts including liaison with the MET, the community safety team, more patrolling by the constabulary and signage to help users to be aware and with advice of types of locks that are more difficult to break.

SN reflected that the GIAG event this year fulfilled many of the objectives of the COL and Clubs, and has raised the profile of Croquet on the Heath. When possible a further discussion on the facilities at Parliament Hill would be welcomed.

### Upcoming & Recent Events

PJ provided an update on recent events:

- English National Cross Country – event was very well received, especially followed a cancelled event from last year.
- Night of 10m Personal Bests – event has grown in popularity, with approx. 4,000 spectators at this year's event.

- GIAG – Extremely hot weather meant a number of wellbeing events did not take place. The event was very well received with a number of activities on offer.
- British Water Polo League (Men's 60<sup>th</sup> and Women's 35<sup>th</sup>) Anniversary – event was a great success, with the matches being played in the deep end of the Lido, whilst public swimming continued. 300 participants and spectators enjoyed the event, with 15 exhibition matches taking place across the day, including the Men's & women's 2012 Olympics teams.

Upcoming events include:

- Duathlon (4<sup>th</sup> September).
- London Youth Cross Country (19<sup>th</sup> November)
- Christmas Day Swim

#### Update from Pro-Active Camden

RS provided an update. A focus area for the next few months is a response to a drop in participating levels for sports and physical activities amongst girls during the pandemic. In other London Boroughs the drop in participation levels was equal amongst boys and girls. A focus in participation amongst girls and young women should again be a focus for the Forum.

RGi fishing school sessions will be taking place in September, when the schools return. The GIAG Angling taster session has been postponed but will be taking place.

## Main Report

### Management Framework

1. An update on Sub-Divisional Plan 2022-25 projects is attached (appendix 1) for information.

### Capital Projects

2. A "project on a page" summary has been prepared in relation to the Swimming – Safety, Access and Security Capital Project (appendix 2) and the Parliament Hill Athletics Track resurfacing Capital Project (appendix 3).

### Events

### **Constabulary Update**

5. With extreme temperatures being witnessed across the country, the focus during the summer for the Hampstead Heath Constabulary has been fire safety and security. With an increased risk of wildfires, the Constables have proactively engaged with members of the public, reminding visitors not to have bonfires or barbecues on Hampstead Heath. Staff were equipped with fire fighting back packs and vehicle drawn bowsers.
6. The Metropolitan Police, in partnership with the City of London Corporation and the London Borough of Camden (Community Safety Team) ran a week long operation on Hampstead Heath, Parliament Hill Fields during the summer. The purpose of the operation was to provide public reassurance, especially at a time when parks and open spaces are becoming busier with an increased footfall. The Park Manager can provide a verbal update on the outcomes of this operation.

### **Judicial Review Outcome**

7. A challenge to the charging policy at the Ladies' Pond was heard at the High Court on 22-24 February 2022. The case, *R (Efthimiou) v The Mayor and Commonalty and Citizens of the City of London*, was brought by a disabled swimmer who contended that the charging policy unlawfully discriminated against her. The thrust of the challenge was that disabled persons as a class were financially worse off than non-disabled persons, and that the charging policy (even with concessionary rates) created significant barriers to their ability to swim.
8. Judgment was handed down on 23 June 2022. The Court held that the charging policy, under which disabled swimmers receive a 40% discount on single swims and season tickets, did not breach the duty to make reasonable adjustments for disabled persons, and was not indirectly discriminatory towards disabled persons. The root problem was a lack of disposable personal income, and all those of limited income, whatever their circumstances, were catered for under the charging policy by the same concession.
9. The Court held that, as a general principle, charging for leisure facilities was fundamentally fair and reasonable. On the facts, the charges were modest and compared favourably with charges at other similar facilities. The Court also held that the claim did not fall within the ambit of Article 8 of the European Convention on Human Rights (Right to respect for private and family life) or Article 1 of Protocol 1 (Protection of property).

## **Ponds & Wetlands Conservation Plan**

10. Conversations with the Hampstead & Highgate Angling Society and swimmers are in progress to re-open float fishing at the men's bathing pond north bank. Fishing was suspended 5 years ago after an accident with a swimmer that was injured with fishing equipment. New measures have been put in place to separate the area from the swimming area and officers are in conversation with all stakeholders to make sure the right balance is achieved in using the pond for different activities.
11. Works are planned to create a dedicated area for dog bathing at the Hampstead pond number 2. Dogs can access the pond in various areas and they are not sufficiently controlled to protect wildlife on site. By creating a dedicated area and with clear signage and natural barriers it is hoped that access can be controlled better.
12. The recent hot weather generated an increase of algal blooms in the ponds when water levels are falling and water flow through the chain is negligible. A network of floating aerators have been used to improve oxygen levels in the water and where necessary additional 'splash pumps' have been used to keep the algae controlled and maintain a good level of oxygen in the ponds.

## **Gift Aid**

13. The project is progressing well and still on track to have a fully functional gift aid option for donors by April 2023 in line with the incoming tax year. This schedule includes contingency time noting the lengthy processes to set up bank accounts and registering with HMRC. We are also still reviewing the possibility of using a 3rd party, such as Just Giving or CAF, who will then organise our Gift Aid donations, reducing the administrative workload on officers. A project on a page update for Gift Aid is attached at appendix 4.

## **Queen's Green Canopy**

14. The Queen's Green Canopy (QGC) is a tree planting initiative created to mark Her Majesty's Platinum Jubilee in 2022. The QGC invites people from across the United Kingdom to "Plant a Tree for the Jubilee". As such, the City of London Corporation has become actively involved with the QGC activities, including Education and Conservation. A report was submitted to the Open Spaces & City Gardens Committee on 7 July ([\(Public Pack\)Agenda Document for Open Spaces and City Gardens, 07/07/2022 10:00 \(cityoflondon.gov.uk\)](#)) setting out a request from the incoming Lord Mayor via the Remembrancer's Office to find a location within Hampstead Heath to plant 33 trees, to represent each of the London Boroughs.
15. The proposed tree species and planting locations have been carefully selected to maximise the opportunities for the trees to flourish whilst promoting nature recovery and biodiversity:

*Hampstead Heath Extension*: a group of 11 Italian Elms (*Ulmus pumila* hybrid) which are Dutch Elm Disease resistant, to be planted along the pathway leading

across the cricket field to replace the native elms that succumbed to Dutch Elm Disease.

Kenwood Nursery Yard: a group of up to 11 traditional orchard apple and pear trees, to be planted within the hazel coppice compartment. Up until the outbreak of the Second World War this site was a commercial orchard producing significant produce. This will increase the conservation and the education value of the area.

Tumulus Field east of the Tumulus site: up to 11 native oak trees (*Quercus robur*) to be planted to mark the lost field boundary and increase the nature conservation value of existing hedges. The trees will be planted in twos and threes to achieve the most 'natural' effect.

16. This will be a great opportunity for the Heath to engage in a national scheme; host a large event; welcome the incoming Lord Mayor and encourage children and volunteers to get involved with the tree planting efforts. Full funding is provided for this project by the Town Clerks Department. A map is included at Appendix 5.

### **Good News**

17. The fundraising total for the Heath Extension Playground has been reached. Planning approval for the proposed changes at the Heath Extension has been granted and contractors have been appointed. Works are planned to start on site in the autumn.
18. Hampstead Heath has been successful in obtaining a Green flag award for 2022. The Heath is also taking part in the a 2022 London in Bloom awards. The results are due to be announced on 21 September.
19. The London Cricket Trust has confirmed funding for improvements of the cricket facilities at Parliament Hill, the Heath Extension, and at Highgate Wood. A Stakeholder engagement will commence in the autumn to scope the details of the works. The improvements include new nets and artificial cricket squares.
20. A partnership project with the Royal Free Hospital is being scoped to provide cancer patients a view of the Heath via a video link. Officers are still assessing the feasibility of the camera installation and the viability of the proposal. Funding for implementation is provided by the Royal Free Hospital.
21. From 15 – 31 August, Hampstead Heath hosted the 'Green City' outdoor exhibition at the East Heath entrance. Developed by London Metropolitan Archives, the exhibition highlights the essential role played by London's parks and open spaces in the lives of Londoners. From playgrounds and picnics to concerts and Sunday football kickabouts, Green City: A Visual History of London's Parks and Open Spaces celebrates green spaces and the way in which Londoners have embraced and enjoyed the 'great outdoors' since the sixteenth century. Following its successful run on Hampstead Heath, where it was enjoyed by thousands of people during the last two weeks of the summer holidays, it can

be seen at The View in Epping Forest's Visitor Centre from 1 – 18 September 2022.

22. Works have started on creating the new pond at the bottom of Judge's Hollow, to the west of Whitestone Pond. The project is community led, with the Reddington Frognaal Association partnering up with the City of London, and funding raised for an excellent exhibition earlier this year at Burgh House, celebrating the return of what was once the subject of several Constable landscape paintings. The new pond has been inspired by a Constable painted nearly 200 years ago, and has been designed specifically for wildlife. It is hoped that the clay lined pond will be completed along with some marginal planting next spring.

### **Corporate & Strategic Implications**

23. The projects and works outlined in this report contribute towards the achievement of the three aims set out in the City of London Corporate Plan 2018-23: Contribute to a flourishing society, Support a thriving economy and Shape outstanding environments.
24. The projects and works outlined in this report contribute towards the achievement of the Hampstead Heath Management Strategy 2018-2028 Strategic Outcomes A: The Heath is maintained as a flourishing green space and historic landscape, B: Improved quality of life for Heath visitors, C: The Heath is inclusive and welcoming to a diverse range of visitors and D: Greater number of and diversity of People taking care of the Heath.

### **Financial Implications**

25. Donations are currently being sought for the following project:
  - Model Boating Pond Island - wildlife sanctuary (£50,000). The Trees and Conservation Officer and Heath Ecologist are also drafting an application to the London Wildlife Trust's Rewilding London Fund for works to install additional reed beds and protect the island at the Model Boating Pond. £6,153.00 has currently been raised towards this project.
26. We have recently reached the funding total (£5,000) for the bird and mammal shelters project.

### Introduction

This Sub-Divisional Plan is part of the Management Framework for the Hampstead Heath, Highgate Wood, Queen's Park and Keats House Sub-Division, which sits within the City of London Corporation's Natural Environment Division.

The Division is comprised of three individual charities, each with their own Charitable Objectives:

Hampstead Heath (803392)	The preservation of Hampstead Heath for the recreation and enjoyment of the public.
Highgate Wood & Queen's Park (232986)	The preservation in perpetuity by the City of London Corporation of the open spaces known as Highgate Wood and Queen's Park, Kilburn for the use by the public for exercise and recreation.
Keats House (1053381)	To preserve, maintain and restore for the education and benefit of the public the house and grounds known as Keats House as a museum and memorial to John Keats.

The Sub- Divisional Plan is part of a hierarchy of strategies and plans which form a 'golden thread', translating City Corporation Strategic Outcomes into operational delivery, as follows:

- Corporate Plan, 2018-23.
- The Natural Environment strategic framework
- Hampstead Heath Management Strategy 2018-28

## Summary

This report sets out the high-level concept plan (appendix 1) for the Parliament Hill Lido, which will aim to ensure the facility continues to serve the needs of users and the local community, whilst increasing the value of the Lido for health and fitness.

## Recommendation

Members are asked to:

- Provide feedback on the high-level concept plan (appendix 1).

## Main Report

### Background

1. Parliament Hill Fields Lido, located within Hampstead Heath, was opened on 20 August 1938. The Lido has been operated by the City of London since 1989. Designed by Harry Rowbotham and TL Smithson of the London County Council Parks Department, the Parliament Hill Fields Lido is almost identical to the Victoria Park and Brockwell Park Lidos.
2. In 1999 the Lido was listed as a Grade II building. It provides an unheated 60m long open-air swimming pool which is open 365 days a year, a small café, and a small sauna. A small-scale gym provider is currently licenced to operate within the facility. Since 2005 there have been a number of building refurbishments on a phased approach and a stainless-steel lining was installed, a pioneering solution and first of its kind in Britain. In 2021 a proposal for improvements to the sun bathing terraces was approved as part of the planning process. The structure is generally ageing and in need of investment.

3. A Capital Project funding bid in relation to safety, access and security at the Swimming facilities was approved in 2021. A review of the existing layout at the Lido has been commissioned which focuses on identifying underutilised space, and improving the health, wellbeing and fitness offer at the Lido.
4. The Lido offers a number of activities and free swim session that add social value including to schools, refugees, NHS workers, BAME communities' mental health swim sessions. A successful triathlon club uses the Lido every Tuesday evening, and it hosts water polo sessions at the weekend, cold water swimming events and the annual Heath Duathlon.

### **A Blueprint for the Lido**

5. The Parliament Hill Lido has underutilised space which could be utilised to support the swimming offer and provide additional health and fitness opportunities. It is important that the blueprint retains the main function of the Lido, as a cold-water swimming venue.
6. In 2021, 160,749 swims were recorded at the Lido and participation levels are broadly in line with similar Lidos. However, the Lido is still subsidised by the Heath's Local Risk Budget. The subsidy for 2021/22 was in the region of £400K. To support income generation, it is proposed to consider and create opportunities for health, wellbeing and fitness which complement the cold-water swimming offer.
7. A blueprint for the Lido will aim to ensure the facilities continue to serve the needs of users and the local community and increase the value of the Lido for health and fitness.
8. A high-level concept plan is attached in Appendix 1. This includes:
  - A circa 200 sqm health and fitness suite (capable of accommodating circa 40 stations). To be located in the southwest part of the site within part of the existing male changing rooms and adjacent storage facilities;
  - Two studio spaces to be located on the southeast part of the site within part of the existing female changing rooms and the education centre (assuming the education team can be adequately relocated, and this can be phased when a suitable location and investment is found);
  - The old basket rooms close to reception will be reutilised as staff offices and a shop. The use of individual lockers would continue;
  - New toilets and enhancements to changing facilities;
  - The café may be extended although this space is currently rented to an external operator.
9. The proposed changes were considered after a supply and demand analysis was carried out to assess latent demand and current health and fitness offers within a 1.5 miles catchment area. The analysis included demographics, Sport England Local Insight Tool, Index of Multiple Deprivation and the 2011 census.
10. Members views and feedback on the high-level concept plan (appendix 1) are welcomed.



## **Corporate & Strategic Implications**

11. The proposals outlined in this report contribute towards the achievement of the aims set out in the City of London Corporate Plan 2018-23: Contribute to a flourishing society, Support a thriving economy
12. The proposals outlined in this report contribute towards the achievement of the Hampstead Heath Management Strategy 2018-2028 Strategic Outcomes A: The Heath is maintained as a flourishing green space and historic landscape, B: Improved quality of life for Heath visitors and C: The Heath is inclusive and welcoming to a diverse range of visitors

## **Financial Implications**

13. A Capital Bid funding application may be considered to support the development of the high-level concept plan. External funding opportunities will also be considered.

## **Resource Implications**

14. Staff resources will need to be reviewed in line with a business plan that can highlight the revised usage of the Lido. If additional resources are required, they will be funded by the improved health and fitness offer at the Lido.

## **Climate Implications**

15. The changes will not impact on the City of London's Climate Action Strategy, which was launched in October 2020. A key part of the strategy is conserving and enhancing biodiversity alongside reducing carbon emissions and any proposed changes will need to be in line with the strategy.

## **Legal Implications**

16. Under article 7 of the Greater London Parks and Open Spaces Order 1967, the City Corporation may provide indoor and open-air facilities for sport and for any form of recreation whatsoever. Similarly, under section 19 of the Local Government (Miscellaneous Provisions) Act 1976, the City Corporation may provide such sporting and recreational facilities, whether indoor or outdoor, as it thinks fit. The Lido is a Grade II listed building, and any proposed changes will be subject to planning permission and listed building consent, as appropriate.

## **Risk Implications**

17. Risks are monitored and recorded through the Hampstead Heath Charity Risk Register. Any risks arising from this proposal will be included in a project risk register.

## **Equality Implications**

18. No impact.

## **Security Implications**

19. Security implications are monitored and recorded through the Hampstead Heath Charity Risk Register.

## **Conclusion**

20. This proposed high level concept plan (appendix 1) for the Parliament Hill Lido, sets out a number of proposed changes which will enable the Lido to improve the health and fitness offer for the local community.

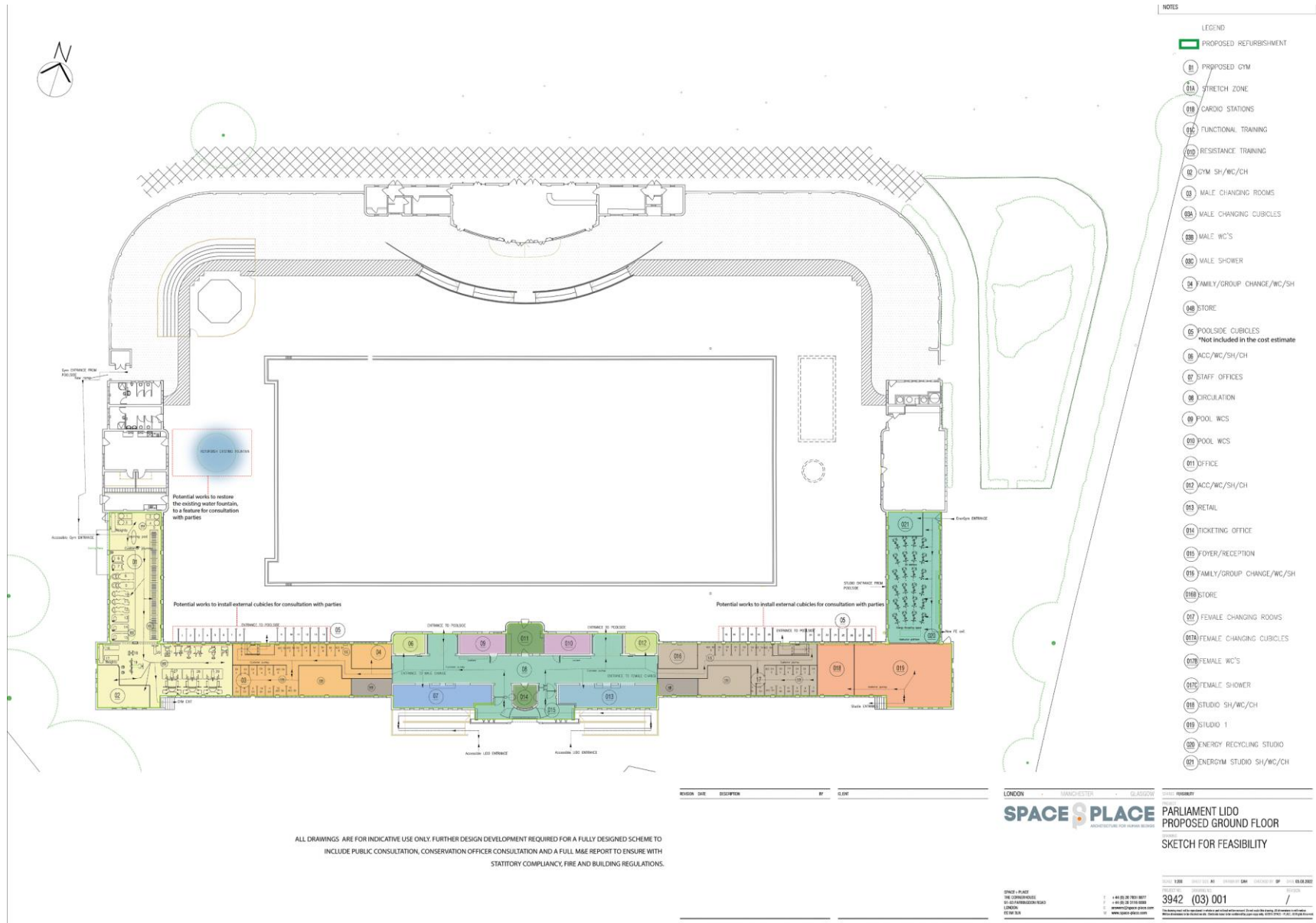

## Summary

The report sets out a series of proposals for future grassland management on Hampstead Heath in response to the City of London's 2020 Climate Action Strategy, nature recovery and the biodiversity emergency.

## Recommendations

It is recommended that:

- Members provide feedback on the future grassland management proposals set out in paragraphs 7 - 10 and appendix 1.

## Main Report

### Background

1. The City of London launched the Climate Action Strategy in October 2020 with a series of milestone objectives to achieve net zero by 2040. At the same time the global pandemic was placing immense pressures on open spaces across the UK and beyond as the public sought respite from lockdowns. In early 2021 works started across the Heath to repair the impact of increased visitor numbers and widespread erosion and compaction on grassland and in woodland areas.
2. With the pandemic moving into a new phase the Trees and Conservation unit propose a series of interventions to build on the nature recovery work carried out over the last 18 months and to commence on a programme of lowland meadow creation by taking areas of amenity grassland out of regular cutting regimes. This will have multiple benefits, notably reducing compaction, increasing biodiversity, reducing flooding, and improving carbon absorption and storage.

## **Current Position**

3. Hampstead Heath extends to 275 hectares in area. The Heath's two largest broad habitat types are woodland and grassland, with woodland covering an estimated 105 hectares, and grassland 117 hectares. These figures come from the 2009 Vegetation Survey, now 13 years old but still relatively accurate. Of the 117 hectares of grassland 33 are currently classified as amenity grassland and remain intensively managed for sports and informal recreation. The remaining 84 hectares are managed as lowland meadow and cut on an annual or longer cycles.
4. The amenity areas demand an intensive management regime of weekly cutting from March through to September to maintain a short sward. Some of the sports pitches are on a more intensive maintenance programme with cricket being the most labour and machinery intensive. With the costs of fuel exceptionally high for the foreseeable future maintaining these sports facilities remains a major commitment financially. This report does not propose any changes to the current level of sports pitch provision as these facilities provide a critical local recreational resource.
5. Returning to the Climate Action Strategy, there are ten linked work streams delivering the key objectives, with Natural Environment (Open Spaces) working towards the Carbon Removals Project. An external consultancy is currently finalising a report which provides detailed data on carbon sequestration and storage values across all the Open Spaces. The report also identifies opportunities for increasing carbon removals through a variety of interventions, including tree planting and vegetation management. One of the interventions identified is conversion of amenity grassland into lowland meadow, a process that involves the cessation of regular mowing in the growing season. These areas are then allowed to naturally regenerate and repopulate with a variety of plant species providing valuable habitat, improving biodiversity, and allowing soil recovery.
6. The meadow creation will have an important additional benefit in terms of flood alleviation where the new meadow areas alongside the Highgate Pond chain will act as buffering zones during heavy rainfall events absorbing excess surface water and reducing inflow into the pond chain.

## **Proposed sites for lowland meadow creation and works in Spring 2023.**

7. The Ecologist and Trees and Conservation Manager have initially identified a maximum extent of 7.2 hectares across the Heath where areas of amenity grassland not designated for sports activities could be allowed to develop into meadow. However due to the current extent of amenity usage of these areas it is initially proposed to allow the development of up to 3.3 hectares of meadow to assess this change in management before any further proposals are developed. Alongside this relaxed mowing regime, it is proposed to further enhance some of these areas with wildflower seeding. An initial area has been identified for the creation of 0.1 hectare of wildflower meadow on Hampstead Heath Extension. It is hoped that this will be a project linked with the conservation charity Butterfly

Conservation. A map setting out the proposed location is available at appendix 1. Table 1 shows the proposed size of these areas.

8. The Ecologist and Trees and Conservation Manager intend to implement the proposed grassland management changes in March 2023, and will be liaising with the grass cutting teams this summer to ensure that the selected areas are clearly marked up for the start of the cutting season next spring.
9. Areas with relaxed mowing regimes will then come under the wider cyclical grassland management programme but will for the first couple of years receive an Autumn cut.
10. The Heath Ecologist will be monitoring the areas and recording change. These finds will be reported back to Committee, along with any future proposals resulting from this initial work.

### Corporate & Strategic Implications

11. This contributes towards the achievement of the three aims set out in the City of London Corporate Plan 2018-23: Contribute to a flourishing society, Support a thriving economy and Shape outstanding environments, in particular the following Corporate Plan outcomes:

13. The proposals embed the Hampstead Heath Management Strategy 2018-2028 Strategic Outcomes A: The Heath is maintained as a flourishing green space and historic landscape, with the proposals focusing on habitat creation, landscape

character, and balancing visitor impacts with conserving the natural fabric of the Heath and B: Improved quality of life for Heath visitors.

#### Financial Implications

14. A small reduction in fuel usage is expected as a result of the proposals. This will help to offset current increase in fuel prices.

#### Resource Implications

15. No impact.

#### Climate Implications

16. The City of London launched its Climate Action Strategy in October 2020 and the strategy is now in implementation stage. A key part of the strategy is conserving and enhancing biodiversity alongside reducing the City of London's carbon emissions. The proposals included in this report will contribute towards achieving the Climate Action Strategy's objectives of Net zero by 2040. will be the main objective at Hampstead Heath in the short term, especially following the impact of exceptionally high number of visitors due to COVID-19.

#### Legal Implications

17. The objects of the Hampstead Heath charity are the preservation of Hampstead Heath for the recreation and enjoyment of the public. Under section 16 of the Hampstead Heath Act 1871 the City Corporation "...shall at all times preserve, as far as may be, the natural aspect and state of the Heath, and to that end shall protect the turf, gorse, heather, timber and other trees, shrubs, and brushwood thereon." The City Corporation as trustee has other statutory powers to provide recreational facilities, set aside part of the Heath for sports pitches, etc. A balance must therefore be found between preservation and recreation.
18. Where amenity grassland is not required it is entirely consistent with the 1871 Act to manage that land in a way that captures more carbon, in line with the wider City of London Climate Action Strategy, particularly where this will enhance biodiversity. If climate change is not addressed, then this will inevitably have an increasing impact on the natural aspect of the Heath. As a reservoir undertaker it is also appropriate to give consideration to measures which will reduce the risk of overtopping along the Highgate Chain.

#### Risk Implications

19. Risks are monitored and recorded through the Departmental Risk Register. Mitigations, such as fire breaks, will be in place to reduce the risk of fires associated with long grass.

#### Equality Implications

20. A Test of Relevance: Equality Analysis has been undertaken and a full equalities analysis is not proposed/required.

#### Security Implications

21. Security implications are monitored and recorded through the Departmental Risk Register.



## **Conclusion**

22. These proposed amenity grassland changes will be part of a wider programme of Climate Action focused works including tree planting and nature recovery projects to protect the natural fabric and mosaic of habitats that make up the Heath.

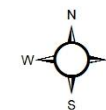

## Summary

This report set out proposed changes to the Booking System used at the Bathing Ponds and Lido on Hampstead Heath.

## Recommendation

Members are asked to:

- Provide feedback on the content of the report.

## Main Report

### Background

1. In 2020, during the first National Lockdown, a booking system was introduced to respond to the COVID19 pandemic, to allow the Heath's Bathing Ponds and Lido to operate and introduced a system that proved useful to manage crowded periods and peak usage.
2. The systems currently in place are Eventbrite for the booking of the swimming sessions and Clover for the payment of pay as you go. The two systems are not integrated and to obtain statistics in relation to usage, officers need to use manual systems that are time consuming.
3. Officers have worked with the current booking provider, Eventbrite, to streamline the booking process where possible, however there remain limitations with the current systems.
4. The systems do not offer opportunities to choose other method of payments such as flexible payments or bookings through a dedicated application.

## **Proposed Improvements**

5. It is proposed to explore the use of alternative booking systems which support an integrated payment approach, offer flexible payment opportunities such as direct debits, provide usage data, and continue to support the existing wristband arrangements.
6. The booking systems to be considered have been tested and have had longstanding use in swimming environments, with applications that can guarantee data protection and cyber safety.
7. The scoping of the new booking system can be shaped together with our stakeholders and users, assessing needs and using feedback from customer surveys.
8. The principles used in the choice of new systems are:
  - Improvement of booking experience introducing more flexible approaches for payments and multiple ways i.e. use of an app as well as the website.
  - Retention of features that are already working to minimise set up costs, i.e. use of wristbands, minimising disruption to customer experience.
  - Improvement of booking systems to facilitate administration and improve data collection on usage.
9. It is important to note that the ponds will continue to be considered unique environments and the new booking systems will not seek to introduce a more formal approach.
10. A dialogue with all users will continue to capture feedback that can be incorporated in the scoping of the new systems where possible.
11. The current systems use an income sharing model and fees. It is anticipated that the new system will generate some efficiencies in relation to staff usage and income. This is because the system will operate on a single licence that can be forecasted with no shared income. The system will be less manual and staff duties can be repurposed to support other activities that are currently understaffed such as support to other booking activities and engagement.

14. Introduction of a new booking system will reduce the manual elements of the current booking arrangements, which will enable staff to support user engagement and other leisure and sports activities across the Heath.

### Climate Implications

15. The changes will not impact on the City of London's Climate Action Strategy, which was launched in October 2020. A key part of the strategy is conserving and enhancing biodiversity alongside reducing carbon emissions and any proposed changes will need to be in line with the strategy.

### Legal Implications

16. All personal data will be processed in accordance with the Data Protection Act 2018 and the UK GDPR.

### Risk Implications

17. Risks are monitored and recorded through the Hampstead Heath Charity Risk Register. Any risks arising from this proposal will be included in a project risk register.

### Equality Implications

18. The new booking system will support access to the Bathing Ponds and Lido. The telephone booking line will remain in place.

### Security Implications

19. Security implications are monitored and recorded through the Hampstead Heath Charity Risk Register.

### **Conclusion**

20. It is proposed to explore the use of alternative booking systems for the Bathing Ponds and Lido which support an integrated payment approach, offer flexible payment opportunities, provide usage data, and provide a good user experience.

## Summary

This report provides Members a vision for improvements at Parliament Hill.

## Main Report

### Background

1. In 2007, a proposal for improvements to Parliament Hill was considered as part of a wider proposal to the Heritage and Lottery fund. This was over 15 years ago and clearly the priorities for the area need to be reassessed in order to agree the principles and a Vision that can be adopted for future funding opportunities.
2. New priorities and strategic frameworks are currently being discussed as part of the establishment of the new Natural Environment Division, including an emphasis on Nature recovery and visitor and community engagement. Any new Vision should take into account the current Divisional Plan and other new policies applying to the open spaces as a whole, whilst always reflecting the unique character of the Heath, and local issues.
3. A fresh proposal in Camden to re-develop the nearby Murphy's yard, which had been paused, has created an opportunity to emphasise the value of Hampstead Heath to the local planning authority as very important green infrastructure for Camden residents. A new Vision and principles for Parliament Hill improvements would identify opportunities that could then be developed into detailed costed

proposals for future funding from planning obligations linked to developments in the local area.

### **Vision and concepts for improvements**

4. The Vision for improvements at Parliament is based on the following principles:
  - The emphasis on the Heath's Nature conservation delivering the new priorities of the City's Climate change strategy and the Nature recovery strategy for the Natural Environment Division.
  - A pedestrian priority to ensure visitor can enjoy the natural space.
  - The need of a defined visitor hub to strengthen the recreational value of the area in line with the Charity Objectives, and with interpretation in line with the Natural Environment Division's Visitor Strategy.
  - Repurposing the buildings to generate more community value.
  - Harness opportunities to increase the learning and education value, in line with the Natural Environment Learning Strategy.
5. As part of the Vision, the following main proposals are considered a priority:
  - The creation of Sustainable drainage with the introduction of a wetland area that can resolve some of the drainage issues on site. This will also create new habitats and increase the biodiversity value.
  - Defined pedestrian access routes that can minimise soil erosion and increase safety of pedestrians.
  - Refurbishment of buildings for a better community use.
6. There is an opportunity to scope the improvements of the Gordon House Road entrance in line with any proposed development at Murphy's yards with an improved public realm proposal although at this stage this cannot be defined.
7. Parliament Hill is also hosting a number of leisure and recreational facilities including an Athletic Track, a Lido, a cricket pitch and a bowling green. The development of these facilities is progressing with separate projects and proposals that will feed into the Vision once the details are finalised.
8. The Vision for the improvements are at this stage conceptual and further engagement and consultation is needed to develop detailed proposals. The Vision is attached in appendix 1.

### **Corporate & Strategic Implications**

9. The proposals outlined in this report contribute towards the achievement of the aims set out in the City of London Corporate Plan 2018-23: Contribute to a flourishing society, Support a thriving economy.
10. The proposals outlined in this report contribute towards the achievement of the Hampstead Heath Management Strategy 2018-2028 Strategic Outcomes A: The Heath is maintained as a flourishing green space and historic landscape, B: Improved quality of life for Heath visitors and C: The Heath is inclusive and welcoming to a diverse range of visitors.

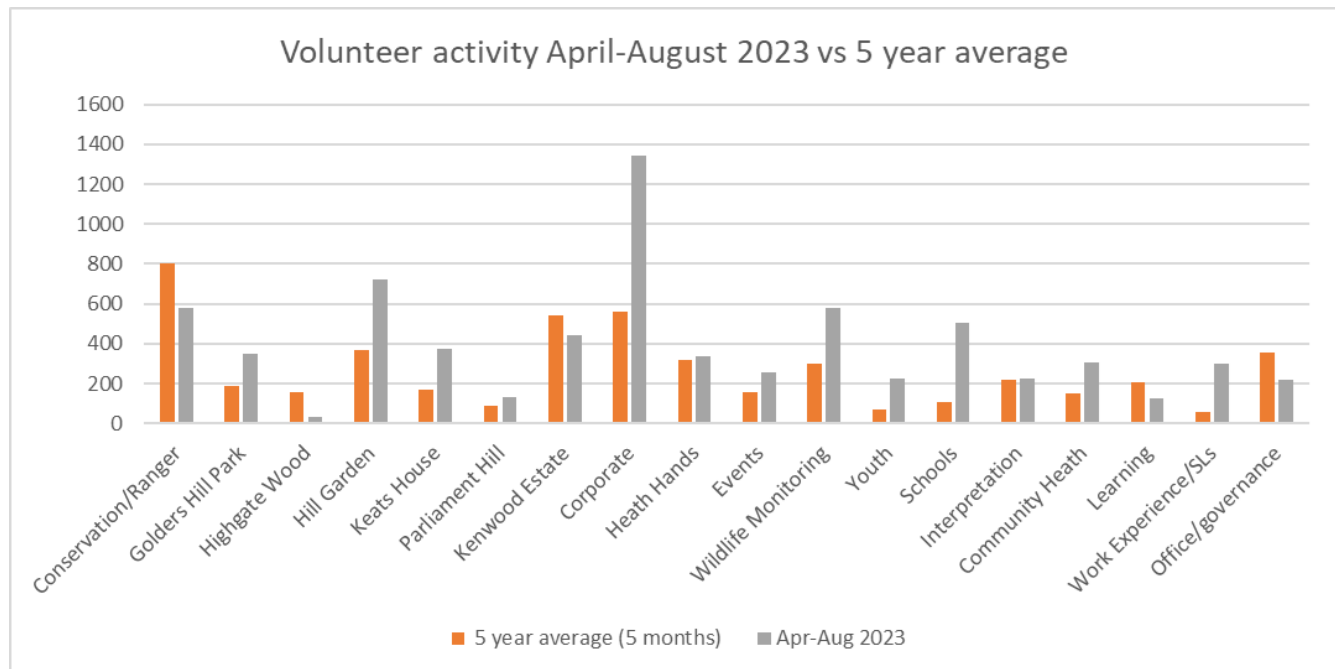
