Principal's Public Report May 2019

Introduction

The School continues to explore new initiatives across all departments with a subsequent increased awareness externally of the breadth of work being undertaken and the partnership opportunities. We have noticed an increase in the number of proposals for collaborative projects from both national and international organisations.

We marked the launch of two significant partnership projects with two well-attended events - the opening of the exhibiton 'Beasts of London' in partnership with the Museum of London and the launch of Music Education Islington with Islington Council and the City of London. The School is taking the lead in the delivery of music activity and numbers of students enrolled in the programme have already risen from forty starters to over one hundred regular attenders. We are in discussion with Islington about rolling out the model to other parts of the borough.

We are now in a transition stage with cross discipline programmes the BA in Performance and Creative Enterprise (PACE) and the reinvigorated MA in Leadership, moving them both from Creative Learning to the Drama department. There has been a great deal of consultation with staff and students to ensure everyone understands the importance of nesting these programmes firmly within one of the School's higher education departments.

Senior Management Team will hold an Away Day on 9 May to discuss the School's contribution to the City's Fundamental Review, as well as our continuing space requirements, the draft digital strategy, the draft international strategy and our Access and Participation plan, to be submitted to the Office for Students.

Highlights of current departmental achievements are grouped under two headings: Quality of Learning and Teaching and Organisational Sustainability.

Electronic Music:

- Illuminated River An external partnership has been developed with the Illuminated River Foundation (IRF), led by the Head of Electronic Music. The initiative is enabling Guildhall School composers to write short new pieces tied to those bridges on the Thames that the IRF is lighting up.
- Recorded & produced all of the 'Beasts of London' Soundtrack and 90% of the sound-design.
- Commissioned to produce one of the 10 site-specific pieces in partnership with 'Musicity' for Culture Mile's "PLAY THE MILE" initiative (Smithfield Rotunda). Delivered last week.
- Successful installation at the 'Getting it Right' research day in March

Drama Highlights

- 1. Successful review of Acting Studies BA completed. A thorough, compelling and welcome review of the relatively fledgling programme was carried out by Christina Coker. The results of which will contribute towards the future evolution of the course.
- 2. Impressive west-end showcase by the 3rd year Acting BA and MA students in April. This combined with 4 public productions across the Spring term has led to the vast majority being signed with high calibre agents and a number already in or offered work in both film, tv and theatre including a ten part Netflix series, HBO series, West End.

- 3. Wonderful evening of the Josephine Hart Prize for Poetry hosted by Lord Maurice Saatchi for our 2nd year Acting students. 5 finalists were chosen and they will perform at the British Library in June.
- 4. A very impressive BA Acting Studies performance was shared with staff and students which has led to a greater understanding and appreciation of the power and potential of international exchange and collaboration across the department.
- 5. In collaboration with AV have purchased new equipment for self-taping which means we can have a high-spec pop-up self-taping facility in the TV Studio.
- 6. Beasts of London collaboration.

Production Arts: Highlights

- Beasts of London opened to critical acclaim and record box-office sales this was a
 massive undertaking for the new Guildhall Live Events unit, with collaboration from
 not only the Video Design for Live Performance students, but also from students
 studying Scenic Art, Lighting, Stage Management, Sound, Electronic Music and Acting.
- MA CTPD students completed a very successful residential project at the Centre de Creation near Bergerac developing a short circus piece.
- Production Arts staff and students collaborated to great effect on "Towers", "A Midsummer Night's Dream", "Orestes" and "Opera Scenes".
- Production Arts Skills Exchange (PASE) will take place in Shanghai in early June. Ongoing discussions about continuing the model beyond current ACE funding.
- The new proposal for a BA (Hons) Design for Performance has been approved by PA Programme Board and will now move on to Academic Board.

Organisational Sustainability

Advancement: Highlights

- The School is delighted to announce a major fundraising event which will take place on Thursday 5 December 2019. In celebration of alumnus Sir George Martin, the School has been given exclusive rights to screen *Yellow Submarine*, with live orchestra. The event will include a champagne reception, 3-course gala dinner, and silent auction, and raise vital funds for the School.
- The Gold Medal will take place on Friday 10 May, welcoming back alumnus Sir Bryn Terfel to the judging panel. The Development office will lead on hospitality for the event, ensuring that donors, alumni and honoured guests are stewarded appropriately.
- Our annual Summer Gala evenings will take place on Monday 8 and Tuesday 9 July, with a gala dinner and reception ahead of performances of this year's musical, Stephen Sondheim's *Merrily We Roll Along*. The evenings will raise funds to support scholarships at the School.

- The School's third annual Undergraduate Open Day took place on Sunday 24 March. 650 visitors attended (342 prospective students and 308 accompanying guests). Feedback was almost universally positive, with 82% of survey respondents saying they were more likely to apply to the School as a result of attending the day. The event is a key student recruitment initiative, involving over 200 members of staff and student volunteers, and showcases programmes and activity across the School.
- Music Education Islington, the music education hub for the London Borough of
 Islington for which the School is the lead delivery partner, was officially launched on 1
 April, with an event hosted by Catherine McGuinness, Policy Chair of the City of
 London, and Richard Watts, the leader of Islington Council. The event gave
 Advancement the opportunity to engage media and the arts and education industry in
 this ground-breaking partnership.
- The School was named in the top ten institutions for performing arts in the world in the QS University Rankings 2019. This will be rolled out across the School's promotional materials going forward.

Creative Alliance: Highlights

City of London / Islington: highlights since February 2019

• The partnership between the City of London and London Borough of Islington continue, jointly led by the City's Policy Chair and the Leader of Islington Council, with the most recent steering group meeting taking place on 21 March. A key development has been the launch of Music Education Islington, which took place at the Barbican on the 1 April and consisted of a daytime conference for music educators and music organisations. Alongside the conference was an evening launch reception for school leadership and governors, key stakeholders and industry professional to celebrate the start of this ambitious programme.

Guildhall Young Artists: Highlights since February 2019

- Junior Guildhall student Leia Zhu has been invited to perform as a soloist with the Mariinsky Orchestra at the Mariinsky Theatre in St Petersburg, Russia. This is an outstanding achievement for any professional musician let alone a conservatoire student and particularly one at just 12 years of age.
- CYM London was included in the Parliamentary Review and the Head of CYM London attended the Parliamentary Review Gala at the Houses of Parliament on 28th March
- CYM Taunton is a finalist in the Taunton Deane Business Awards Creative Industries category Award
- The Interim Head of Regional Centres continues to visit regional centres to understand local issues and to build a clear future structure for each centre.

Guildhall Innovation: Highlights since February 2019

• Guildhall Live Events completed an installation, Beasts of London, for the Museum of London which received positive reviews

- Our Coaching & Mentoring programme will be offering training to the British Council and the City of London Corporation
- After a successful first year in 2018, our Easter Short Courses offer grew, including Easter Music Camp which had a 20% increase in the number of bookings in 2019 with very positive feedback
- Evening courses have had much success, with the Music Production course receiving 100% positive feedback and with most students registering for the second level course
- In its second academic year, the Employability Programme engaged with National Careers Week by creating a series of careers interview videos with the School's senior management
- Guildhall Innovation has strengthened its relationship with Barbican Guildhall Creative Learning, included four Creative Careers Sessions attended by young people through Young Barbican. Board Members are welcome to attend the Big Pitch Event for Creative Entrepreneurs on June 25 at Milton Court.
- We put out a call to all students to provide content ideas for Culture Mile's Play the Mile programme, with great success: within a two-week turnaround, we had received 39 applications from across the School, many of which were interdisciplinary. 19 applications were approved in principle, with 8 projects confirmed for Summer and 11 projects in planning.

Guildhall Research: Highlights since February 2019

- We provided an institutional response to Research England's consultation on the proposed Knowledge Exchange Framework (KEF), outlining key positions for the institution and conservatoire sector including the need to ensure that financial metrics and traditional knowledge transfer outputs are not valued above other forms of exchange (including community impact).
- Began a series of discussions with Music Therapy on future collaborations and had a first meeting with a possible future external partner, the Central and North-West London NHS Trust.
- Our most over-subscribed ResearchWorks presentation to date took place by Sarah Doxat-Pratt (University of Nottingham) on Music in Prisons.
