

# Member Declaration of Interests

Section 29 (1) of the Localism Act 2011

I, <u>Caucine</u> <u>Blames</u>, a Member of the City of London Corporation, give notice that I have the following disclosable pecuniary interests.

By signing this form, I declare that I understand that the Localism Act 2011 and the City of London Members' Code of Conduct, adopted by the Court of Common Council on 25<sup>th</sup> October 2012, require me to declare any disclosable pecuniary interests specified in Regulations made by the Secretary of State, the details of which have been made available to me. I am aware that I must notify the Comptroller and City Solicitor of any disclosable pecuniary interest which is not already on the register (or notified to the Comptroller and City Solicitor\* and awaiting inclusion on the register) within 28 days of a disclosure being made at a meeting of the City of London Corporation (which includes Sub Committees etc.).
