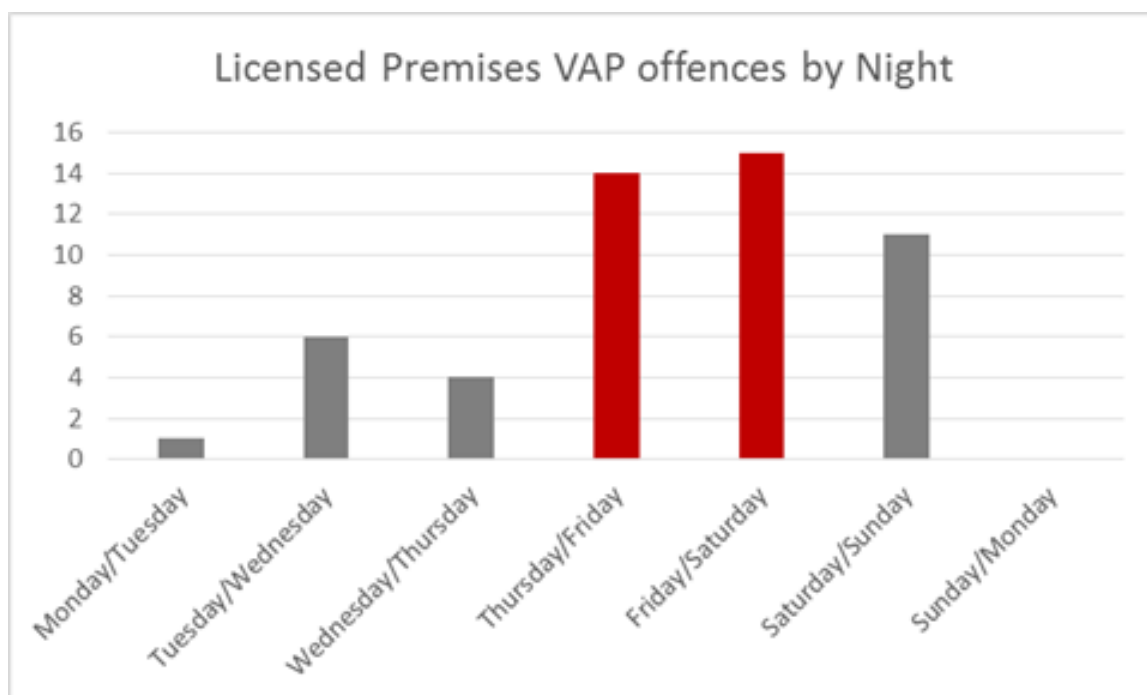
Summary

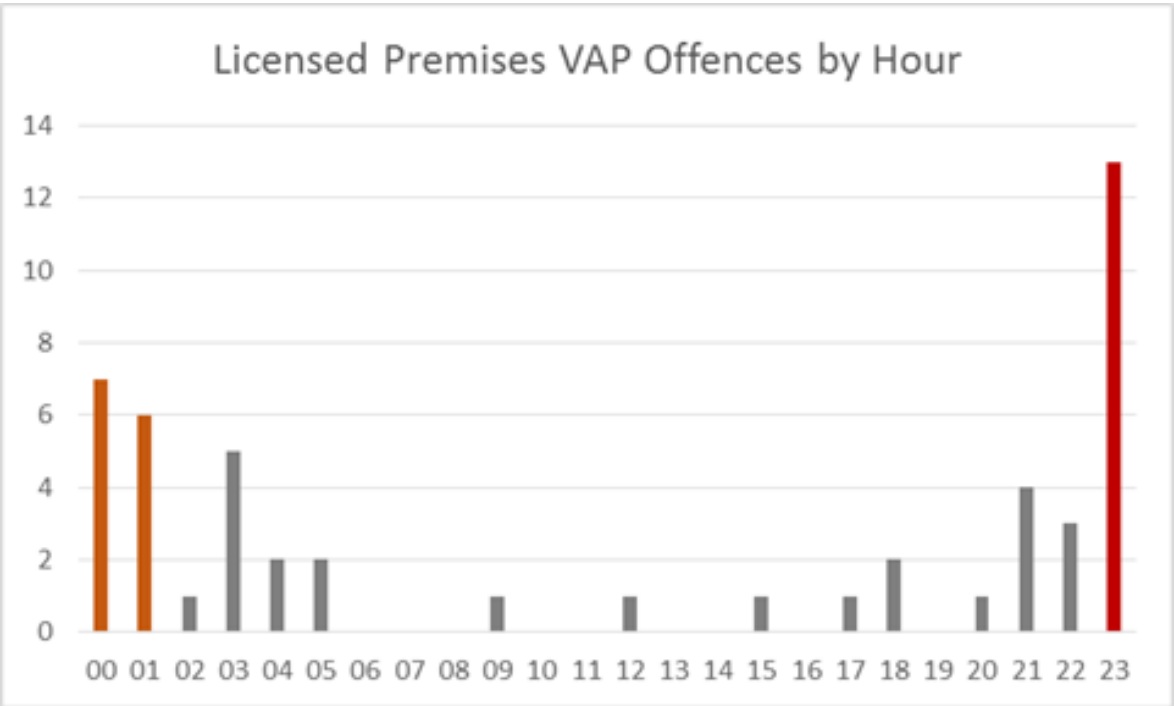

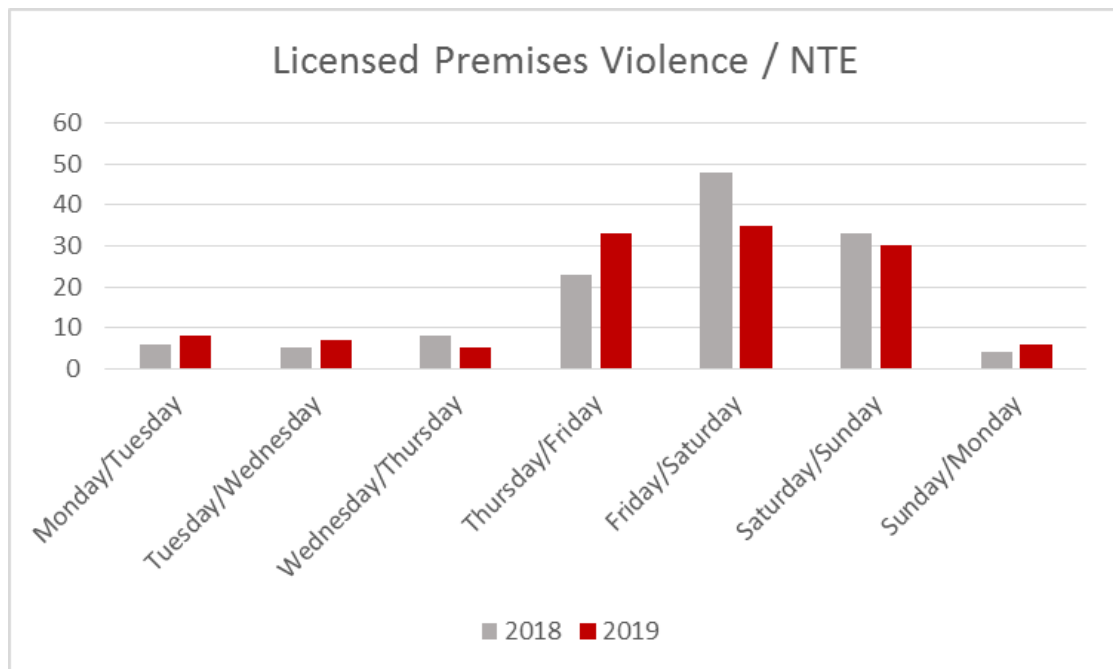
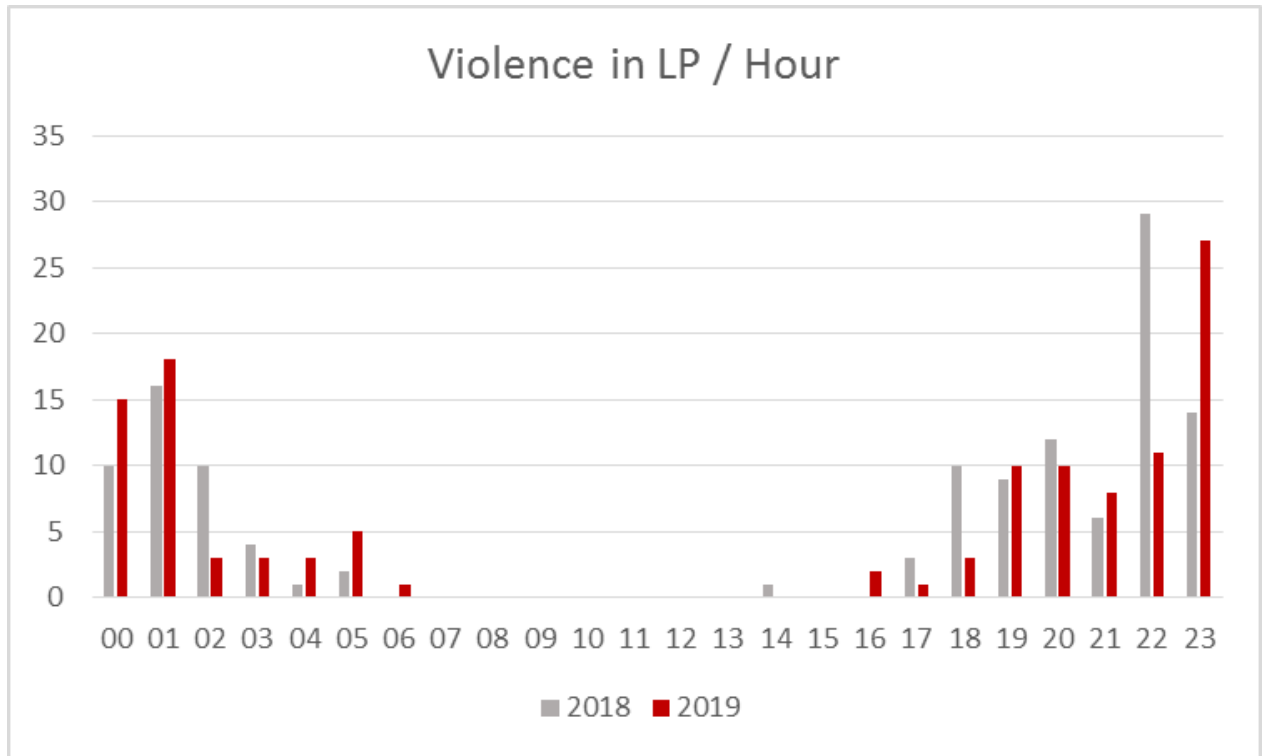
Offending continued to be predominantly during NTE hours (92.7%) – with Thursday and Friday nights accounting for 52.7%



Offending between 2300-0000 accounts for 26% of VAP crime in LP during this period, increasing to 52% between 2300-0200.
