## **1. Welcome, Introductions and Apologies for Absence**

- 1.1. The ICB for the first 50 minutes was operating in its capacity as the Local Outbreak Board.
- 1.2. Apologies were noted as listed above.

## **2. Declarations of Interests**

- 2.1. The **City Integrated Commissioning Board**
  - **NOTED** the Register of Interests.
- 2.2. The **Hackney Integrated Commissioning Board**
  - **NOTED** the Register of Interests.

## **3. Questions from the Public**

- 3.1. There were no questions from members of the public.

## **4. Vaccinations Update**

- 4.1. The item was presented by Richard Bull. Patients in vaccination cohorts 1-4 had all been offered vaccine appointments at least three times. There was a high degree of hesitancy or deferral in City & Hackney. We expected numbers to improve, however it was acknowledged that not everyone would accept the vaccine. Cohort 5 would begin being offered vaccinations from next week onwards. We were also engaging with communities such as the Charedi community who had exhibited a high degree of vaccine hesitancy.
- 4.2. Haren Patel noted that whilst there was a currently high degree of hesitancy, this was changing quickly, particularly as those who were hesitant had friends or family members receive the vaccine.
- 4.3. Jon Williams asked how we would deliver the vaccine to people with learning disabilities. He also noted that there were some instances of vaccine misinformation circulating among specific communities in Hackney. Richard Bull noted that there had been some people with learning disabilities who were being vaccinated at John Scott, however there were also behavioural specialists working with some people who were especially hesitant. Mark Rickets also added that some people were being vaccinated in their homes.
- 4.4. Jake Ferguson noted that there would be an event next Thursday evening with the black community in Hackney, but noted that much of this vaccine misinformation stemmed from the experience of many years of structural racism. There was a high level of mistrust, therefore, and rebuilding trust in those communities was a long-term goal.
- 4.5. Jake Ferguson also asked if there was a specific threshold by which vaccinations could be said to be effective enough that there was herd immunity. Mark Rickets responded that this was an evolving picture due to research still being ongoing. Sandra Husbands responded that the current figure for herd immunity was around 80% however we were not currently certain of this figure due to the changing landscape of vaccines and new variants of the coronavirus. Evidence around the AstraZenaca vaccine was still very early and therefore limited.

- 4.6. Sandra Husbands further iterated that, as it was still uncertain that the AstraZenaca vaccine prevented transmission of the coronavirus, people who have received the vaccine should still continue to abide by social distancing regulations and stay-at-home orders.
- 4.7. Cllr Bramble asked when the vaccine was re-offered to people if they had refused it. She also noted that it was not just black communities who had exhibited high levels of vaccine hesitancy and a lot of the mistrust stemmed from a lack of faith in national government. Richard Bull stated that the current message going out to patients was that all those over 70 who had not received their vaccine should contact their GP to book an appointment themselves.
- 4.8. Andrew Carter noted that there had been a lot of hard work to get the figures in the City of London to where they were. He added that there was an urgent and pressing need to get accurate figures around the uptake of the vaccine among homeless people in City & Hackney. Furthermore, we need to engage in a long-term conversation with communities to rebuild trust. Cllr Bramble added that if there was a high degree of hesitancy in black and ethnic minority communities, this could lead to further stigmatization.

## **5. Data Intelligence Update**

- 5.1. Diana Divajeva introduced the item. She noted that there had been sustained and substantial decreases in covid-19 infections in City & Hackney. There were still high rates amongst young adults, however this was still less than 250 infections per 100,000.
- 5.2. There was also a decreased number of covid-19 patients in hospital, and decreased levels of staff absence on hospital sites. This had not yet led to a reduction in the number of weekly deaths however these numbers were expected to decrease soon.
- 5.3. Sandra Husbands noted that the system had displayed an encouraging amount of resilience, particularly at a time when there is increased cold weather. Mark Ricketts added that critical care was still under a high amount of pressure, but this was expected to decrease in the coming weeks. He also noted that the high degree of ITU pressure was due to treatment for covid-19 becoming more effective.
- 5.4. Helen Fentimen asked if the reduction in numbers of cases would lead to a more effective test and trace system. Sandra Husbands responded that contact tracing was necessarily easier with a smaller number of cases. Local contact tracing capacity had increased, however, and we had additional capacity in the event that we deal with a large spike in cases, such as was seen around the new year.
- 5.5. Marianne Fredericks stated that it was encouraging to see the infection rates decrease, however the public had concerns about children going back to school in several weeks' time. She also asked if there were any plans to vaccinate school staff. Sandra Husbands responded that there was not local discretion to vaccinate teachers and other school staff, as the prioritization list was currently set by the Joint Committee on Vaccinations and Immunisations (JCVI). In terms of support for schools, we had been making preparations since before Christmas to allow in-school testing or, alternatively, provide access to lateral flow testing.

# High level overview of progress to date

## Vaccination of high priority cohorts (01-06)

- **Population cohorts according to national strategy (01-04)**
  - As of 10<sup>th</sup> Mar:
    - **Cohorts 01-04:** 69% have received first vaccination (+9% vs 2<sup>nd</sup> Mar)
    - **Cohort 05:** 72% have received first vaccination (+5%)
    - **Cohort 06:** 45% have received first vaccination (+33%)
- **Housebound residents**
  - 75% of all housebound patients have been vaccinated (as of 5<sup>th</sup> Mar)
- **Care homes**
  - 85% of Cohort 1 (OA residents in care homes) have received first dose (as of 10<sup>th</sup> Mar, according to CEG data)
  - 89% of all CQC registered care home residents have received first vaccination dose (as of 8<sup>th</sup> Mar, according to Capacity Tracker)
- **Uptake by ethnicity**
  - Breakdown of total vaccinations by ethnicity now available (slide 10 & 11, NIMs data)
- **Other vulnerable cohorts (e.g. homeless, asylum seekers, mental health patients in secure settings, sex workers)**
  - The Greenhouse Practice (practice for homeless pts) are vaccinating at Bocking Street
  - Excel centre team are supporting us with vaccinating other vulnerable groups using roving models including our homeless, sex workers and mental health patients in secure settings

## Vaccination of health and social care staff

- **Total health and social staff vaccinated at HUH hospital hub**
  - 6,877 frontline health and social care workers (including voluntary sector and HUH staff) have been vaccinated (as of 23<sup>rd</sup> Feb)
  - Booking system does not currently enable reporting of vaccinations by type of organisation (e.g. LBH, CoL, care homes); work in progress to resolve this
  - To date, CCG has put forward the details of 4,195 frontline workers, of which 100% have received invitation.
- **Demand and capacity – look ahead**
  - Over the next 5 days, 73 frontline workers are booked in for vaccination. (Max capacity = 1880)
  - 3020 vaccines are remaining
- **Uptake by ethnicity**
  - Data not yet available
- **Uptake by GPs and primary care staff**
  - It is thought that c.69% of all the total 815 primary care headcount has been vaccinated. All staff have had the opportunity to be vaccinated.

- 2 key local vaccination hubs: Bocking Centre and John Scott Health Centre
- Housebound and care home residents vaccinated through roving model (GPs and DNs)

### Commentary:

- WoW change from dashboard 02.03.21 to 10.03.21
- Local vax programme was delayed due to need to replace Elsdale Street but C&H quickly caught up
- There has been enough capacity to vaccinate all of cohort 1-4 locally
- In light of vaccine hesitancy, practices have provided a self-declaration that all patients have been invited up to three times as necessary
- Uptake of vaccinations at mass vaccination sites is unknown but suspect it is low
- CCG is trying to help promote uptake of vaccines at community pharmacy sites which we understand is currently low
- Decline rate is % of recorded as declined. There are still plenty of pts who are unsure/waiting and these won't be recorded as declined.
- Cohort 4 has increased from 11,571 to 20,840 due to updated in how shielding guidance from 15.02.20

### Commentary:

- As at 5th February just under 75% of housebound patients have been vaccinated.
- This is based on the number of practices that have confirmed plans in place - either through the practice or via the DNs - and an expected number of patients that refuse or cannot have the vaccine now because they are unwell or for other reasons.
- The confederation supported this work and have provided nurses to assist in February
- We have agreed a plan for ongoing community vaccination (with joint provision from the ACN team and GPs) to cover remaining / newly emerging patients in this cohort
- Size of cohort has increased as practices are adding patients onto temporary housebound list to enable practices to vaccinate these people.
- Confirmation required whether the updated size of cohort includes new shielding patients

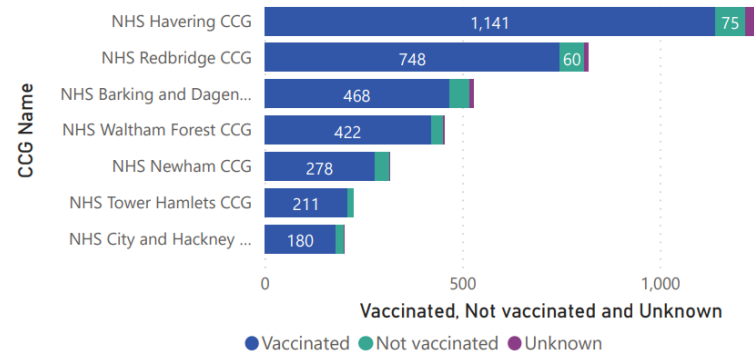

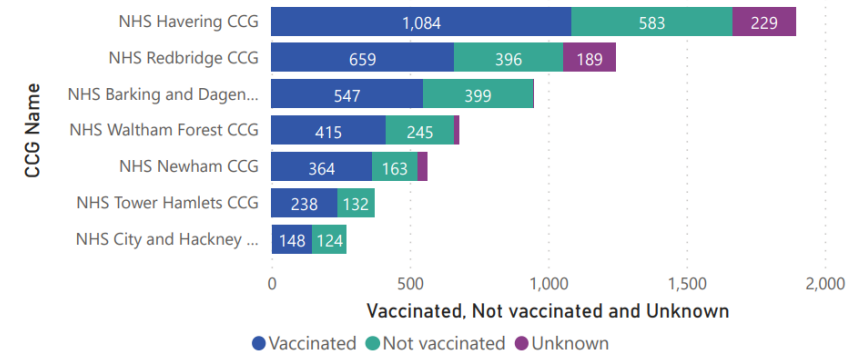

- 4 homes now have residents ready for vaccination (previously unable to receive vaccination) – care providers liaising with residents' GP practice to arrange vaccination
- We have agreed a plan for ongoing provision of community vaccination with joint delivery by the ACN team and GPs – this will cover the small number of housebound and care home residents eligible for vaccination who have been unable to receive it to date

*Mental health & LD are working with care providers to identify and support their residents to access vaccination. They are also working on collation of data report on coverage and challenges vaccinating these cohorts.*

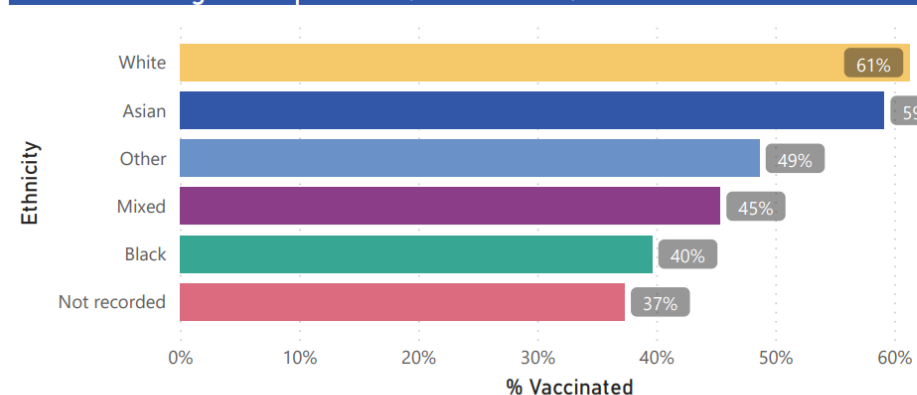

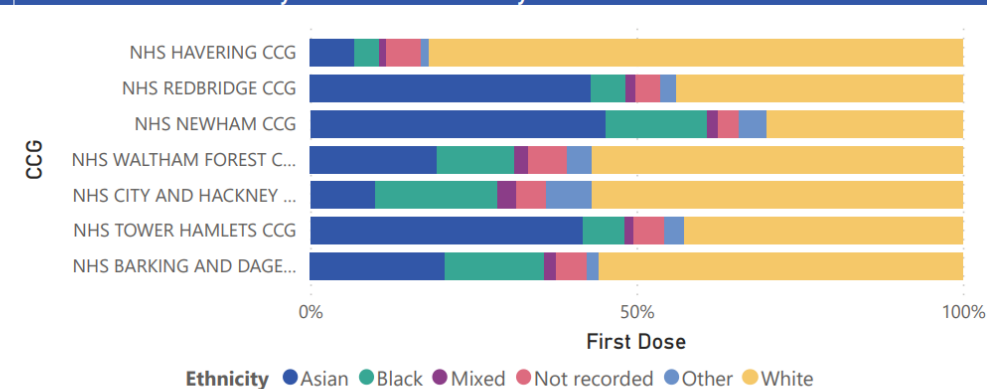

- Based on total staff headcount, 69% (116/169) of staff at the five sample practices had taken up the offer of the COVID-19 vaccination. All staff had been offered the vaccine;
- The uptake figure fell to 62% in BAME staff (48/77) and 60% in CEV/shielding staff (6/10);
- The range in percentage uptake across the five sample practices was 51-88% for total headcount and 46-90% for BAME staff;
- Anecdotally, most of the practices spoken to indicated that uptake was higher among GPs and clinical staff than in administrative staff;
- Two practices reported that they had a staff member each who was exempt due to pregnancy;
- One practice reported that four staff had not taken up the offer as a result of having recently had covid.

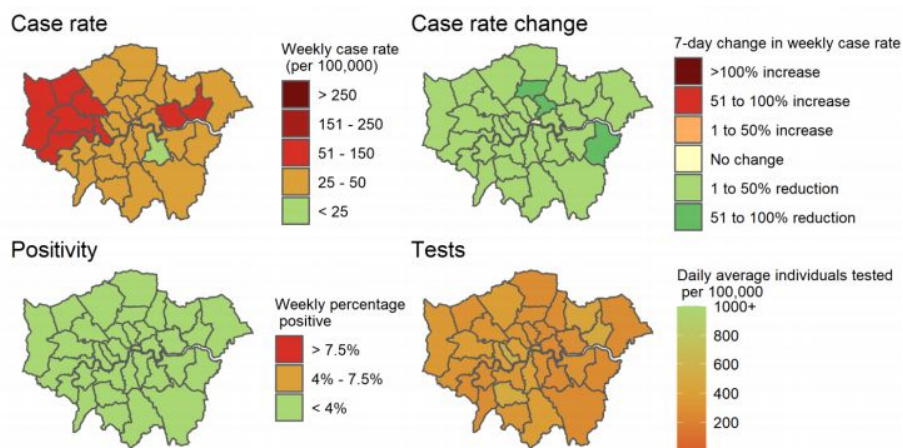

# Incidence rates have continued to decline in London and are currently 31% lower than the average for England

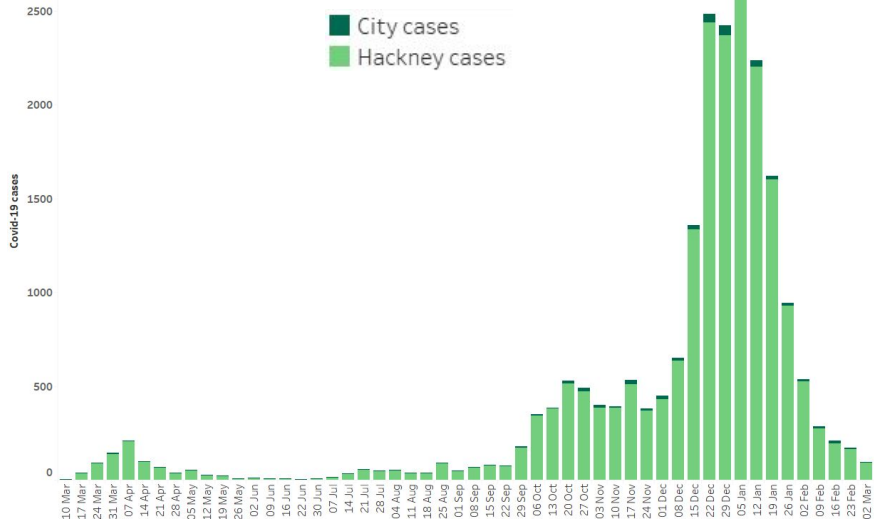
COVID-19 incidence, case rate change, positivity and testing rates in London region, weekly rate, week ending 4 March 2021



- In the week ending 4 March, London recorded an incidence rate of 44 cases per 100,000 population. This is 31% lower than the average for England and 34% lower than the rate recorded in London in the previous week.
- In London, the highest incidence rate was recorded in Hounslow at 74 cases per 100,000 population in the latest week, while Lewisham recorded the lowest rate at 23 cases per 100,000.
- Hounslow also recorded the highest positivity rate at 3.7% compared to a London average of 2.2%.
- Testing rates have increased in London over the past week, with 339 individuals tested daily per 100,000 population. Hackney recorded the 3rd lowest daily testing rate in the latest week at 276 tests per 100,000.

Number of weekly COVID-19 cases in Hackney and City of London, up to week ending 3 March 2021\*

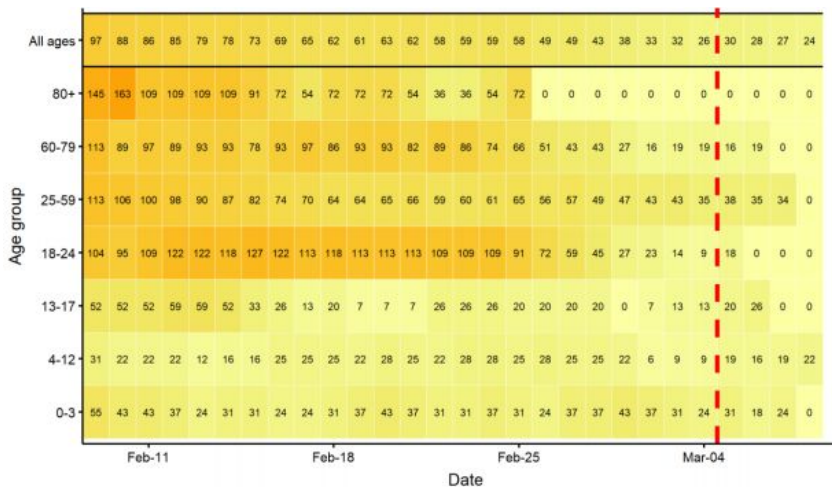

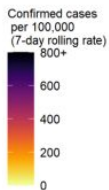
- The number of COVID-19 cases recorded in Hackney and the City of London has decreased week on week consistently since the first week of January when an incidence rate of 935 cases per 100,000 population was recorded.
- In the week ending 2 March, COVID-19 incidence rates in Hackney decreased by 44%: currently the rate falls at 33 cases per 100,000 population - among the lowest in London.
- Two cases of COVID-19 were recorded in the City of London in the latest week, resulting in an incidence rate of 21 cases per 100,000 population.
- Testing rates have increased by 16% in Hackney and the City of London within the last week to 4,132 cases per 100,000 population (PCR: 3,007; LFT: 1,125).
- Around 4,000 tests per 100,000 population have been recorded each week since the end of January.
- Positivity rates have decreased week on week since the beginning of January. Currently the overall positivity rate is 1.0% (0.3% for LFT and 1.2% for PCR).

Daily COVID-19 incidence rate by age in Hackney (8 February to 4 March)\*



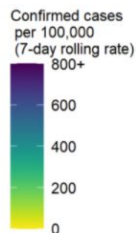
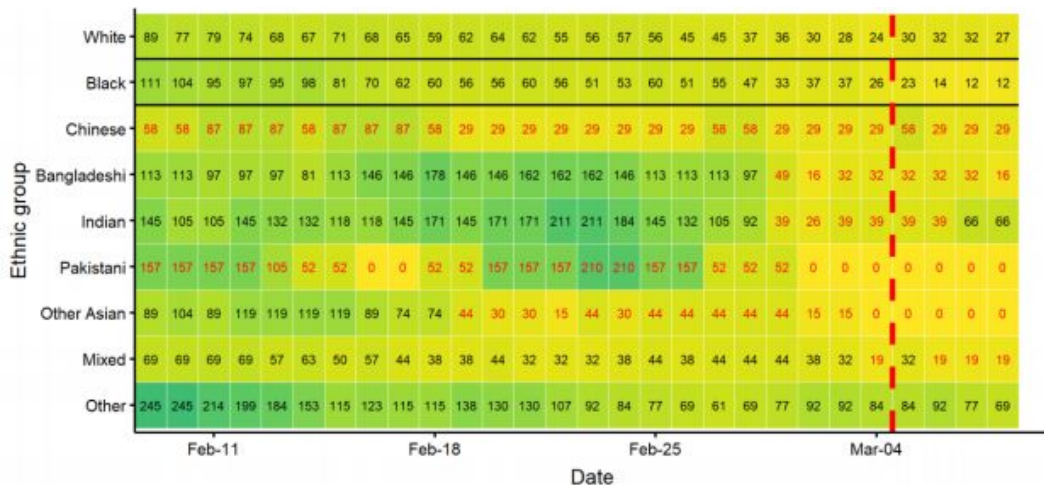

COVID-19 incidence rate by ethnic group in Hackney (9 February to 4 March)\*



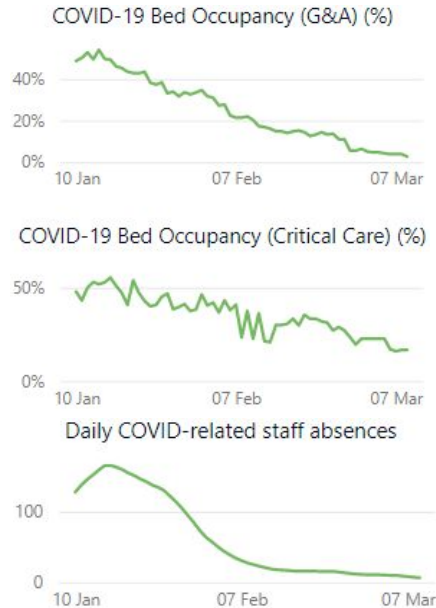

- Incidence rates have fallen among all ethnicities since mid-January. However, the rate of decline has not been consistent between ethnicities.
- Between the week ending 9 February and the week ending 4 March, Other Asian ethnicities recorded the greatest decrease in incidence rates, at 100%, and Other ethnic populations recorded the smallest decrease at -66%.
- Other ethnic populations also recorded the highest incidence rates in the latest week of available data (ending 4 March), at 84 cases per 100,000 population.
- For ethnicities with case number of greater than 5, incidence rates in the latest week fell at:
  - Other: 84 cases per 100,000 (-66% since week ending 9 February)
  - Black: 25 cases per 10,000 (-77%)
  - White: 24 cases per 100,000 (-73%)

COVID-19 acute and critical care bed occupancy and staff absences at the Homerton Hospital, to 7th February 2021

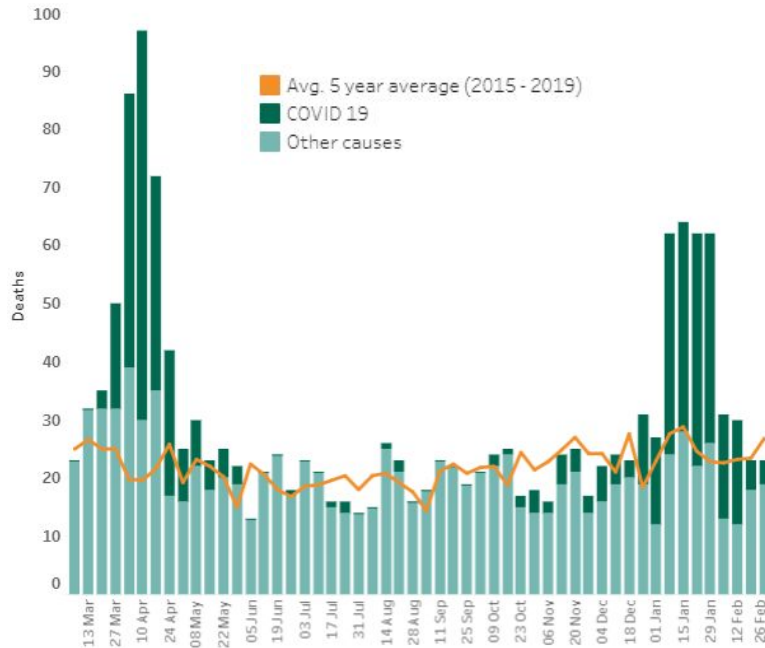


- The number of Homerton Hospital beds occupied by COVID-19 patients has been decreasing since mid-January.
- In the week ending 7 March, COVID-19 related occupancy fell at 3% in general and acute (G&A) and 17% in critical care.
- In contrast, at the beginning of January these figures were 52% and 48%, respectively.
- Overall bed occupancy remains relatively high: 61% of G&A beds are occupied and 64% of critical care beds are occupied\*.
- The number of staff absences due to COVID-19 has reduced considerably over the past two months from over 150 absences a week to six in the latest week

# 40% of all COVID-19 deaths recorded among residents of Hackney and the City of London have been registered since the beginning of January 2021

- 40% of all deaths due to or involving COVID-19 recorded in Hackney and the City have occurred since the beginning of January 2021: five in City (45% of all deaths recorded so far) and 190 in Hackney (39%).
- However, the number of deaths recorded each week is now reducing week on week: four COVID-19 deaths were recorded in Hackney in the week ending 26 February and none in the City of London. This is the lowest number of weekly deaths since mid-December.
- In the week ending 26 February, a crude rate of 3.45 COVID-19 deaths per 100,000 population was recorded in England, 2.45 in London, and 1.42 in Hackney.
- People with three or more pre existing conditions have accounted for 81% of all COVID-19 deaths recorded in Hackney and the City so far. Only 9% of all Covid-19 deaths have been recorded in people with no pre existing conditions.
- The pre existing condition that was mentioned most frequently among the 423 deaths involving Covid-19 was hypertension (54%).

#### **Communications and engagement:**

Communications continue to focus on meeting the objectives of the LOCP- in particular, preventing and mitigating the spread of Covid-19 to save lives, communicating openly and honestly with key stakeholders, and working with the community to develop capacity to support testing and contact tracing locally. This includes the continued reinforcement of the prevention messages 'hands, face, space' on various channels, amplifying government messages and supporting the work of the GLA and London Councils. In addition, there is ongoing work on specific communications related to key areas of work, with key stakeholders, including the public, care homes and local contact tracing teams.

#### **Equalities implications and impact on priority groups:**

Local contact tracing: Covid-19 is understood to have disproportionately frequent and severe effects on specific high risk groups, who may be the least likely to be contacted by the national NHS Test and Trace team. The local service offers an opportunity to address this inequality both directly, by contacting harder to reach individuals at higher risk, and indirectly by contributing to the national and global fight against the virus.

The Community Champions work and Covid-19 Grant Information programme is targeted at key communities and priority groups.

## MAIN REPORT

### UPDATE AGAINST KEY AREAS OF THE LOCAL OUTBREAK CONTROL PLAN

#### TESTING

##### Rapid testing

- The DHSC has confirmed funding for rapid testing up to the end of June. Rapid test sites are a key delivery model to meet this policy directive. We are presently exploring how best to mobilise a local testing workforce which will allow us greater flexibility in scaling up and scaling down our rapid testing infrastructure.
- The DPH Programme of Community Testing is gathering momentum and is setting up more onsite rapid testing (including support with training and clinical oversight) in Supported Living Settings, Hostels and Homeless Provider Settings and Primary Schools presently open for vulnerable children and the children of key workers.
- The DHSC has further announced they will be offering rapid home testing, and a collect option (order online and collect) from a rapid test site will be available to Local Authorities to implement. These options will be live from mid March, Local Authorities can start to develop plans for the Community Collect option now.
- We are also keen to set up rapid testing via Community Pharmacies, a model which has been successfully implemented in Merton.
- Qmatics, the booking system for the 5 rapid testing sites across Hackney and the City, supports the booking of tests 28 days in advance. This will facilitate the booking of multiple tests. All sites are also accessible under one link on both the [Hackney](#) and [City](#) websites, supporting greater visibility of all available booking slots. All sites are listed on [Sitefinder](#) and the Hackney website has embedded this map into the Hackney Website to further aid people in identifying which site is nearest to them.
- Shellgrove Community Hall rapid test has been closed and these resources have been redeployed to Homerton Library, on Homerton High Street. This location is generally busier and the test site is significantly more visible with key transport hubs nearby.
- The Leadenhall Market rapid site in the City is attracting an increasing number of people, numbers have steadily increased week on week, with 465 rapid tests registered in the week ending the 21st February.
- Testing staff in City and Hackney rapid test sites will be trained in Adult and Child safeguarding and in MECC (Making Every Contact Count) for a test site context.

#### LOCAL CONTACT TRACING SERVICE

The recent decrease in cases has allowed the team to focus on service improvement, enabled by the Here to Help IT system and to develop locally enhanced contact tracing

(ECT). A survey is underway to understand the barriers to engaging with local contact tracing (LCT) and sharing contacts from the service user's perspective. With approval gained from the Health Protection Board, two dedicated Environmental Health Officers are to be recruited to support an expanded COVID response including proactive visits to sites of concern and visiting premises for individuals unwilling to engage with LCT. The team will work closely with Public Health to analyse local intelligence and respond rapidly to potential outbreaks.

With a vast number of vaccination appointments to be arranged across the borough, the Customer Services team has stepped up to support NHS colleagues to call members of the public and get them booked for their vaccinations. The complex system already deployed by the Primary Care Networks means that this has not been straightforward, and work continues to develop a solution where our Customer Services can contribute to a significant improvement in vaccine uptake rate and equity. The Contact Tracing team are key in developing a system to achieve this. In addition, we are also developing an expression of interest to improve health protection by making self-isolation a viable option for people living in high density housing via a pilot. This would consist of offering time limited accommodation and/or by providing a clear referral pathway for key groups to mitigate risks associated by personal circumstance. The eligibility criteria for consideration are: split care families; those living with long term conditions/CEV and those experiencing financial hardship.

Table 1. (above) shows a snapshot of vaccine uptake by residents and staff in CQC registered care settings up to 21 February. There is now a functioning database set up to monitor uptake on a weekly basis. Uptake is low among staff in most settings and some also have low uptake among residents. This has been raised in the Care Homes Working Group and a deep dive exercise will be conducted by the GP Confederation into the reasons for low vaccine uptake, to gain a better understanding of the barriers and identify potential solutions to increase uptake. The work will also include mapping the care setting outbreaks with vaccine uptake, to raise awareness of the importance of vaccination.



### **Lateral flow testing**

Lateral flow testing is now being carried out in three care settings with renewed interest from a number of other settings. Staff who do not have access to on-site lateral flow testing have been advised to access the council run testing centres to book twice weekly tests. Bookings can now be made 28 days in advance so that staff can organise testing around work schedules. Regular messaging is sent to all care settings.

### **Visiting Policy**

The national guidance on care home visiting has changed to allow one named visitor on a regular basis. The local guidance is being updated to incorporate this guidance and to signpost relatives and staff to our local testing centres to ensure visitors can book a lateral flow test before they visit their relative.

## **SCHOOLS AND EDUCATIONAL SETTINGS**

The tableau testing dashboard for schools is operational and Public Health can now observe testing by site location. The dashboard also provides an overview of uptake/positivity rates for the schools mass testing programme, as well as the DPH-led pilot programme (which includes some primary schools). Hackney Education have set up a web page to share information dynamically with schools on mass testing. Effective partnership working between education departments and Public Health promotes live information.

### **Mass rapid testing in secondary schools**

Students at secondary school are expected to make a phased return from 8th March.

- The rapid testing regime for pupils and staff has changed, following announcement of the Government Roadmap. It is expected that all secondary schools will test every pupil on return to school, three times spaced three to five days apart, with the appropriate consent.
- After the first three tests, pupils will continue to test twice weekly at home. The workforce will also commence home testing. The DHSC is establishing a new distribution channel for the home rapid testing kits called 'community collect'. These kits will be distributed via the channels outlined in the 'community rapid testing' update.
- Schools in Hackney will receive a delivery of home self test kits for the workforce and onsite testing kits for the return of students between 24th February and 5th March.

### **Mass rapid testing in primary schools and maintained nurseries**

- Primary school and maintained nursery staff continue to test themselves using lateral flow devices (LFDs) twice a week at home. Primary schools and maintained nurseries have already received their allocation of home test kits.
- Primary school pupils are not being considered for the schools mass testing programme by DHSC.
- A handful of primary schools are being supported by a local pilot to test onsite with the option to test both staff and pupils. A recent data return from two of the pilot sites has identified a small number of cases amongst children and adults.

### **Mass rapid testing in early years settings**

- The broader early years workforce will also receive home testing kits with the allocation of kits expected in the middle of March. This includes provision for the private, voluntary and independent settings that provide a large proportion of childcare in Hackney.
- Childminders are not part of this mass distribution but are being considered as a priority group.
- Linden Children's Centre is continuing to set up onsite testing for their staff in the interim through the locally led DPH community testing programme, supported by Public Health and should be ready to begin testing following their site visit.

## **COMMUNITY GRANTS AND COMMUNITY CHAMPIONS PROGRAMME**

### **Public Health Community Champions programme**

We have now trained 142 Public Health Community Champions, with 57 local community organisations and 2 GP practices now engaged with the programme.

The February Forum was attended by 41 Champions and included a discussion on the vaccine to gather insights and concerns raised by residents. Positive feedback was also received on the communication resources, with groups describing how they have been able to use the materials to influence conversations and translate communications.

New Public Health videos have now been created, including one on how the vaccine works, as well as short videos on testing. These have been incorporated into a new resource pack that will be sent out to all Champions; while a new WhatsApp Broadcast group is being launched, to share easily shareable messages, including videos. The recently appointed Public Health Communications Officer will have a sole focus on the Champions programme, with the intention that the frequency and variety of messaging will increase.

In early February, the expanded Champions role was opened up to all residents as aligned to the Ministry of Housing Communities and Local Government (MHCLG) funding. 15 enquiries have been received so far. Outreach and engagement is under way, with a VCH member of staff appointed to work on this three days a week; a social media campaign; articles in the local press; and targeted engagement with health and social care employees, faith leaders and people who are currently less represented amongst Champions, such as people of West African heritage. Weekly information sessions will be hosted for residents who are interested in the role.

### **COVID-19 information grants**

27 organisations were funded in Round 1 and are currently delivering their COVID-19 Information projects, serving a diverse range of communities across both the City and Hackney. A full list of grants is found in the [Hackney Giving Overview, January 2021](#) from p. 14 onwards.

The first set of monitoring returns for these 27 organisations, covering the period up until the end of February, are due for submission mid-March. Data and case studies will be collated and shared at the end of March.

The second grant holders' Forum was held on 23 February. The forum covered communications guidelines, an update from the Public Health team, an update from the Hackney CVS neighbourhoods team, and discussion of successes and challenges so far. Mayor Philip Glanville addressed the forum and thanked the organisations for their work to

date. He also spoke of Hackney Council's commitment to working with the VCS and of the importance of inclusiveness in recovering from the pandemic.

Round 2 of the Covid-19 Information grants is currently open, with an application deadline of 11 March. More information is available on the Hackney Giving website:

This funding will be used to address gaps in provision from Round 1. Identified gaps include:

- Projects supporting Black African heritage communities
- Projects supporting Black Caribbean heritage communities
- Projects supporting adults with sensory disabilities
- Projects supporting adults with learning disabilities.

These communities are included in the existing programme target groups but were under-represented in approved projects, outreach has taken place to VCS groups representing these communities.

We are in the process of finalising our plans for a third round of community grants based on the successful MHCLG application. This will prioritise small grassroots community organisations who will be able to apply for grants of up to £5,000.

## **PARTNERSHIP CASE STUDIES**

### **Hackney Faith Forum**

Three Public Health engagement sessions have been run to:

- improve partnership working
- amplify Public Health messages drawing on the expertise and reach of faith leaders via improved communications
- co-design participation in phase 2 of the community champion programme
- counter misinformation, through enhanced partnership working across the NEL region, including through trusted and experienced intermediaries, such as the charitable organisation, Positive East

### **Metropolitan Police**

Public Health has facilitated improved partnership practice with Hostel, a notably high risk setting. The intention is to reduce domestic violence and breaches of the peace exacerbated by lockdown restrictions. A plan will be developed to improve prevention and compliance via the Neighbourhood Policing lead and the Metropolitan Police will link Hostel's CCTV with their radio police channel to support rapid response assistance.

## INCIDENT MANAGEMENT TEAM MEETINGS

### Charedi IMT

We have continued to work in partnership with Charedi community groups, members of the Rabbinate, PHE and Haringey Council and CCG, to ensure the continued decline in infections in this community and address high risk situations. Work led by Dan Beagle in Hackney Communications and shared with areas across the country that also have orthodox Jewish communities, has meant that this year's Purim festival was celebrated in a COVID-safe way, with no need for extra input from the Police or Enforcement colleagues.

Communications have been prepared, featuring a well-respected, local GP, to provide trusted and credible information to the community about the COVID vaccines.

## COMMUNICATIONS

### Ongoing communications

Daily social media posts across all City Corporation and Hackney channels on testing, vaccination roll out and promotion of central government messaging on hands, face, space and lockdown rules. Both the City Corporation and Hackney websites are updated regularly, to provide information on the vaccine rollout and changes to local test operations.

Hackney Council and its partners are delivering a major communications and engagement campaign in 2021 to encourage residents to get a Covid-19 vaccine. This campaign complements the national campaign, with a focus on more nuanced, culturally sensitive messaging for our diverse audiences. Research has gathered insights from local residents, particularly those from our diverse communities that may not engage with the national Public Health messaging. The insight gathered is informing the Hackney and pan London 'Keep London Safe Campaign'.

  - Weekly meetings with Jewish community representatives on communications.
  - Intensive work has been done with the community, to ensure safe Purim celebrations, including a piece in Hackney Today sent to all homes, a press release, leaflets and posters sent to schools and places of worship, a video created by Dr. Davis, Jpeg of advice sent round whatsapp and social media



## **LOCAL OUTBREAK CONTROL PLAN (LOCP) & STANDARD OPERATING PROCEDURES (SOPs)**

### **Local outbreak control plan**

The LOCP is being updated, at the request of DHSC and in accordance with their new template. This requires inclusion of the plans on the following themes:

- Higher-risk settings, communities and locations e.g. care home, prisons, hospitality, hospitals and education
- Vulnerable and underserved communities
- Compliance and enforcement
- Governance
- Resourcing
- Communications and engagement, including community resilience
- Data integration and information sharing

To reflect our learning to date and the ways in which the COVID response has developed since the plans were first published in June 2020, DHSC is also asking for the revised plans to reflect the following and how we manage these locally, working in partnership with national and regional bodies:

- Community testing - including plans for surge testing and support for organisations managing their own testing
- Contact tracing - including enhanced contact tracing
- Support for self-isolation
- Outbreak management (responding to an outbreak, or outbreaks, of two or more linked cases)
- Surveillance
- Responding to Variants of Concern (VOC)
- Action on enduring transmission
- Enhanced Contact Tracing, in partnership with HPT
- Ongoing role of Non-Pharmaceutical Interventions (NPIs)
- Interface with vaccines roll out
- Activities to enable 'living with COVID' (COVID secure)

The draft updated plan will be submitted to DHSC on 12 March.

### **Standard operating procedures**





- The schools and education settings SOP has been updated to reflect changes introduced to the rapid testing regimes for schools and full reopening considerations
- Care setting SOPs will reflect the new visiting policy after the 8th March
- SOPs are refreshed on a monthly basis to provide assurance to the reader that the guidance is in date. This now happens regardless of any guidance changes

- The latest monthly meeting with Single Points of Contact (SPoCs) described in detail the Government's road map for exiting lockdown and implications for settings
