Summary

Governors are asked to review the current list of Governor Designated Roles to the Board of Governors and consider the introduction of a new Governor Designated Role on City Junior School and Transition. It is proposed that this new role will replace the existing Governor Designated Role on Preparatory School, with the wider scope of the new role reflecting the changing arrangements for preparatory education. It is further proposed that the existing Governor representative for the Preparatory School be appointed to the role of City Junior School and Transition moving forward.

Recommendations

That the Board of Governors:

- Review existing Governor Designated Roles;
- Agree the introduction of a new Governor Designated Role for the City Junior School and Transition in place of the Preparatory School role; and,
- Agree that the existing Governor representative for the Preparatory School be appointed as Governor with Designated Responsibility for the City Junior School and Transition.

Main Report

Background

1. Individual Governors are responsible for overseeing particular areas of the School. Governors' Designated Roles are currently allocated as set out below and expressions of interest from Governors regarding any vacant Governor Designated Role are welcomed:

2. The areas represented by Governor Designated Roles are reviewed regularly and it is requested that Governor consider the introduction of a new Governor Designated Role on City Junior School and Transition in place of the existing Governor Designated Role on Preparatory School.
3. The proposed alteration is in response to changes to the arrangements for Preparatory School education which will be delivered by the co-educational City Junior School from September 2022. The introduction of a dedicated Governor Designated Role on City Junior School and Transition is anticipated to create a robust mechanism of support between the City of London School for Girls and City Junior School, as well as ensure Governor expertise is in place to support the key issue of pupil transition between Years 6 and 7.
4. It is further proposed that the existing Governor representative for the Preparatory School be appointed to represent the wider role of City Junior School and Transition moving forward, providing continuity for both schools as well as expertise and experience in the area of preparatory education and transition.
