Please accept this as a Police representation against the Temporary Event Notice received on the 18th July 2022 for an event at the above premises on the 30th/31st July 2022 until 04.00. The representation is in connection with the licensing objective of the prevention of crime and disorder namely that as a Pizza restaurant they are likely to have no experience of hosting such events, which we know from experience can carry substantial risk which they should consider. I have e-mailed the premises with our concerns but there is insufficient time for this information to be gathered prior to the last date for representations on this Temporary Event Notice which is today.

The applicant contacted me on Friday, after the hearing, indicating that he wanted to “work with us” and I told him what I was expecting by way of information concerning the proposed event. This was not provided fully as requested on the submitted TEN and no new risk form was subsequently submitted for further information, provided after I e-mailed them requesting this, on Monday 18th July 2022. I have had no response to my e-mail at all up to this time.

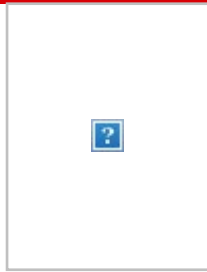
