 - NEW 63mm DEEP YORKSTONE PAVING, 300mm X 200mm TO BE LAID PERPENDICULAR TO ADJACENT KERB
 - NEW RAISED CARRIAGEWAY IN 2 COLOUR SET PORTUGUESE GRANITE SETTS (70% SILVER GREY, 30% MID GREY) LAID RANDOMLY, FLAMED TOP AND THE TOP 20mm OF ALL SIDES TO BE GROPPED
 - NEW 300 X 150 X 150mm MID GREY GRANITE SETT PAVING TO FORM CARRIAGEWAY CHANNEL
 - NEW 400 X 400 X 63mm YORKSTONE TACTILE PAVING
