Purpose of grant request: Low Cost Living Initiative to engage and educate communities, develop skills in reducing environmental impact, saving money, and creating self-sustaining, healthier households.

Background

The Hornbeam Centre was set up in 1991. It describes itself as a community hub for sustainable living. It undertakes environmental education projects, for example short courses in healthy eating courses seasonal food, workshops in draught proofing. refurbishment and water saving measures. Hornbeam works in partnership with other local not-for-profit organisations concerned with sustainable living including Forest Recycling Project, Organiclea food cooperative and HEET energy efficiency project. The organisations collaborate on the delivery of projects and cross-refer interested individuals. Hornbeam's building houses its community café, and provides offices and meeting space for its partners and other community groups. It offers environmental volunteering placements, including a project for people recovering from or having mental ill health.

Funding History

In 2001 you awarded a two year grant of £30,000 towards the salary costs of a Hornbeam co-ordinator, together with training and small equipment costs. The monitoring reports were satisfactory.

Current Application

Hornbeam wants to use its environmental expertise to widen its reach into low income and unemployed households, and Black and Minority Ethnic (BAME) groups. Waltham Forest is known to be a deprived borough, with high levels of poverty and unemployment. Hornbeam and its partners have contacted local community groups including Age Concern, tenants associations and BAME organisations, who have told them that rising living costs and declining incomes are putting intolerable pressure on their communities. The Low Impact Living project has been designed to help these households access affordable local food, reduce their waste, improve their access to sustainable transport and increase efficiency in their energy consumption. By doing so, households will reduce their environmental impact in terms of reducing food miles, waste,

water and energy while saving household money, developing healthier life styles and building their knowledge and skills in sustainable living.

Households will be contacted by working with local community groups, including faith groups. Information and advice will be delivered through practical workshops on draught proofing and basic repairs, peer-to-peer skill sharing, use of an easy to read tool kit and setting up of new groups, for example family walking, cycling groups, cookery classes. Learning and behaviour change will be measured through user feedback, savings on household bills and take up of energy efficiency measures. Up to 600 residents will benefit each year.

A part-time community environment worker (28 hours per week) will be employed to develop the initiative, and to coordinate the contribution of the partner groups in delivering aspects of the project. 'Experts' will be engaged as session staff if required but the emphasis will be on sharing knowledge and skills, and empowering local people to help each other.

Financial Observations

Audited accounts for the year ended $31^{\rm st}$ March 2012 show income of £73,387 and an end-of-year deficit of £1,241 (-1.7% turnover). As a company, the organisation does not have a formal reserves policy such as a charity is required to maintain, however, the directors confirm that they are currently developing a view on reserves to be held. At $31^{\rm st}$ March 2012 free unrestricted funds stood at £28,093, which equates to 4.5 months of total expenditure.

In 2012-13 there will be a deficit of approximately £15,000, which represents £14,120 unrestricted funds and £880 restricted funds.

The 2013-14 budget shows estimated income of £139,800 and expenditure of £122,870, leading to an end of year surplus of £1,930. This comprises a surplus on restricted funds of £2,850, partially offset by a deficit on unrestricted activity of £940. The total budgeted income of £139,800 includes grants income totalling £93,950; of which £18,950 has been secured to date with other applications are awaiting decisions. Total budgeted income also includes estimated café income of £36,000 and room hire of £8,350, which should be achievable based on past performance.

Officer's Appraisal

Hornbeam has a long track record in the promotion of and engagement in sustainable living. This project offers a significant opportunity for a greater range of households in East London to take small and simple steps to reduce their carbon footprint while minimising household outgoings and improving their quality of life. A smaller grant than requested is recommended, which is more in keeping with the finances of the organisation. Hornbeam has indicated that this would be acceptable.



Recommendation £60,000 over three years (£20,000; £20,000, £20,000) towards a 4 day per week community environment worker post and project running costs on condition that match funding is secured.

4. Main activities of your organisation

Creating a hub for local sustainable living through:

- Developing a range of initiatives focusing on local food, including a vegan café selling locally-grown and ethically-sourced food (open 4 days a week), a Saturday organic market stall, an organic box scheme, a fruit-picking project, and regular workshops and events.

- Raising public awareness of climate change and biodiversity issues via stalls at many borough events, and giving talks.

- Initiating and supporting Transition Walthamstow & Transition Leytonstone, and supporting other environmental groups such as Waltham Forest LETS.

- Supporting local arts and crafts by hosting events such as a weekly knitting group, E17 Art Trail exhibitions, running monthly Open Mic evenings for local musicians and hosting one off music events such as Jazz nights.

- Hire of meeting space to local groups and other organisations such as OrganicLea, Kid's Kitchen, many of which use this as their regular venue.

- Production of the annual Waltham Forest Green Celebrations events guide and organisation of Energy Fairs at different locations in the borough.

- Recruiting & placing volunteers into local environmental organisations.

Hornbeam is a founder member of GREEN, an IPS established in Dec 2011 to address environmental and social justice issues in East London, and has installed 2 photovoltaic arrays funded via community shares.

The Hornbeam Low Cost Living project aims to: reduce the impact of Waltham Forest's community on the environment, reduce household expenditure, engage communities in environmental activities and improve health and wellbeing through environmental education. The Hornbeam Centre is a sustainable environmental project hub in Waltham Forest. Its key partners are OrganicLea, Forest Recycling Project, Home Energy Efficiency Training and Transition Walthamstow. These organisations form a unique alliance that offers fantastic potential for this project to develop as a replicable model of grassroots engagement in sustainable living. Decades of eco-pioneering work is now so strongly embedded that by broadening the scope and depth of our community outreach work the project will carry the message to the people most in need. Waltham Forest's diverse communities can be brought closer together by the common need to increase the availability of low cost local food, minimise waste, and increase energy efficiency & sustainable transport use.

The growing need for the project became evident from actively working with local people to identify individual concerns but is also very clear when examining key indicators used by statutory agencies: Waltham Forest ranks 15th most deprived among the 326 English local authorities (down from 26th in 2007). It is 6th most deprived London borough; over 16,000 private homes need insulation; 15.6% of owner occupiers are fuel poor; over 35% of year 6 pupils are overweight/obese; domestic recycling rates have fallen by 2.5% in three years; 50% of Waltham Forest residents are from a minority ethnic background; and one in five households are workless.

Residents of Waltham Forest have told us of their struggles to prioritise environmental issues over

day to day living challenges.

This shows us that the Low Cost Living project will help people understand that the pressures of everyday life can be mitigated by taking small, simple, steps to live in a low impact, sustainable manner. The project will demonstrate easy ways to reduce living costs and improve living standards at the same time. Outcome 1 - reduced CO2 emissions achieved through: engagement with 90 community groups; 1800 people attending outreach events/roadshows; 900 people attending 90 workshops/skillshares. Outcome 2 - reduced domestic costs in food, transport, utility bills, and consumer goods achieved through: 50% of workshops & skillshares focused on low-income families; case studies of 20 families each saving £500 in costs. Outcome 3 -- increased diverse communities participation in environmental activities achieved through: 60 diverse community organisations involved; 450 people involved from hard to reach groups; 150 placed in environmental volunteering roles. Outcome 4 - improved wellbeing & healthy living achieved through: 150 volunteers engaged in physical activity; 120 households taken out of fuel poverty; 18 healthy eating workshops/skillshares. The Hornbeam has a proven model of engagement, "the reskilling model" and alongside this model the key to project delivery will be the appointment of a Community Environmental Worker to draw together the expertise of the partnership and broker opportunities with other community organisations for further collaboration. Hornbeam has developed a programme promoting volunteering via lottery and council funding, and the existing volunteer network will be bolstered to provide the Community Environmental Worker with the person-power to deliver the project's objectives. The monitoring and evaluation of this project will be built into the delivery plan, including equality and diversity data for all contacts.

The Hornbeam has a great track record over 20 years of involving local people in its management and operation, welcomes people of all backgrounds and values diversity. and has a policy of inclusion and respect for all; it will not tolerate discrimination or exclusion of people.

16. Explain how you will monitor and evaluate both your own outcomes and those of the programme under which you are applying.

The project aims listed above provide a monitoring framework. Age & ethnicity information will be maintained, and a photographic record will demonstrate different project elements and beneficiary range. Follow up surveys 6 months after workshop participation will inform an assessment of changes resulting, and support continual improvement in programme delivery.

Beneficiary feedback will be encouraged through structured surveys and informally via suggestions and comments. Beneficiary sampling will use calculators and other tools for measuring improvements in carbon emissions, domestic expenditure, and health. This will not yield a complete picture of environmental activity change, but offers a flavour of those within our capacity to measure. The project is designed to provide pathways encouraging progression from outreach activities to workshops, followed by involvement in clubs and support networks. A key indicator of success will therefore be the extent to which people follow progression pathways and move from no engagement to active participation.
