An example project I am currently working on:

- Successfully bid at auction on a rare to the market mixed use freehold property off Carter Lane in the City during the height of the credit crunch having unearthed omissions in the property description that other bidders may not have been aware of.
- Continued to lease the retail units on the ground and basement with rent covering loan repayments.
- Successfully obtained planning permission to change use from empty office on upper floors and addition of an extra storey to create four new residential units providing an uplift of valuation as existing but with benefit of planning permission of 60% within 2 years.
