# **City of London Corporation Local Development Scheme**

# February 2025

### Introduction

The Development Plan for the City comprises the London Plan (2021) and the adopted Local Plan (2015). This document sets out the formal programme for the preparation of the City of London Local Plan (City Plan 2040) which, once adopted, will replace the Local Plan 2015 and form part of the Development Plan.

This document has been prepared against the requirements of Section 15 of the Planning and Compulsory Purchase Act 2004 (as amended) and the Planning Practice Guidance (PPG).

For completeness, it also sets out the timetable for the preparation of other Supplementary Planning Documents which will provide additional guidance on the policies of the new local plan.

#### Format of this document

This document has been prepared to provide the key information relating to the preparation of planning policy documents in an accessible format which includes key data in accordance with the Government's data standards (see: <a href="https://www.planning.data.gov.uk/dataset/local-plan-event">https://www.planning.data.gov.uk/dataset/local-plan-event</a>). The key dates as set out below are also available in digital (CSV/JSON) format. Once adopted the City Plan 2040 and each SPD will be uploaded on the Government's Planning and Housing data portal.

This version and the data contained within it is correct as at February 2025, but will be regularly updated.

### Local Plan (City Plan 2040) key dates

The emerging local plan consists of the City Plan 2040 and Policies Maps, covering the whole of the City of London. The following sets out the key milestones or, in data terms, the 'local plan events' relating to the preparation of the new local plan.
