Organisation

Amount and Purpose of Grant

Montage Theatre Arts

£4,000 to match CEP funding towards the wage costs of 2 Apprentices for 1 year from October 2013. The national minimum wage must be paid.

DASH

£6,000 over 1 year towards the staffing and artistic costs of community workshops for a cross-cultural arts project with London's communities from the Former Soviet Union.

Clouddog £24,000 for one year towards the Clouddog Chief Executive post and project running costs for the Open Horizons project in London.

Christ Church Kensington £1,176 for the costs of an independent access audit and design appraisal for Christ Church Kensington.

Vocaleyes £12,400 for a third and final year of VocalEyes audio-description service, conditional on receipt of a satisfactory monitoring report on the charity's current grant. The award to cover costs of 5 days per month of a Programme Manager and 10 days over the year of an Audience Advocate plus project running costs.

City Bridge Trust £4,950 to complete the Parklife London website as part of the Trust's Growing Localities initiative.
