Withdrawn Applications:

Organisation	Purpose of Request
Young Vic Theatre Company	"Arts Apprenticeships".
	Application has been withdrawn following confirmation that the posts involved are not apprenticeships, but internships, and therefore ineligible.
Historical Royal Palaces	"To support the creation of two new gardens at Hampton Court, a Tudor children's play garden and a Georgian kitchen garden".
	The organisation withdrew the application upon realising that some of the capital funds requested did not meet your criteria and that it could reapply at a future date for revenue support.
Helios Foundation	"To provide Counselling and Psychotherapy sessions for vulnerable LGBT people dealing with depression, low self-esteem, harassment and isolation, with advocacy and personal support where required".
	Application withdrawn while the organisation improves some underlying governance issues.
Camden Arts Centre	"Learning disabled individuals will access the arts at all levels; inclusion in activities, employment as

	leaders, and strengthening inclusion across the arts and education sectors".
	The organisation has withdrawn this application in order to submit a more focused bid.
Over The Wall	"To fund places for London based children, aged 8-17 at our camps for children with serious illnesses in 2014, 2015 and 2016".
	A revised application has been submitted which is recommended for a grant at today's meeting.
Jigsaw4u	"To provide a specialist holistic service, taking referrals of children, young people and their mothers affected by domestic abuse to improve their safety, health and wellbeing".
	Application withdrawn as the proposal fell within the obligatory fallow period and therefore, was ineligible.
Age Concern Havering	"To provide a modern befriending service to socially isolated and lonely older people, some of whom are housebound, living in and around Havering".
	Since submitting, the organisation has reorganised its work programme and wishes to integrate its befriending work more closely into its core programme.
CREATE London	"A health and well-being project, working with older people to revive fruit and hop picking; helping to change our ideas about food production and cultivation".
	Application withdrawn when the organisation realised it was ineligible to apply due to being within your fallow period following your previous grant.
Sadler's Wells	"The Elixir Festival celebrates the older artist and incorporates a conference promoting the benefits of dance on the quality of life for the elderly".
	Organisation has decided to withdraw this application on being made aware that it did not meet your criteria. A revised proposal is to be expected.

St Mungo's Broadway	"Employing a Financial Inclusion Worker to advise staff, support complex welfare rights cases, and
	train staff and homeless clients in welfare benefits and financial resilience".

Having submitted a final monitoring report on its previous grant in March 2014, the charity is not yet eligible for further funding. The organisation has therefore withdrawn this application and is likely to re-apply in 2015.

Ealing CVS "We will support organisations to develop financial management, monitoring and evaluation procedures and share learning about what works in supporting organisations to develop these skills".

The applicant has withdrawn the application in order to re-submit a bid which fully meets the Trust's priorities.

placements".
