Organisation	Purpose of Request
The Parochial Church Council Of The Ecclesiastical Parish Of Acton	"To hold weekly ESOL classes for homeless and marginalised people".
	The organisation has decided to withdraw the application as it has insufficient staff to deliver the proposed work.
Deen City Farm	"'Growing Gardens' uses the open spaces of Deen City Farm to improve Londoners' health and environmental knowledge through three strands of volunteering, eco-therapy and education".
	Organisation has withdrawn the application as it wishes to consider a revised proposal.
Nafsiyat	"Through Transform, Nafsiyat will provide intercultural therapy for young people from Black, Asian, Minority Ethnic and Refugee (BAMER) communities experiencing mental distress with remedial action".
	After discussion with your officer, the organisation has withdrawn this request top re-submit a more focused proposal.

Advocacy in Barnet	"To improve the lives of older people with dementia through advocacy support (with trained volunteers) in hospital settings."
	Application withdrawn when the organisation realised it was ineligible to apply due to being within your fallow period following your previous grant.
Peel Institute	"To support a Wellbeing Hub for older people to encourage healthy lifestyles and reduce isolation".
	Application withdrawn following discussion with your officer on strengthening the bid's focus and on the financial viability of the organisation. It is likely to re-apply in 2015.
Spare Tyre Theatre Company Limited	"To support and develop the work of our COMPANY OF ARTISTS, a group of performers over the age of 60 working with learning disabled artists".
	The application has been withdrawn to allow for the submission of a focused bid which will more clearly address your area of interest.

	The applicant has withdrawn the application in order to submit a more appropriate bid.

	The application has been withdrawn as the charity is reviewing its project idea with a view to submitting a different application in due course.
