### **The Charity**

Age UK London is the only London-wide older people's capacity-building organisation. It has a good track record of working with a range of partners and stakeholders to make London a better place to grow old. Together with local Age UK's, Age Concerns, older people's borough forums and others, it works across London to expand the contribution of older people, improve their quality of life and enhance their status and influence. Current activities include a pan-London programme 'Fit for Purpose' designed to build the capacity of over 450 older people's organisations. In addition, the charity recently launched a three year project raising awareness of the needs of older private tenants in London.

### The Application

Age UK London is requesting three year funding to develop an Age Friendly campaign. This will challenge stereotyping of older people and encourage organisations to make small changes in the way they work, and relate to, older people. The funding will cover the costs of 2 part time posts a (3dpw) programme Officer and a (1dpw) Research and Campaign Officer, and associated running costs.

#### The Recommendation

The Age Friendly campaign developed following consultation with small grass roots organisations and large-scale surveys of older people. Findings show that age discrimination is prevalent with older people experiencing multiple disadvantage accessing information, services and support. Your funding, if awarded, will allow Age UK London to develop a series of interactive workshops with older people, supporting participants and organisations to become 'Age Allies'.

£113,200 over three years (£40,500; £40,500; £32,200) for the salary costs of a part-time Programme Officer (21hpw) and Research and Campaign Officer (7hpw), and associated running costs.

## Background and detail of proposal

Ageism is widespread in the UK and affects people at different stages in their life cycle. There are currently some 2.2 million people aged 50+ in London, of whom over 900,000 are aged 65+. Ageism and age discrimination affect people in a variety of ways. These include: difficulties accessing public services, information, and goods and services; employment opportunities; and by belittling or patronising older people's capacity and ability. Since 2011-12, the charity has carried out an annual survey of older Londoners' priorities. Results consistently show concern about ageist stereotypes and their effects. Interactive workshops will be run by a Project Officer and local older people and delivered to statutory and private sector organisations and schools across London. These workshops will raise awareness of ageism by identifying barriers faced by people as they age. The project aims to change attitudes of people and organisations towards older people, supporting them to be more inclusive through making 'one small change'. People aged 75+ will be key participants. A London-wide map will be complied of organisations which are Age Allies and the changes they have made.

#### Financial Information

Forecast income for the current year 31<sup>st</sup> March 2017 is £715,255 of which £262,097 (37%) had been secured by 14th June 2016. Income has fallen and deficits have been incurred over the three financial years shown in the table below. The charity's trustees recognise the need to raise unrestricted income and to this end have recruited a fundraiser, who will focus on fundraising from individuals.

The charity's free reserves were low at £77,024 on 31 March 2016, equating to less than one months' worth of expenditure. As noted, the charity plans to increase income to gradually accumulate free unrestricted funds. However, in addition to its free reserves, the charity also held designated funds amounting to £650,000 which it has set aside for key projects over the next 3 years.
