# <u>Standing Order No. 41(b) - Consultation Response: Proposed changes to the ULEZ: start date and emission standards</u>

### Background

At the Port Health and Environmental Services Committee on 9 May 2017, authority was delegated to the Town Clerk, in consultation with the Chairman and Deputy Chairman, to provide a written response in relation to proposed changes to the Ultra Low Emission Zone (ULEZ) to improve air quality in London

The Transport for London (TfL) consultation sought views on proposals to introduce ULEZ seventeen months earlier in central London, and to strengthen the emissions standard to also cover Particulate Matter emissions from diesel vehicles. The closing date for this consultation was 25 June 2017. A draft response was circulated to all Members of the Port Health and Environmental Services Committee for their comments which have been incorporated into the letter at Appendix 2.

### Action taken
