Our Mission Statement

Eye Music alms to bring contemporary music and arts to the widest possible public.

By creating new environments and using public spaces we attract all to our events through curiosity.

By linking music, colour, light, space and movement we give new dimensions to public perception and new understanding of contemporary music and performing arts.

Through educational programmes we seek to broaden participation in the arts through natural enjoyment and exploration of colour, light, sound and movement.

Main activities of your organisation:

The most well-known activities of Eye Music Trust are workshops and public events within Colourscape structures. Colourscape is a large walk-in structure of colour and light. Within these unique structures Eye Music presents performances of music, dance and other performances to create journeys of colour, music and space. This concept draws large audiences of local people and families to experience contemporary music in a new way.

Alongside our public presentations Eye Music presents a large number of workshops each year. The largest proportion of these workshops are given to Special Needs and disabled children and adults who benefit enormously from the experience of intense colour and music.

Additionally we present workshops within Special Needs schools with our new Colour/Music Sensory Space (funded in 2013 by City Bridge Trust). This new installation enables children and adults to create their own music and colour using specially-designed movement sensors and software so that all become creative artists whatever their disability.

Summary of grant request

BACKGROUND

In 2007 we were successful in bidding to City Bridge Trust and ACE to build a new "mobile" Colourscape - designed to take our

unique colour and music workshops directly to Special Needs schools across London. The three-year City Bridge grant also helped lever additional funds from London Councils increasing numbers from 8 to 18 London boroughs across three years.

This programme continues with funding from new charities and foundations.

In 2013 a further successful bid to the City Bridge Older Londoners fund created a new installation of colour and music with movement sensors enabling those with Dementia and Frallty to become creative musicians/performers. This three-year project had huge success and developed new funding streams to extend its reach: 31 care-homes from 21 boroughs involved.

We will build on our successful model of working with as many London boroughs and as many SN schools as possible in this new City Bridge programme.

THE PROJECT

The Colour/Music installation (created through City Bridge Older Londoners funding) has also developed uses for our SN work over the last three years.

The installation is based on a flexible architectural Installation transforming any classroom or other indoor space into a new world of colour and light. Within this space are different movement sensors and new ?touch-paintings? created with latest touch-sensitive paint.

Disabled children control sensors with hands, feet, head: literally any part of the body to create and control music and strong therapeutic coloured light. All can be involved from PMLD to higher-ability ASD students.

At the end of the week we stage a public performance in the school; at a public Colourscape event; even in shopping centres!

The whole project is designed to run in as many London boroughs as possible (c.x16). Projects will be flexible allowing each school to shape the project according to need?.some schools choosing a Colourscape project as being more suitable?others working towards finished public performances. The most involved schools will self-fund our long-term installation of the Creative-Sensory-Pod giving legacy.

We continually receive requests from SN schools demonstrating NEED for our unique creative-work....

OUR PARTNERS

Eye Music Trust already has good working relationships with SN schools across London. Many have come to Colourscape workshops in Lambeth and others have worked on weeklong projects. We also have good relationships with borough arts and education teams and will build these partnerships to give maximum benefit: involving parents and the local community.

We are a supporting organisation of the Arts Award scheme.

Outputs and outcomes

OBJECTIVE ONE? Enabling disabled children to take part in the arts. OUTPUT: Over the three-years we present at least twelve full weeks of Sensory-Space workshops in London SN schools providing new participatory artistic experiences.

OBJECTIVE TWO? Increasing self-esteem and pride. OUTPUT: We present at least twelve final concerts across the three-year programme for relatives and carers to see their children giving public performances.

OBJECTIVE THREE? Increasing Well-being. OUTPUT: We present at least six workshops and experiences in our large Colourscape structures. These focus on stimulation through intense colour and sensory instruments for those with Sensory Deprivation. Our permanent Colour/Music Installations will give longer-term benefits in hand/eye coordination and greater control of environment.

OBJECTIVE FOUR? Increasing Creativity. OUTPUT: At least twenty-four new compositions and performances created by the children themselves. All of our Symphony of Senses projects will aim to enable children to create their own performance events? creating sounds; shaping into musical forms: using musical/emotional expression

What main differences or outcomes do you hope the activities you have described above will achieve? Please include no more than 5. The participating disabled children gain new skills? creating music? learning to shape musical forms? connecting colour and music together? recording their own voices/sounds? shaping those sounds into musical performances. At least 900 children per year benefit. Monitoring gives numbers/range of disability/effects on participants

Giving public performance develops great self-esteem in disabled children. It is rare for them to be able to develop full public performances. Good side-effects are increased pride from parents and siblings increasing family cohesion.

For PMLD children it is harder to quantify benefits of our intense colour and music experiences. We have seen across projects: increases in movement and awareness - less emotional outbursts or "tlcking". We will use our specialist "Steps-in-Sensor-Awareness" monitoring to gain understanding through observations from classroom assistants and teachers.

Creativity is liberating: increasing awareness of self-worth. All people grow through expression and creativity. Being in control of emotional expression through music and art increases well-being through the activity of ?doing-it?. Mind and body work together in harmony. Monitoring by teachers/assistants gives observations/reports

Over many years running our SN work we have been very successful raising funds from a large variety of funders including ACE and many foundations. The development activity funded by City Bridge will enable us to create new installations: drawing new funding sources to this valuable work. Our ACE NPO grant (2018-2022) continues to fund our SN work onwards.
