#### Aims of your organisation:

Vital Xposure Is a disability-led theatre company, based in Hackney. Launched in January 2011, under the creative leadership of disabled artist Julie McNamara, Vital Xposure?s aims are:

- ? To create inclusive and innovative theatrical experiences for audiences, artists and communities
- ? To bring hidden & excluded voices centre stage by telling stories from people in the margins of our communities
- ? To ensure the talent and training needs of disabled artists and creatives remain the focus of our work
- ? To develop our creative programme to challenge common assumptions about people on the periphery and to champion inclusivity and collaboration
- ? To place access at the heart of everything we do, so it becomes central to our productions and activities
- ? To address the multiple factors that prevent disabled individuals from accessing and participating in theatre, both as performers and practitioners
- ? To offer employment opportunities to disabled people interested in the creative industries and develop a diverse workforce

#### Main activities of your organisation:

Vital Xposure is a bold, dynamic and well-respected theatre company in London. We are disability-led and deliver a programme of professional performances, original theatre productions, mentoring and development opportunities to create a fully inclusive experience for artists and audiences alike.

Main activities:

- ? Creating, producing and touring multi-layered theatre productions as tools for social engagement.
- ? Research & development workshops and creative labs to develop shows for full production and touring.
- ? Providing work experience and paid employment opportunities to a wide range of professional disabled creatives
- ? 1 to 1 mentoring matching disabled trainees with appropriate mentors who are highly skilled within the creative industries.
- ? Delivering a professional development programme for emerging disabled theatre practitioners, tailor-made to suit the needs of the individual.
- ? Working collaboratively with relevant organisations to share learning, to develop best practice, to offer work experience and to be a strong advocate for disability arts and for diversity within disability arts.

#### Summary of grant request

We are requesting £57,198 towards the salary costs of Vital Xposure?s Artistic Director, and to improve access to the arts for disabled people in London.

#### The need:

Through our experience, consultation and research, we know there is a need to address the multiple factors that prevent disabled people from accessing and participating in theatre, as performers, practitioners and audience members. Our work addresses these physical, economic and social barriers, and creates opportunities for people who identify as disabled to manage, participate and benefit from the arts.

There is also a need to share this learning with our wider networks to benefit even more disabled people in London.

How the work will be delivered:

This two-year grant will go towards the salary costs of Vital Xposure's Artistic Director, Julie McNamara, who identifies as disabled, and will lead on three key areas of delivery:

- 1. Training and mentoring of early career disabled theatre practitioners
- 2. Researching and implementing access provision for disabled people to take part in theatre
- 3. Disseminating best practice regarding theatre and access provision for disabled people to arts organisations in London

What our project will achieve:

This project will ensure that Vital Xposure remain at the forefront of making theatre accessible. It will:

- ? Enable more people to become involved with the running and management of arts provision
- ? Increase the number of people accessing theatre and improve their quality of experience
- ? Broaden the opportunities and support for disabled artists and cultural organisations to build a more inclusive and representative cultural sector

Vital Xposure is the right organisation to deliver this work, because:

- ? We are a disability led organisation with access, diversity and equality deeply embedded at the heart of our service delivery
- ? Artistic Director, Julie McNamara, has a high profile reputation in disability led theatre and we have an excellent track record in this area
- ? We have strong networks and partnerships with other leading arts organisations in London and beyond, which widen our reach and strengthen our delivery

Vital Xposure?s work and raison d?etre fits perfectly with the Trust?s outcomes:

1. Disabled people involved in the running and management of arts provision? Vital Xposure is a disability-led organisation.

All 3 staff members identify as disabled and all planning, management and running of our arts provision is done by disabled people. Funding towards our Director?s salary will enable us to further develop this taskforce and champion, mentor and enable more disabled people to become involved with managing the arts.

2. Disabled people actively taking part in arts: We are experts in making theatre accessible for everyone and participation is central to our philosophy. We want to improve access for any person who self-defines as disabled, particularly people with learning difficulties. This grant will enable us to better understand and take action to enable more people to actively engage with the arts as audience members, participants and practitioners.

How our project meets the Trust's ?Good Practice' principals:

- ? All our work is planned, managed and run by disabled people, from Vital Xposure's Board of Trustees to our staff team and volunteers.
- ? Vital Xposure works with some of the most excluded and marginalised people in society. We welcome people from all backgrounds and diversity is at the heart of all we do.
- ? We keep our volunteers numbers low to ensure that we can fully support their needs and assess and meet training requirements.
- ? To reduce our carbon footprint: Company meetings are paper free, we recycle, we reuse costumes and props, we utilise video conferencing and use public transport when possible when touring.

Deliver a Research & Development project in 2018 exploring how to create an accessible performance with people with learning difficulties for an outdoor arts festival in London in 2019.

Deliver 4 webinars and disseminate best practice on ?improving access to theatre for disabled people? to disabled and non-disabled arts organisations in London.

What main differences or outcomes do you hope the activities you have described above will achieve? Please include no more than 5. Arts organisations in London will feel better informed and able to support a diverse workforce and audience.

We plan to further develop this work beyond the two-year grant from the City Bridge Trust. This will be funded through a combination of grants, sponsorships and earned income through ticket sales, presentations and co-productions.
